#### 1. Summary

The report presents a summary of:

Public art is both the process and impact of artists in creating temporary or permanent artwork in and for public spaces.

Public art can be a positive force for the city, creating a sense of place and building on key visions and programmes. It can, for example, support the city's Economic and Tourism action plans, and the well-being agenda.

The budgetary constraints within which any on-going programme is delivered should be acknowledged, advocating for quality rather than quantity in commissioning, from artistic, planning and financial perspectives.

#### Report

#### 1. Introduction

Public art has many benefits for the city. It provides considerable enjoyment, creates interest and a sense of place and builds on key priorities.

Public art refers to both the process and impact of artists in creating temporary or permanent artwork in and for public spaces.

#### 2. Public art in Leicester

An inventory of existing public art in Leicester is attached at Appendix 1, showcasing the wide range of public art exhibited across the City. These include items in the council's ownership and that of other organisations, but everything is accessible and intended for the general public to enjoy.

Public art is cared for by a wide range of council services, depending on where it is located, so, for example a school will be responsible for upkeep of an artwork at that school and parks look after all items in parks and cemeteries.

The Culture and Neighbourhood Services Division leads on public art, but within the City Development and Neighbourhoods Department, officers from two key service areas work closely together, keep an overview, provide advice and liaise with other departments. These are the Arts Management section of the Arts and Museums Service, and the Conservation section of the planning division. Officers from the two teams are involved as the expertise of arts and planning specialists are complementary. Sometimes one will lead, sometimes the other, according to the needs of individual projects.

#### 3. Leicester City Council's approach to new commissions

When new public art is commissioned, officers from these teams, working jointly together, will provide advice on this process, and will on occasion be responsible for commissioning artworks on behalf of the council.

Ideally, public art commissioning should respond to the following key principles:

- Artwork should be enjoyed, create a sense of place and build on key visions and programmes
- People in the city should have a say about art in the City
- The artwork should be site specific, that is created with the needs of a particular location in mind
- The artwork should be relevant to the City and its people
- The process and artwork should engage with the community
- The artwork should be appropriate and robust
- The process and artwork should take account of budgetary constraints (i.e. be fully funded, including on-going maintenance and decommissioning)
- Providing a clear line of responsibility for the final artwork, including safety, reactive and proactive maintenance requirements, and liability

#### 4. Funding

Public art commissions can cost anything from around  $\pounds$ 5,000 to above  $\pounds$ 10,000,000. This includes the cost of the actual artwork, and project costs to develop and deliver it. Whatever the scale of the project, the budget allocated should be sufficient to ensure the required quality.

Public art can be funded from both public and private sources. Funding might include a local authority's capital, revenue and strategic programme funds, external funding applications and private donations. In addition it may be considered for future programmes of Community Infrastructure Levy Funding, or through individually negotiated Section 106 Planning Agreements, although the Government has limited this opportunity in recent National Policy announcements.

The council does not have any regular identified funding for new public art so when approached to assist with a commission would expect it to be fully funded/ funding raised by the commissioning group or individual.

## 5. Costs of commissioning

Commissioners must consider not only the initial set-up costs of commissioning, creating and installing public art, but also on-going costs such as maintenance and any on-going running costs (e.g. if power or water are needed). Funds need to be allocated or identified and agreed at the point of commissioning to pay for maintenance during the "lifetime" of the public artwork (i.e. up until the permitted decommissioning date stated in the commissioning contract). Associated

decommissioning and/or removal costs must also be allocated or identified and agreed in case this is required.

Unless otherwise specified, the landowner of the land where public art is sited has a duty of care and budgetary responsibility for maintenance (and decommisioning where applicable). This can be the local authority or a private owner.

#### 6. Process on requests for, and gifts of, public art

Leicester City Council regularly receives requests from individuals, community and other special interest groups, and partners to support public art commissioning in the city. It is able to offer advice and support on the assumption that:

- The commission will support the local authority's aims
- Commissioners will identify maintenance and decommissioning provision
- Commissioners will have the agreement and support of the landowner where they wish to locate the new commission

#### 7. Commissioning guidelines

When considering commissioning a public artwork, the following should be considered:

- Consultation and public engagement
- Commission brief preparation
- Artist appointment method
- Budget available
- Technical checklist
- Risk assessment for project

## 8. Public art projects with Leicester City Council involvement

Leicester City Council is currently involved in the following projects:

- Sainsbury's public art commission
  - Public art commission for Melton Road, to be located near the new Sainsbury's store. Celebrating Leicester and the heritage of the local area
- Alice Hawkins statue
  - Support provision of a statue of Alice Hawkins in the City, to be commissioned by a recently constituted community group.
    Statue to be located in new market square
- Nelson Mandela statue
  - Support provision of a statue of Nelson Mandela memorial in the City, to be commissioned by a community group

- Belgrave Road project
  - Small scale interventions to be commissioned along Belgrave Road, to better brand the area
- De Montfort Hall commission
  - Support gift of public art for the gardens and De Montfort Hall. A sister work to the Concerto work already in place.
- Westbridge Wharf commission
  - Landscaping improvements to the setting of the work commissioned for Westbridge Wharf, which include visibility of the artwork
- Soar Island redevelopment
  - Initial scoping work to improve the A50 corridor with temporary public art interventions
- Sikh war memorial
  - Support provision of Sikh war memorial in the City, to be commissioned by a recently constituted community group
- Writers' Block
  - Work with Friends of New Walk regarding a potential new public artwork to be located in De Montfort Square
