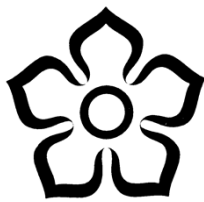

1. Appointment of Chair

Councillor Pickering was appointed as Chair of the meeting.

2. Apologies for Absence

There were no apologies for absence.

3. Declarations of Interest

There were no declarations of interest.

4. Minutes of Previous Meeting

The minutes of the previous meetings held on 4 November 2024 and 18 November 2024 were recorded as a true and accurate record.

5. Application for a Review of an Existing Premises Licence under Licensing Act 2003 and Review of Pavement Licence Issued under the Levelling Up and Regeneration Act 2023 - Rum and Spice, 2 King Street, Leicester

Councillor Pickering, as Chair led on introductions and outlined the procedure the hearing would follow.

The Director of Neighbourhood and Environmental Services submitted a report on a review of an existing premises licence under Licensing Act 2003 and review of pavement licence issued under the Levelling Up and Regeneration Act 2023 for Rum and Spice, 2 King Street, Leicester.

The premises licence holder Mr Merenre Millett, his representative Mr Joe Harvey, solicitor from Poppleston Allen, and Mr Reg Jeb, Certified Security Solutions, were in attendance. Also in attendance was PC Jefferson Pritchard, Leicestershire Police. Also present was the Licensing Team Manager (Policy and Applications) and the Legal Adviser to the Sub-Committee.

All parties agreed that the hearing to focus on the review of an existing premises licence. The Police were advised to submit a separated application for a review of the pavement licence.

The Licensing Team Manager (Policy and Applications) presented the report and outlined details of the application.

An application was received on 22 October 2024 from Leicestershire Police for a review of the existing premises licence for Rum and Spice. The application was made on the grounds of the prevention of crime and disorder, public safety, the prevention of public nuisance and the protection of children from harm.

PC Pritchard, Police Constable for Leicestershire Police, was given the opportunity to outline the details of the Police's review application and answered questions from Members and the representative of the premises licence holder.

Mr Millett, Mr Harvey and Mr Jeb were given the opportunity to address the Sub-Committee and answered questions from the Members and officers.

All parties present were then given the opportunity to sum up their positions and make any final comments.

The Sub-Committee received legal advice from the Legal Adviser to the Sub-Committee in the presence of all those present and were advised of the options available to them in making their decision. The Sub-Committee were also advised of the relevant policy and statutory guidance that needed to be taken into account when making their decision.

In reaching their decision, Members felt they should deliberate in private on the basis that this was in the public interest, and as such this outweighed the public interest of their deliberation taking place with the parties represented present, in accordance with the Licensing Act 2003 (Hearings) Regulations 2005.

The Chair announced that the decision and reasons would be announced in writing within five working days. The Chair informed the meeting that the Legal Adviser to the Sub-Committee would be called back to give advice on the wording of the decision.

The Sub-Committee recalled the Legal Adviser to the Sub-Committee to give advice on the wording of the decision.

RESOLVED:

As a result of the representations made to committee, it was satisfied that the representations by the Police engaged 3 of the 4 licensing objectives and committee accordingly determined that it is appropriate and proportionate in light of Licensing objectives to:

1. **REMOVE** Mr Niblett as the premises Designated Premises Supervisor.
2. **SUSPEND** the Premises Licence from 3 January 2025 until 28 February 2025.
3. **MODIFY** the licence conditions by reducing the Terminal hour on Fridays and Saturdays to 5am with the last entry for customers to be at 3am.
4. **MODIFY** the licence conditions by requiring the Premises Licence Holder to ensure that the fire exit doors in the basement and ground floor are not obstructed and kept clear at all times.
5. **MODIFY** the licence conditions by requiring the Premises Licence Holder to ensure a door security team is deployed at the premises from 11pm on Fridays and Saturdays and on bank holidays and on Christmas eve and New Year's Eve.
6. **MODIFY** the licence conditions by requiring the Premises Licence Holder to become a member of city watch Leicester.
7. **MODIFY** the licence conditions to encompass the steps put forward by Mr Harvey at paragraph 9 of his submissions which includes that all security staff shall wear bodycams, and have access to an internal radio system. All staff to be trained on an accredited course such as ALPS (award for licensed premises staff).

REASONS

1. Committee identified that the cause or cause of the concerns which gave rise to this review was the failure of the premise licence holder to comply with its legal obligations under the licensing Act 2003 and that failure led to serious breaches amounting to criminal offences.
2. Committee determined that once the premise licence holder's director was notified of the serious breaches, through numerous verbal and written warnings his response was delayed and ineffective. A professional and competent business should be able to complete forms to appoint a DPS and to take the steps identified to them by the Police to address serious breaches of the licence conditions.

3. The Premise Licence holder's director attributed blame for much of the wrongdoing to incompetent staff however committee found that he failed to take responsibility and was culpable for the cause or causes which led to the police making the application for review.
4. The premises has 3 floors containing residential accommodation, and it is imperative that the premise licence holder complies with the modified condition relating to fire safety and follows any advice given by the fire service.
5. The committee was on balance persuaded to accept Mr Harvey's submissions not to revoke the licence however it accepted the concerns expressed by the police and determined that the remedial actions identified above were appropriate and proportionate to promote the licensing objectives relating to the promotion of crime and disorder, public safety and the prevention of public nuisance.
6. Committee determined that 1 month closure offered by Mr Harvey was not sufficient for the premises to train staff, appoint a new DPS, apply to vary the licence and to address the other shortcomings raised in this review and accordingly it was appropriate to suspend the licence for the period set out above.
7. The Premise licence holder should treat this decision as a final warning and take all necessary steps to ensure the promotion of the licensing objectives.

Any appeal against the decision must be made within 21 days to the Magistrates Court.

1. Summary

- 1.1 This report outlines an application under the Licensing Act 2003 for a variation to an existing premises licence for Donkey, 203 Welford Road, Leicester, LE2 6BH, and summarises the representations received. It also highlights the licensing objectives and the relevant parts of both the statutory guidance and the Licensing Authority's Licensing Policy.

2. Determination to be made

- 2.1 Having considered the application and representations, Members must consider whether to
- Grant the licence without modification
 - Modify the conditions of the licence
 - Reject the whole application

3. Application and promotion of the licensing objectives

- 3.1 An application was received on 11 November 2024 for a variation of an existing premises licence for Donkey, 203 Welford Road, Leicester. A copy of the application is attached at Appendix A.

3.3 The steps the applicant proposes to take to promote the licensing objectives are set out in the operating schedule (see section M of Appendix A).

3.4 The existing licence is attached at Appendix B.

3.5 In arriving at its decision on the application, the Licensing Authority's primary consideration must be the promotion of the licensing objectives.

4. Representations

- 4.1 A representation was received on 06 December 2024 from the Noise team. The representation relates to the prevention of public nuisance. The Noise Team are concerned that sound from regulated entertainment may travel across a wide area and customers at the premises may cause disruption to surrounding properties. A copy of the representation is attached at Appendix C1.
- 4.2 A representation was received on 04 December 2024 from the Licensing Enforcement team. The representation relates to the prevention of crime and disorder and the protection of children from harm. The Licensing Enforcement Team is concerned that the conditions on the application may not be sufficient to uphold these licensing objectives. A copy of the representation is attached at Appendix C2.
- 4.3 A representation was received on 09 December 2024 from a Castle ward councillor. The representation relates to the prevention of crime and disorder and the prevention of public nuisance. The representee is concerned that opening later will cause nuisance to residents. A copy of the representation is attached at Appendix C3.
- 4.4 Fifty-six representations were received throughout the representation period from members of the public. The representations relate to one or more of the licensing objectives. The representees are concerned that the hours proposed are not appropriate in a residential area and they have previously been disturbed by music emanating from the premises. Many are also concerned that later timings could result in more anti-social and criminal behaviour in the vicinity of the premises. Copies of the representations are attached at Appendix C4-C59.

5. Conditions

- 5.1 The conditions that are consistent with the application and the representations are attached at Appendix D.
- 5.2 The Live Music Act 2012 and the Legislative Reform (Entertainment Licensing) Order 2014 amended the Licensing Act 2003 in relation to the provision of regulated entertainment. Certain entertainment does not require a licence subject to audience limits, between 08.00 and 23.00 hours each day. These exemptions may affect the application under consideration because conditions may not be imposed at this stage to control live or recorded music that is unregulated. However, if problems do occur as a result of that entertainment then conditions may be imposed to control such music in the future after a formal review.

a) General – all four licensing objectives (b,c,d,e) (please read guidance note 11)

The premises currently operates as a live music venue and has done for multiple years, they welcome bands from all over and have always been known as a large music venue. During their time in operation, we are not aware of any complaints received against the premises and the venue has always worked with local neighbours to ensure that no nuisance is caused.

Given the changes proposed, we have carefully considered the application, the effect on the licensing objectives and the Council's Licensing Policy. The purpose for seeking later hours would allow the customers to continue their night in a safe and comfortable environment and give the premises slightly more flexibility around trading.

This variation application has also been submitted to update the premises licence conditions to ensure that they are suitable for the style of operation at the premises. We have taken the opportunity to offer an updated bespoke operating schedule to the hours proposed which has been carefully crafted ensuring it is robust, clear, appropriate and enforceable.

Considering the above, we believe that the variation would not have an adverse impact on the licensing objectives, and we believe that the measures proposed are adequate and will ensure the premises promote the licensing objectives.

Please see additional conditions we will be implementing as part of the variation:

b) The prevention of crime and disorder

1. If the premises is open beyond 01:30am Monday to Wednesday or beyond 02:30am Thursday to Saturday, the need for door supervisors will be assessed by way of a risk assessment carried out by the Designated Premises Supervisor or nominated person and cognisance will be taken of any Police advice.
2. Where SIA registered door supervisors are use at the premises, a record must be kept of their SIA registration number and the dates and times when they are on duty.
3. A CCTV system shall be installed at the premises. The CCTV system shall be maintained in working condition and record the premises when they are conducting licensable activities.
 - (a) All entry and exit points will be covered enabling frontal identification of every person entering in any light condition.
 - (b) The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises and will include the external area immediately outside the premises entrance.
 - (c) All recordings shall be stored for a minimum period of 31 days with date and time stamping.
 - (d) Viewing of recordings shall be made available immediately upon the request of Police or authorised officer throughout the entire 31-day period.
4. The Premises Licence Holder or nominated person shall ensure that all relevant members of staff receive training in their responsibilities under the Licensing Act 2003. Such training shall be documented, and records made available upon request from the Police or an authorised officer of the Licensing Authority.
5. A record of refusals shall be maintained which documents every instance that a sale of alcohol (and any other age restricted product) is refused on the premises, indicating the date and time the refusal was made, and the member of staff making the refusal. The record of refusals shall be available for inspection by authorised officers of the licensing authority, officers of the trading standards service, and officers of the police.
6. An incident log shall be kept at the premises for at least 12 months, and made available on request to a Police officer or an authorised officer of the licensing authority, which will record the following:

All crimes reported to or by the premises to the Police.

All ejections of patrons

Any incidents of crime and disorder

Seizures of drugs, offensive weapons, fraudulent ID or other items

Any faults with the CCTV system
Any refusal of the sale of alcohol

7. Drug prevention measures must be employed, and signs displayed.

c) Public safety

8. The premises will have first-aid facilities available on site.

d) The prevention of public nuisance

9. Clear legible notices are to be displayed at all exits from the premises requesting patrons to respect the needs of local residents and to leave the premises and area quietly.
10. A direct telephone number for the premises shall be available upon request to resident in the vicinity, to call at all times the premises are open.
11. The doors (except for access and egress) and windows to the premises will be kept closed at all times when there is regulated entertainment.

e) The protection of children from harm

12. A 'Challenge 25' policy shall be adopted, implemented, and maintained ensuring that all members of staff are trained to refuse supply to anyone who appears to be under the age of 25 and who is seeking to obtain any age restricted product unless that person provides credible photographic proof of age evidence. Such credible evidence shall include a photograph of the customer and acceptable form of ID. Examples of acceptable ID are limited to photo card driving licence, passports, military identification, or proof of age cards bearing the 'PASS' hologram. No other evidence of age and identity may be accepted.
13. Challenge 25 posters shall be displayed at the premises.
14. Children are not permitted on the premises beyond 10pm unless attending a specific event or private function.

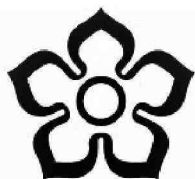

Annex 1 - Mandatory conditions

No supply of alcohol may be made under the premises licence -

- a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises-

- a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
 - i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supplied alcohol), or
 - ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-

- a) a holographic mark, or
- b) an ultraviolet feature.

The responsible person shall ensure that-

- a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
 - i) beer or cider: ½ pint;
 - ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - iii) still wine in a glass: 125 ml;
- b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

Annex 2 - Conditions consistent with the operating schedule

All external doors and windows must be kept closed, other than for access and egress, in all rooms when events involving amplified music or speech are taking place. (Note to applicant: Ventilation or air conditioning may be required in warm weather).

No food or drink shall be consumed outside of the premises after 23.00 hours.

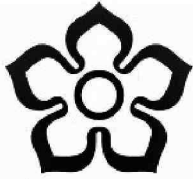

I have concerns regarding the playing of live and recorded music till early hours of the morning. The noise from live music acts and recorded music could affect the health of the residents nearby, with loud music and raised voices causing sleep deprivation. I wish to make an objection on the licencing objective of public nuisance.

The application does not state any other mitigation methods to manage the noise, other than the current condition of closing all doors and windows when there is regulated entertainment.

Additionally, the application states that a phone number would be available to residents in the vicinity to call at all times when the premises are open. This would be only a viable option for those people who are comfortable ringing to speak to a member of staff at the premises, as not everyone would be comfortable making a complaint regarding noise. Therefore, a more proactive approach managing public nuisance would be more beneficial.

Noise from on the street, as patrons are leaving is difficult to manage. Residents' sleep could be affected by patron shouting/singing, vehicles arriving and departing six days a week up until the early morning. The application has stated the premise would have notices displayed at the exits asking patrons to leave quietly. To prevent noise, however from experience this has limited effect on people when they are leaving.

The Noise and Pollution Control team have not witnessed noise nuisance since 2019. However, we have received initial complaints regarding amplified music from Donkey public house and unregulated amplified recorded and live music from the premises can affect the residents nearby. These complaints were from further away e.g. Howard Road/ Lorne Road than those properties adjacent to and close to the premises. This would indicate that noise disturbance, from the premises has potential to affect a large residential area.

I was informed that further sound insulation was being added to premises, by Savannah Courtenay (Flint Bishop Limited), to help reduce noise breakout. However, without an acoustic survey and pre and post noise assessment completed it would be difficult to identify the level of reduction this insulation has provided.

It is advised as a proactive measure to reduce the impact from of internal noise levels that a noise limiting device is installed at the premises and all regulated entertainment including live music is run through this device. Prior to opening, the noise limiting device shall be installed and the noise level set by the Noise and Pollution Control team.

It is very difficult to control the noise level from the on street activities as detailed

above. I would have serious concerns, in relation to any extension of hours beyond the current licensable hours for regulated entertainment. Therefore, I recommend refusal.

If the licence is granted it is requested the following conditions are added:

- Installation of a noise limiting device with the level set by the Noise and Pollution Control team
- Receiving of deliveries must only be conducted between 07:00hrs and 22:00hrs.
- Emptying, dispensing or disposing of bottles in outside bins must only be conducted between 07:00hrs and 22:00hrs.
- All external doors and windows shall be kept closed, other than for access and egress, in all rooms when events involving amplified/live music or speech are taking place.

*(Note to applicant this may mean that air conditioning is required

Seasonal variations have been applied for Christmas Eve, Boxing Day, New Years Eve and all Sundays before a Bank Holiday, to add one hour to the scheduled licensable activity/ closing time.

There will be no change to the provision of late night refreshment.

In addition, the applicant has asked to add additional conditions to the premises licence under Annex 2 of the existing Premises Licence LEIPRM0896.

The premises is located in a detached building on the ground floor at 203 Welford Road in the Castle Ward of Leicester.

The Licensing Authority believes that some of the additional conditions will be inadequate with regards to the prevention of crime and disorder and the protecting children from harm, and we have proposed alternative conditions which we believes will better fulfil the licensing objectives.

On Monday 25th November Elizabeth Arculus approached the agent Savannah Courtenay of Flint Bishop Limited via email to explain the Licensing Authorities position on the conditions proposed. Ms Courtenay subsequently confirmed that the applicant agreed to change the relevant conditions and include those proposed by the Licensing Authority.

The Licensing Authority do have concerns about the premises and the effects it may have on the local community, both business and residential. This relates to the detail of the operating schedule that has been applied for.

We believe that with the amendments and additions shown below that the premises and applicant could promote the licensing objectives in line with conducting their business in a safe manner.

I wish to object to the licence application for The Donkey Public House on the grounds of Public Nuisance and Prevention of Crime & Disorder.

The effects of the later hours will be to disturb local residents not just in terms of noise directly from the pub itself but also the coming and going of patrons arriving by cars and taxis with slamming doors and revving engines in what is a quiet residential area after midnight. The Donkey's Patrons are also likely to disturb residents by noisy conversations and rowdy behaviour into the small hours coming and going from the pub by foot.

The fact that this pub will be a late outlier in terms of licensing hours means it may well attract people who have been asked to leave other premises so will present an accumulation of people who will have, in all likelihood, consumed too much alcohol already leading to increased chances of alcohol fuelled crime as well as noise.

My main concerns are:

The Donkey public house has for many years created a public nuisance for local residents with its existing licensing hours and operation, playing loud music outdoors at weekends during the summer. Loud music can also frequently be heard in nearby properties when bands are playing inside at the venue during evening up until closing.

In the application the applicant describes the Donkey as 'a large music venue' this is worrying as it suggests that either the applicant has never actually seen the venue or they know nothing about the music industry, as the Donkey is certainly not a large music venue (and I say that as a personal licence holder and former DPS of various music venues in the East Midlands). The Donkey premises has no sound insulation meaning that sounds bleed out impacting dozens of nearby properties.

With the new University of Leicester 'student village' and the adjacent terrace housing, the Donkey is situated in arguably the city's highest density residential area. In addition the Council has just approved planning permission to create 54 student studio flats at 186 Welford Road, immediately opposite the Donkey.

The Donkey should have the same licensed operating hours as other Clarendon Park public houses, such as 'The New Road Inn', The Craddock and the Clarendon.

As a premises which was already causing a nuisance for local residents, this will only be multiplied many times by noise emanating from 'live and recorded music' playing until 2am, 4am and 5am on various nights. This will impact residents ability to sleep, especially in the summer when their windows may be open.

On top of this there will be the noise of patrons arriving and departing the venue throughout the night, some walking noisily through adjacent streets, other by cars and taxis, again increasing the noise levels in a residential area.

These proposed opening hours, suggest that the 'new' Donkey will have a very different operating model, aimed at a different client demographic.

The attraction of a pub outside the city centre with night club opening hours is likely to attract a range of customers from across the city and to attract the type of antisocial behaviour and crime and disorder associated with the city centre late night scene.

I would like to share my concerns with the request for extended opening and alcohol licensing hours at the Donkey pub in Clarendon park.

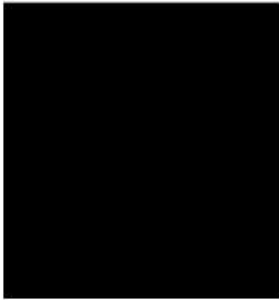


These new later hours will encourage more anti social behaviour which there is already in the area and bring more noise pollution to the area.

Essentially, a local pub is being turned into a nightclub. This is completely inappropriate for this area, for several reasons:


Noise. Music from the Donkey can be clearly heard inside properties on Howard Road and surrounding streets. The terraced houses serve, if anything, to increase the noise level, as the sound reflects from the buildings as it travels down the streets. While this is acceptable during the day and early evening, it would cause serious disturbance during the proposed hours.

Anti-social behaviour. It is reasonable to assume that people who have been drinking into the early hours will be intoxicated. They will be noisy and disruptive when leaving, and making their way through streets of family homes. This will seriously affect the quality of life of local residents.

Inappropriate location. Clarendon park is a residential area, housing working families with children, older, long-term residents, and in many cases people with disabilities. There are residential properties all around this venue whose occupants will be distressed at having to live next to a nightclub.

Local character. The busiest street in this area, Queens Road, has plenty of restaurants and bars which operate at normal licensing hours. These premises cause no problem to residents, and enhance the character of Clarendon Park. It's a nice place to be in the evening. The introduction of an all-night venue will have the opposite effect, destroying a quiet respectful area.

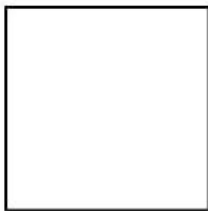
Alternative venues. The city centre has abundant night-life opportunities. We don't need more of them here. Please consider these matters when making your decision.

It was with great disappointment that we, as locals residing on Howard Road since 1978, learnt of the imminent closure of The Donkey on Welford Road and an application by the new owners for a change to its licence.

In common with many other locals, my family & I are most unhappy about the terms of this new application. As we live close to The Donkey [REDACTED] we are likely to be among those most impacted if the application is approved.

THIS IS A RESIDENTIAL AREA. The fact that The Donkey is itself situated on a main road should not be entertained as an argument that it is not in, and does not affect, a residential area. The proposal to extend the alcohol sale hours and use of recorded & live music until 2.00 am (Mon & Tues), 4.00 am (Weds & Thurs) and 5.00 am (Fri & Sat), with corresponding opening hours of 2.30 am, 4.30 am and 5.30 am, is outrageous and totally unacceptable within this residential community. We already have regular instances of night-time noise and public nuisance in this area. This is largely associated with the student population. There is a high risk of such noise & nuisance becoming exacerbated by such extended opening hours.

The Donkey was a much-loved local amenity with quality musical entertainment (...I know, I've played there myself!) within sensible hours. If the intention is to turn it into a city centre type bar/venue, it is likely to have a highly detrimental effect on the area. Loud music after midnight and potentially antisocial behaviour are not acceptable to local residents. There seems to be a move towards trying to turn the entire area into a student village. Approval of this planning application would simply reinforce that situation. In any event, no public house in a RESIDENTIAL AREA (irrespective of local population makeup) can justify such late opening hours.

I urge you to reject the application. With the exception of special events and public holidays, opening hours beyond midnight are inappropriate and unacceptable in this RESIDENTIAL AREA.



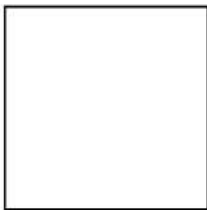

The Donkey, Welford Road, variation of premises licence

I **object** to this variation on the grounds it will be against the licensing objectives to prevent public nuisance or crime and disorder.

- Contrary to what is said in the application I have heard many local people complain about noise, particularly music noise, from The Donkey. Even though I live nearly half a mile away as crow flies, in recent years I could hear music noise from them in summer, which is only irritating here, but adds to the many sources of such noise we get. Music from there can be clearly heard on Victoria Park
- Noise levels would be much louder in the terraces and flats close by The Donkey. Recently a new student development was allowed on appeal - directly opposite at 186 Welford Road. This is aimed at those such as post-grad students, who may want a quieter environment than the large student block experience. Though residents in the extensive multi-storey student housing around Putney Road have themselves complained about noise from The Donkey, principally music noise, from both inside and outside.
- Before it closed, The Donkey had last orders at 11pm, and was generally closed by around midnight for the weekday live music events. They didn't use the full extent of their licenced hours. Which means that the variation is even more of a change than it might appear.
- 'All-nighters' have their place, but need to be carefully sited, well away from dense housing. Public nuisance comes not just from the premises, but from people leaving and returning home at unsocial hours and often very drunk. It is a different style and customer base and known that people drinking for long periods expect music volume to increase as the night wears on. Such drunkenness can go beyond nuisance and turn into crime, committed by and to customers. This is not an appropriate location so close to dense housing. We already have the O2 and student union to cater for the late hour need locally, well away from housing.
- I cannot think of any conditions that could make the proposed extension in hours acceptable.
- However if any extension was granted it's important to apply conditions to close the outside yard at earlier hours. Until this licence application I didn't realise that The Donkey's current licence only allows music indoors. However in reality the yard was used for regular outdoor music events as can be seen in the attached photo taken from Google Earth. Living near to a number of licensed

premises I know how much disturbance can come from outdoor activity - even when it is just conversation with its sudden bursts of laughter and squeals. There are homes adjoining the yard. This application is also only for indoor music – however experience suggests that may be difficult to enforce, and that the indoor music noise levels would be unacceptable without further controls even at more reasonable hours.

I am a resident of Lorne Road and have very strong objections to the proposed change in licensing hours for the Donkey.

The Donkey already causes significant disruption and public nuisance by playing extremely loud music on Friday, Saturday, and Sunday afternoons. It is especially disruptive on a Friday during working hours when it is clearly audible from inside the house with the windows closed. The volume is such that there's no point listening to music in my own home as it's drowned out.

The idea of this behaviour being extended by the Donkey opening all night is absolutely outrageous. This is a residential area inhabited by many families and older people.

We have a school-aged child who has just started high school. This is a very important stage of her education which runs the risk of being completely derailed if she is disturbed by late night revellers every single night of the week.

Granting this sort of license directly impacts her safety from harm in terms of simply getting a decent night's sleep on a school night. Not to mention drunks roaming the streets at all hours dropping takeaway litter, breaking glass bottles and starting fights.

We also have two adults with full time jobs who need a decent night's sleep. We definitely do not need a night club within earshot 7 nights a week.

I strongly object to this proposal. Regular pub hours are more than enough disruption in a residential area where people are raising families and older people are trying to live a peaceful existence.

This proposal directly impacts the community around the venue from the point of view of increased disorder, public nuisance, and the harmful impact on children who live closeby.

Please do not grant this license or any extension beyond normal pub hours.

I am writing to you to object strongly to the proposals for the above premises to extend the hours for the sale of alcohol, live music and recorded music.

We live, as a family with children on [REDACTED] Lorne Road, alongside other families with young children in the immediate vicinity. We have lived here 12 years and during

the summer months, in particular, we experience the loud music from the Donkey which is disruptive and audible from the inside our house, but at least we know this will cease at a reasonable time. We are not the closest home and I have no doubt many more homes experience this disruption now.

Frankly, the proposal put forward in extending the hours on every day of the week 2.30am, 4.30am and 5.30am, except Sunday, is ridiculous in what is primarily a residential area. Based on our experience to date of the noise disruption we experience this should not be accepted.

I am equally concerned by the aspects of the proposal, alongside music, to include selling alcohol until 2.30am, 4.30am and 5.30am which is not dissimilar to the hours of a nightclub opening. This will certainly increase disruption with people coming into the neighbourhood aware of this from all parts of the city as a destination, including public nuisance, noise and potentially antisocial behaviour.

Whilst we acknowledge and accommodate the current level of disruption (by being reasonable citizens), the current proposal is disproportionate to what should be acceptable within a residential neighbourhood and shows complete disregard and disrespect for the residents and families and the neighbourhood they are located in. The Donkey is not located in an isolated part of the city, adjacent to non-residential uses and if this application was approved this would set a worrying precedent for other venues in similar locations.

I am not supportive of the new owner's application to extend the pub's opening hours and I am lodging an objection to these plans, my reasons are below. I am objecting under the Prevention of Crime and Disorder, the Prevention of Public Nuisance, and the Protection of Children from Harm.

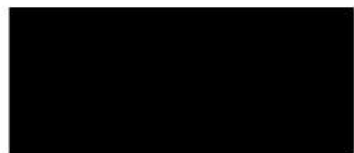
- If the opening hours are allowed to be extended as requested, this would lead to an increase in noise near to my home which would include music, plus loud talking, laughing, shouting, and shrieking from people in the beer garden or arriving at/leaving the pub, car doors slamming, and cars playing loud music when they arrive/before they are driven away. The noise would make it difficult for my family (and other nearby residents) to sleep and this a concern as we need to get up early in the morning to go to work, and to school. My children would not be able to sleep through the above pub-related noise and it would not be fair to inflict this on them, as would have a detrimental effect on their ability to learn at school due to them being tired and potentially stressed.

- The noise of the people in the bar garden sounds incredibly loud late at night. On previous occasions I have been unable to sleep or open my bedroom window on a hot evening until they disperse, but as this would happen around midnight-ish, I could manage this. If the extension is granted, the noise of the beer garden could disturb me until up to 2.30am or 4.30am during the week and this is unthinkable as I need to get up at 6.30am the next day to get ready for work, and my children get up at 7am to get ready for school.
- I would be very concerned that the music would not be kept within agreed levels, and this can lead to the noise of the loud vibrations of the pub windows reverberating around my house. I have also physically felt the vibrations of loud bass while in my home.
- There could be an increase in pub-related rubbish left in the street, including glasses, bottles, and vomit. The glasses and bottles are likely to get smashed, so would result in broken glass on the street which is a danger to residents, especially for the children who walk past the pub on the way to school. Those who catch a school bus at the stop near the Donkey would be subjected to seeing whatever detritus had been left there from the late night drinkers the night before.
- There is the possibility that violent altercations could occur late at night/early in the morning between drunken people which would be loud, unsettling and scary for nearby residents, particularly the children.
- Intentional or unintentional damage to cars and properties could occur, with people leaving the pub very early in the morning. People could use the entries/side passages of the nearby houses as toilets when leaving the pub, or urinate up the walls of houses.
- Due to the design of the streetlights, Westbury Road is only well lit directly under the streetlight and in between them it can be quite dark. I would feel unsafe if I returned home in the early hours of the morning and I knew that people who had potentially been drinking for a long period of time could be in the area, due the late opening hours of the pub. I would feel more at risk of being assaulted.
- I would be worried about drugs becoming a problem near my home, either because of people taking them, or because people would come here to sell them. There could be potential for drug related paraphernalia to be scattered around the street (e.g. nitrous oxide cannisters). I live here with children and I do not want them to be exposed to that.
- To be able to open one hour later on Christmas Eve, Boxing Day, New Year's Eve and the Bank Holiday Sundays would be unfair on the local residents as we would want to enjoy those stated days too, and if any of the points I made above were to happen it could ruin the day (e.g. loud music played too late).
- If the music is too loud late at night, I am unable to do anything about it there and then and have to suffer it, until the pub landlord decides to turn it off.
- Not all of the people who will go there to drink until the early hours will respect that this is a residential area and act appropriately, even if the pub landlord tells them to.
- I currently hear large groups of students cheering on a Wednesday night (University sports Wednesdays), however they are not nearby. If they were to convene in the Donkey because they knew that they could stay there until 4.30am, the noise they would make could not be limited or "turned down". This would not be acceptable in a residential area.

Many of the concerns I have mentioned above are based on my previous experiences of living near the pub, including points raised re the noise in the beer garden and in the street, the rubbish that I have seen left outside the pub, arguments and fights heard, drugs being sold, people urinating (or worse) in the street and entries/side passages of the houses.

The requested opening hours are simply not suitable for a venue which is in a residential area.

I'd appreciate your support in addressing my concerns with the licensing authority. Thank you for your support.

This public house is notorious for ignoring volume restraints, no matter who has owned it, How can you evidence this not be the case in this instance.

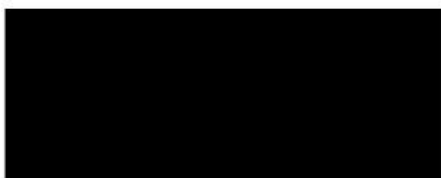

Re: The Donkey – Extension of Opening Hours

I am writing to object to the proposed extension of operating hours for The Donkey Pub on behalf of myself and my family, who reside on Westbury Road. We have serious concerns about the impact this will have on our neighbourhood and its residents.

1. Consideration for Residents – Protection of Wellbeing, Including Children and the Elderly

Our community is home to schoolchildren, university students, elderly residents, and working professionals, all of whom depend on uninterrupted sleep for early starts and busy schedules.

As someone who is in higher education, I rely on sufficient rest to perform well in my studies. I also suffer from migraines, as does my sister, and insufficient sleep significantly worsens our condition. My parents, who work full-time, and my elderly neighbours, who have lived on this street for decades, also need their rest. Extending pub hours to such late times would drastically disrupt the peace and quiet we need for our wellbeing.

2. Noise Pollution – Public Nuisance

Noise pollution from the pub is already a problem, particularly during the summer months. While we have tolerated loud music and gatherings during this time out of respect for others' enjoyment, extending these disturbances throughout the year and late into the night (as late as 5:00 a.m. on weekends) is unacceptable.

The new licence application makes me question whether Star Pubs and Bars consider the impact on residents. This is a residential area, where most people sleep during the night and work or study during the day. The balance between business operations and community wellbeing is clearly being ignored.

3. Parking Issues

Parking on Westbury Road is already a significant problem, particularly in the evenings and weekends. Cars often block driveways, and the congestion makes it difficult for emergency vehicles to access our cul-de-sac. Extending the pub's operating hours will worsen this situation, as patrons park their vehicles here well into the early morning, creating further inconvenience for residents.

4. Antisocial Behaviour – Crime and Disorder

Longer operating hours raise the risk of antisocial behaviour, including noise, littering, and disturbances late at night. This not only impacts the safety of residents but also puts additional strain on local services. The proposed hours will make the neighbourhood less secure and more stressful for those living here.

Conclusion

While I understand the value of The Donkey Pub to the local community, this should not come at the expense of residents' quality of life. The proposed extension of operating hours is unreasonable and detrimental to the wellbeing of our neighbourhood.

I am writing to formally object to the application for extended opening hours submitted by The Donkey Pub. As a resident living in close proximity to the pub, I strongly oppose the proposed

changes due to the significant and detrimental impact these extended hours would have on the local community, including myself and my family.

The Donkey Pub is situated in a predominantly residential area, and the proposed later closing times would exacerbate noise disturbances during unsociable hours. This is especially concerning for families with young children and residents who require a quiet environment at night. I am currently in the late stages of pregnancy, expecting my first child in the early new year. These pubs adhere to standard alcohol licensing times, ensuring a more balanced approach to the needs of businesses and the surrounding community. There is no justification for The Donkey Pub to be treated differently or granted preferential treatment that disproportionately impacts local residents.

This will lead to clientele coming and going in an intoxicated state at all hours of the night, every night, in what is a residential area which contains some students but also many working families.

Since moving to Fleetwood Road in April, we have experienced typically low-level noise by people passing through but occasionally significant noise disturbance at anti-social hours (e.g. a group of around 20 drunk students congregating outside a house on Lytham Road / students setting off fireworks next to the planter directly outside of our home). The creation an almost 24/7 nightclub in the vicinity will without question increase the amount of noise nuisance suffered in this area and there is nothing that the venue operators could do to prevent that. The hours suggested are more obviously suitable to a city centre venue than a suburban one.

Please give further details of WHY you believe this application will have an adverse effect on the licensing objectives : Students from the local area and beyond will be attracted to the venue and will spill out into the nearby residential streets in states of high intoxication at extremely anti-social hours, on every night of the week. The extreme nature of the opening hours raise the strong possibility that some of those people will be using not just alcohol but also illegal drugs (e.g. ecstasy, amphetamines, cocaine) in order to stay up so late.

From our back garden, we can very clearly hear any gigs that take place at The Donkey - loud nightclub music would similarly be a problem unless significant measures were taken to mitigate this. Anti-social noise pollution would be a particular problem on warm summer nights, when we need windows open to keep the temperature down for our young children.

I am emailing to lodge my objections to the new management of The Donkey's application to extend their hours for both music and alcohol. The posted proposal is to extend to 2.30 am Mon and Tues, 4.30am weds and Thurs, and 5.30am Fri and Sat.

For alcohol service alone, these hours concern me. The area is not a nightlife area, and the Donkey's proposed hours would likely make it the only venue open beyond midnight. There will be insufficient police presence in the area to respond to trouble associated with excessively drunk patrons. Beyond the security concerns, there is little reason for a pub to stay open until 5.30am other than for the purposes of excessive drinking. It will be disruptive to nearby residents.

The Donkey has traditionally been associated with live music. It is a very noisy pub. We live nearby but don't neighbour it, and yet we often hear performances from our house. An extension of their license, especially if it includes extended hours for recorded and live music, will be disruptive to the neighbouring population, and as with the late opening hours - not compatible with what is a largely residential area. I have no confidence that the Donkey will limit their noise (they have not done so previously) and the longer operational hours will mean that they're even less bound by sensible cutoffs and curfews.

In my opinion the extended hours are wholly incompatible with a residential neighbourhood, and the Donkey's patrons and staff have no previous track record of consideration for their neighbours.

I know of at least 6 cars whose side doors were badly damaged, in what looks like damage from someone reversing into their side door, likely at night, and this is more likely to happen if the driver had had a drink (or more than one).

PUBLIC SAFETY: my subjective feeling is of reduced public safety if the opening hours were extended. (This includes worries about drug use in the surrounding area).

Not only is the noise a problem currently (it really is so loud often it can be heard down the street), but also extending the alcohol license so late would result in drunk people going down the street at all hours of the night, who often will be singing or shouting loudly causing disturbance to those sleeping, but also are prone to vomiting on pavements and breaking glassware in the street, which is unpleasant and dangerous for dogs and cyclists, of which there are many due to the highly residential nature of this area of Clarendon Park and Knighton.

Please give further details of WHY you believe this application will have an adverse effect on the licensing objectives : I believe the problems outlined above are likely partly due to a high local student population who would be likely to use the establishment during the early hours of the morning as proposed, and because the late opening hours and alcohol license will encourage drunkenness and disorderliness in a way that normal hours of pubs do not, at least not outside the times of Friday and Saturday nights with a big football game which tend to die down by the time people are putting their kids to sleep. Additionally, because of the inability of the establishment to contain the noise as already stands.

Are there any changes that could be made to the application that would reduce or remove your concerns?: Yes

Please explain what changes you think would help: Normal pub opening hours would be fine if they want to play live music on other days, with very strict rules on noise such that it would be inaudible outside the premises with the doors closed, and strict decibel limits inside the building if that is necessary to achieve that aim.

On behalf of Friends of Clarendon Park, I **object** to this application on the grounds of:

- 1) Prevention of Public Nuisance
- 2) Prevention of Crime and Disorder

Current Licence

The Donkey's current Premises Licence WITH Alcohol LEIPRM0896 includes the following licensable activities:

- Performance of live music (indoors only)
- Playing of recorded music (indoors only)
- Provision of late night refreshment (indoors & outdoors)
- Supply of alcohol (ON and OFF the premises)

The regular licensed opening hours are until: 1:30am Mon-Wed, 2:30am Thu-Sat & 1:00am Sun

In addition to the mandatory conditions, the licence includes two conditions consistent with the operating schedule:

- All external doors and windows must be kept closed, other than for access and egress, in all rooms when events involving amplified music or speech are taking place.
- No food or drink shall be consumed outside of the premises after 23:00 hours.

Variation Application

This variation application proposes extending the licensed opening hours to: 2:30am Mon-Tue, 4:30am Wed-Thu & 5:30am Fri-Sat. The application states that “The premises currently operates as a live music venue and has done for multiple years” and the signwriting on the front of the premises says “Live music since 2005”. However, prior to this, when many residents would have moved in, the premises operated as a regular pub without live music. The application also states that “We are not aware of any complaints received against the premises and the venue has always worked with local neighbours to ensure that no nuisance is caused”, but this is completely at odds with the long history of complaints from residents living in the vicinity of The Donkey.

Comparison

Similar premises to The Donkey in the Clarendon Park area are The New Road Inn (201 Welford Road), The Clarendon (7-9 West Avenue), The Old Horse (198 London Road) and The Cradock Arms (201 Knighton Road), which have licensed opening hours until:

The New Road Inn: 1:00am Sun-Wed & 2:00am Thu-Sat

The Clarendon: Midnight-midnight Mon-Sun

The Old Horse: 12:30am Sun-Thu & 1:30am Fri-Sat

Objection

Unlike the city centre pubs, clubs and music venues, The Donkey is situated in a residential area, surrounded by terraced houses and student flats, with a new block of 50 student flats recently granted planning permission directly across Welford Road. The Donkey’s existing premises licence already allows it to open more than late enough for any pub in a residential area. The variation would allow it to open later than many city centre pubs, clubs and music venues, including Firebug, which are in non-residential areas. Despite actually closing at 11:00pm or 12:00am in recent years, there are regular complaints about the noise from The Donkey when they have music indoors and even more complaints when they have (unlicensed?) music outdoors, which can be heard all over Clarendon Park and Victoria Park. In addition to the direct noise nuisance of the music having an adverse impact on local residents quality of life, this is compounded by the noise from people leaving the venue late at night and early in the morning and the anti-social behaviour that inevitably occurs when large numbers of drunken people are making their way home. Extending the existing hours will only exacerbate this with people not just leaving but also arriving on foot and by cars and taxis during the normal sleep hours of 11:00pm to 7:00am. The requested opening hours suggest that The Donkey wants to operate the premises on a different business model, one that may be suited to the city centre but not to a residential area.

Mitigation

The Donkey was not built as a music venue and as such has no sound insulation or double glazing. Both of these measures could help to reduce noise escaping from within the premises but would not address the noise of outdoor music. It may be possible to impose a limit on the noise levels permitted outside the venue but experience of this venue suggests it is unlikely that these would be complied with or that they would be enforced. Realistically, the only way to reduce or remove these concerns is to limit the licensed hours for live and recorded music to those compatible with The Donkey’s location in a densely populated residential area.

Please summarise your concerns about this application: The Donkey pub is in a residential area, with houses in a close proximity. Clarendon Park is quiet residential area with a mixture of residents where families with young children and older residents, including pensioners, live along side a relatively large student population.

Given the location of the pub, in a residential area, make the opening hours applied for totally unacceptable. The closing hours applied for 2, 4 and 5 am would make the Donkey a late night drinking venue and clearly this would raise serious concerns regarding :

Late night noise from customers arriving/leaving the pub

Antisocial behavior and crime from customers arriving/leaving the pub

Concerns regarding safety of local people and customers.

The potential for the pub to attract criminal activity in relation to drugs etc.

If a pub is open to the hours applied for it is inevitable that customers are going to be highly likely to have excessive amounts of alcohol and this will cause all of the above issues. (They are not going there to have a coffee and a chat with their mates !)

It is already noticeable in Clarendon Park that excessive late night noise and antisocial/criminal behavior occurs when there are student "events" on and students go out/come home "under the influence" . Given the location of the Donkey it would appear that students are a significant part of the targeted customer base and the opening hours applied for make the likelihood of this happening six days a week.

If this application is approved it will significantly impact on local residents and has the potential to drive families out of the area and leave Clarendon Park with an imbalance of residents. This has an impact on local services , shops, schools etc.. Is it not an objective of the City Council to protect the area from this ?

Please give further details of WHY you believe this application will have an adverse effect on the licensing objectives : The Area it is located in - residential, huge potential disruption to the local community .

The opening hours make this a late night venue and inevitably that sort of venue causes issues re noise, nuisance, criminality and sadly violence .(are you going to have city center policing in Clarendon park to control this ?) Subject: Objection to Variation of Premises Licence for The Donkey, 203 Welford Road

I am writing to formally object to the application for a variation of the premises licence for The Donkey pub at 203 Welford Road. The proposed extension of operating hours, particularly the sale of alcohol and live music until 5:00 AM on weekends and 4:00 AM on weekdays, raises significant concerns for the local community.

Firstly, extending these hours will likely result in increased noise disturbances during the early morning hours. Clarendon Park is a residential area, home to families with young children, elderly residents, professionals, and students. The impact of late-night patrons leaving the venue, coupled with amplified music, will create an intolerable environment, negatively affecting the quality of life for residents and disturbing their sleep up to six nights a week. Furthermore, the plans for noise proofing the venue will not effectively mitigate the external noise generated by people gathering

outside to socialise or smoke, especially during the summer months when outdoor activities tend to increase.

Additionally, the foot traffic associated with a late-night establishment could lead to safety concerns and an increase in anti-social behaviour, issues for which The Donkey will not be held accountable to. Our streets are not designed to handle the volume of late-night patrons, placing residents' safety, as well as the security of their properties and vehicles, at risk. There has already been an increase in vehicle damage in the area, including keying, damage to wing mirrors and wiper blades, and other vandalism. These issues strain local police resources, and we are concerned that further disturbances, such as public urination, shouting, and littering (including broken glass), will follow. The proximity of Avenue Primary School (just 0.4 miles away) exacerbates these concerns, especially regarding the safety and well-being of local children. The presence of intoxicated individuals also poses a hazard to residents, particularly those travelling to and from shift work or students using the 24-hour library at Leicester University.

The Donkey should be subject to the same licensing conditions as other local venues, such as The Clarendon (which closes at 11:00 PM) and neighbouring venue The New Road Inn (which closes at 12:00 AM), both of which do not feature live or recorded music. Extending The Donkey's hours to the proposed times would likely attract already intoxicated individuals from city centre venues, such as the nightclub MOSH, which closes two and a half hours earlier than the proposed hours for The Donkey.

The applicant's assurances of a robust security and management plan are insufficient to mitigate the risks associated with such extended hours, especially given the lack of detail on how potential issues will be addressed. Moreover, the absence of complaints to date does not necessarily reflect the future impact of the venue's operation on the neighbourhood. As the area evolves, it is likely that such disturbances will increase.

In light of these concerns, I respectfully urge the licensing committee to carefully consider the potential negative impact of this application on the local community. The proposed changes are not in the best interests of residents and could lead to significant disruptions.

Thank you for considering my objections. I trust the committee will act in the best interests of the community by rejecting this application.

CONDITIONS

CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE
If the premises is open beyond 01:30am Monday to Wednesday or beyond 02:30am Thursday to Saturday, the need for door supervisors will be assessed by way of a risk assessment carried out by the Designated Premises Supervisor or nominated person and cognisance will be taken of any Police advice.
Where SIA registered door supervisors are use at the premises, a record must be kept of their SIA registration number and the dates and times when they are on duty.
A CCTV system shall be installed at the premises. The CCTV system shall be maintained in working condition and record the premises when they are conducting licensable activities.
(a) All entry and exit points will be covered enabling frontal identification of every person entering in any light condition.
(b) The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises and will include the external area immediately outside the premises entrance.
(c) All recordings shall be stored for a minimum period of 31 days with date and time stamping.
(d) Viewing of recordings shall be made available immediately upon the request of Police or authorised officer throughout the entire 31-day period.
The Premises Licence Holder or nominated person shall ensure that all relevant members of staff receive training in their responsibilities under the Licensing Act 2003. Such training shall be documented, and records made available upon request from the Police or an authorised officer of the Licensing Authority.
A record of refusals shall be maintained which documents every instance that a sale of alcohol (and any other age restricted product) is refused on the premises, indicating the date and time the refusal was made, and the member of staff making the refusal. All ejections of patrons Any incidents of crime and disorder Seizures of drugs, offensive weapons, fraudulent ID or other items Any faults with the CCTV system Any refusal of the sale of alcohol
