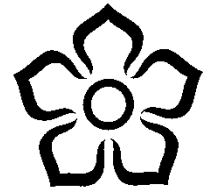

## **Appendix 1 – Highways Update**

### **Flooding 6<sup>th</sup> January 2025**

On 5<sup>th</sup> and 6<sup>th</sup> January, we saw an unprecedented situation. The combination of the rapid thawing of the weekend's snowfall, saturated ground and two inches of rainfall across the River Soar catchment south and east of the city, brought about a massive rise in the level of the Melton Brook between midnight and 8am on Monday 6th January. This resulted in the brook bursting its banks and flooding the Humberstone Lane area. Later that day the River Soar also flooded areas around Belgrave.

The Environment Agency (EA) manages the risk of flooding from the Melton Brook and the council will be investigating the cause of the flooding from Melton Brook in conjunction with the EA.

Over the 6<sup>th</sup> & 7<sup>th</sup> January, as the flooding developed, we had teams working around the clock to deal with the impact of this flooding across the city. Highways teams were busy dealing with road closures and providing support to flooded properties, social care identified vulnerable services users to offer help if needed and the emergency management team opened rest centres at Sandfield Close and Belgrave Neighbourhood Centre, providing clothing and other support.

Any residents or businesses whose property was affected internally by the flooding can report this to us via the council's website.

### **School Run Parking Issues**

Falcons Primary school off Herongate Road is a problem school at school run times, but we have had a recent enforcement operation there. We are also looking at installing additional bollards on street corners to prevent pavement parking in some locations.

Further parking enforcement activity around school is programmed to take place in the coming months at Sandfield Close Primary and North Mead Primary Academy.

### **Gipsy Lane/Woodgreen Road Zebra Crossing**

The council's Road Safety Team are currently undertaking a review into the safety of the zebra crossing on Gipsy Lane near Woodgreen Road following concerns being raised by Ward Councillors. They will be examining accident details and exploring possible options to reduce speeds along this stretch of Gipsy Lane.

### **Victoria Road East**

Concerns have been raised by Ward Councillors into the condition of the footways near the shops on Victoria Road East. The Highway Maintenance team will be assessing the condition in the coming week and will feed back to Ward Councillors.

### **Utility Street Works**

Cadent Gas will be undertaking work to renew gas mains along Barkby Road between January and March. The works will require road and lane closures with signed diversions in place.

### **Highway Maintenance**

Works completed in the last 2 years in the ward include:

- Replacement of damaged crash barriers at Thurmaston Lane roundabout with Victoria Road East
- Victoria Road East (Gipsy Lane to Hastings Road junction)
- Thurmaston Lane Roundabout
- Faldo Close
