**ANNEXES**

**Annex 1 - Mandatory conditions**

No supply of alcohol may be made under the premises licence -

- a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-

- a) a holographic mark, or
- b) an ultraviolet feature.

A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

**Annex 2 - Conditions consistent with the operating schedule**

The restrictions in this Annex do not prohibit any sale, supply or consumption of alcohol previously permitted by the Licensing Act 1964.

Alcohol shall not be sold or supplied unless it is paid for before or at the time when it is sold or supplied.

Alcohol shall not be sold or supplied except during the hours permitted by the licence.

Alcohol shall not be sold in an open container or be consumed in the licensed premises.

The licence holder will ensure that CCTV will be retained for a minimum of 28 days and made available within 24 hours of a request being made by a relevant authority.

The licence holder will ensure that a member of staff will be present at all times that the shop is open to the public who is trained to operate the CCTV.

The licence holder will ensure that CCTV is installed inside and outside

The licence holder will ensure that staff training will be refreshed every 12 months and a written log will remain on the premises and produced to the relevant authorities when requested

The licence holder will ensure that a refusal and incident book is kept on the premises and will be kept up to date and produced when requested by the relevant authorities.

The licence holder will ensure that the premises is kept clean and clear of any obstructions to customers

The licence holder will ensure the acceptance of proof of age cards and / or passports and photographic driving licences

The licence holder will ensure that staff are trained and aware of any potential underage purchase attempts

The licence holder will ensure that Challenge 21 posters will be displayed

The licence holder will ensure that no dustbins will be emptied before the shop opens or after the shop closes.

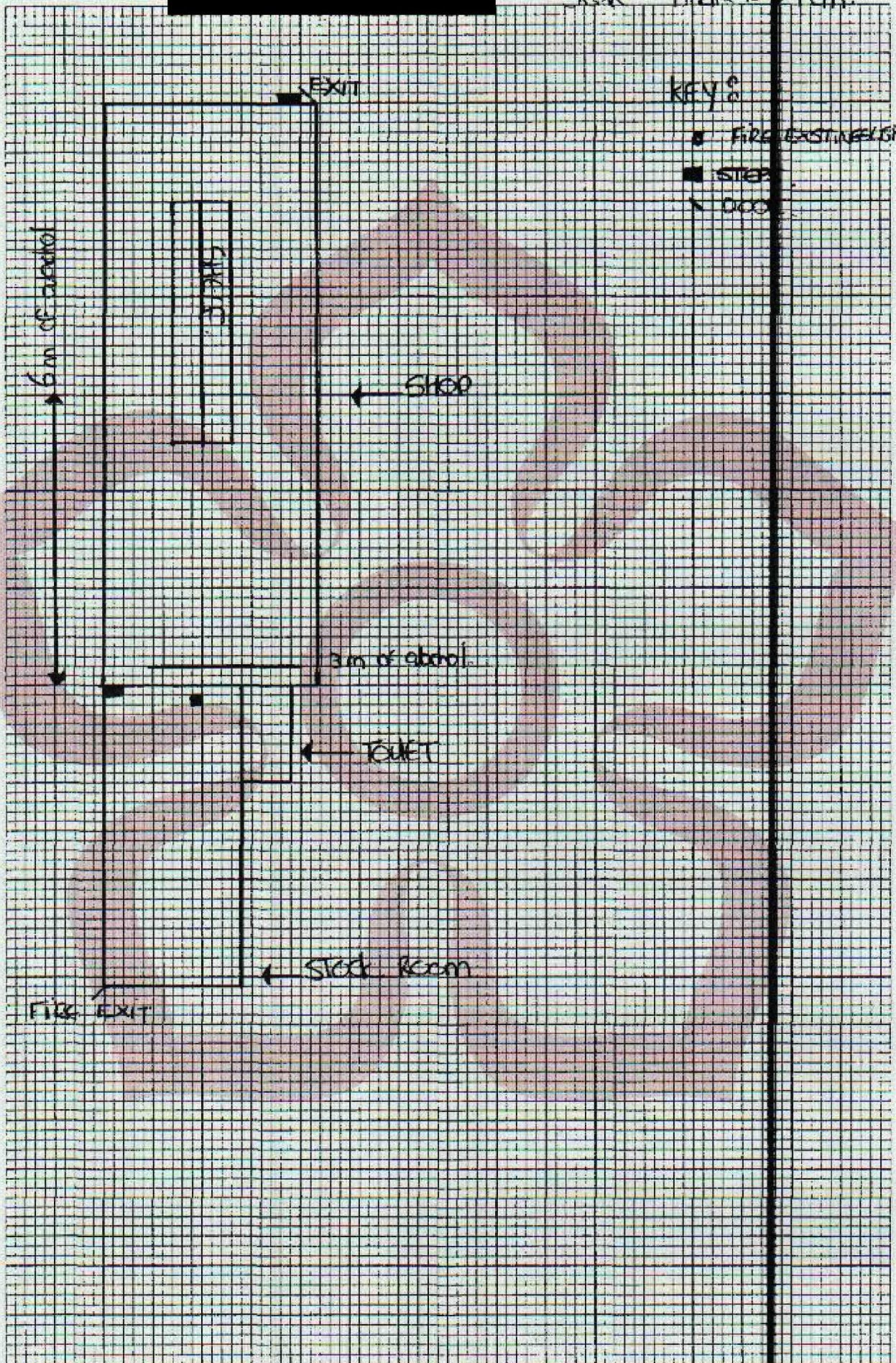
