### 5. SCHOOL ADMISSION ARRANGEMENTS FOR 2006 Appendix B

Councillor Waddington submits a report summarising the results of the annual statutory consultation on admission arrangements and limits for entry into schools for 2006, and proposes arrangements for implementation. operation and adopt the proposed model policy for F1 entry into part time education in a mainstream school.
