## **Appendix 1 - Leicestershire Police**

### Priorities and actions taken:

Drugs – we have a number of drug warrants in the local area in the past few months, but we are aware it is still a prevalent issue. Officers will continue to make this a priority, building intelligence to disrupt dealing and deal with offenders. We have had several reports from you telling us about suspected drug dealing taking place on the estate. Officers have visited the areas and are now working to develop the intelligence further and disrupt the activity.

ASB - With the nights getting lighter, you have told us you are concerned ASB on Maris Lane and TikTok park will increase. Officers will be in these areas carrying out proactive patrols to reduce ASB related issues. They will be working with partner agencies and local schools to educate and engage with young people. Foot patrols have been completed at the mud dumps after a report of graffiti. Officers have also been patrolling Neston Gardens on the area around Maris Lane following reports of kids being involved in ASB.

Off road bikes - You have told us that e-scooters and off road bikes are being ridden across TikTok park and dangerously around the estate. With the nights getting lighter, we will be carrying out patrols to try and tackle this issue. Officers attended a report of four off road bikes weaving in and out of traffic on Knighton Lane East. Unfortunately, they had gone on arrival. A quad bike with a flat tyre was seen on TikTok park. Due to it not being seen ridden, it was not seized but checks have been done and the owner spoken to.

The priorities are determined from surveys via Neighbourhood Link and other data we generate. The priorities are reviewed every 3 months and action taken is updated monthly. # Bins on Streets – Residential & Commercial Bins on Streets – Residential & Commercial

Working with residents and landlords to remove bins from the pavements along with businesses to remove commercial bins once they have been emptied. Abandoned bins are removed as quick as possible from our streets.

Within the Saffron Ward **250 Fixed Penalty Notices** have been issued to properties leaving bins on the pavements.

Please help to keep our streets clean, and ensure your bin is removed from the public highway after collection and not left on the street.

## Fly Posters

Over the last few months 18 Fixed Penalty Notices have been issued within the Saffron Ward for Businesses attaching posters and A Boards to street furniture without permission. With some pending court cases.

## **Obstructions**

Building Materials left on the Public Highway Enforcement Notices sent to properties and materials removed.

## Commercial Business premises within Saffron Ward

Inspections will commence shortly to ensure business waste is disposed of correctly under Section 34 of The environmental Protection Act 1990.





### **Appendix 3 - Highways Update**

## **Highways Maintenance Works**

We continue to inspect the footways and carriageways around the ward and repair actionable defects as we find them on our inspections.

## Works completed 23/24

- Saffron Lane (Burnaston Road to Pork Pie Island) Carriageway Resurfacing completed July 2023.
- Eastern Boulevard (Upperton Road to Mill Lane) Carriageway Resurfacing Completed April 2024 Speed Cushion remains to be completed. See works programmed 24/25
- Freemen's Common Road Footway Works (Counting House Road to Commercial Square) Completed March 2024.

## Works Programmed 24/25

- Saffron Lane Carriageway Resurfacing (Cyprus Road to Fayhurst Road)
- Eastern Boulevard Speed cushion installation on 20th May, for approximately 5 days

## Road Safety Schemes

#### School Streets

Sustrans are working with Hazel Primary School to deliver road safety assemblies and walking and cycling activities. We will also be delivering Bikeabilty training with them in the upcoming term.

In addition, we continue to undertake school patrols with our parking enforcement team:

Hazel Street Primary had programmed visits on the 7<sup>th</sup> April and 2<sup>nd</sup> May 2024, with an extra visit carried out on 17<sup>th</sup> Jan 2024.

Marriot Primary was visited on 18th January and will be visited again in May.

#### Major Utility Schemes

Severn Trent Water will be closing the left turn from Counting House Road onto Freemens Common Road from 19th July until 6th September. This is to allow them to install a new water main.

### Appendix 4 - Housing

Tenancy sustainment across the city for the past financial year (23/24) overall was 97.12%. This equates to Leicester City Council tenancies being sustained for at least 365 days. The tenancy sustainment in the Saffron ward was 95%.

The total void properties (LCC stock) is currently 492. This consists of 51 properties being ready to let and awaiting new tenants to be signed up, 10 properties selected for projects. 11 Supported living properties, 27 properties being used as decants by Housing Management, 79 acquisition properties (where LCC have purchased them) and 314 are categorised as all other voids 20 of which are Homeless Pathway voids and 31 properties are priority request. Of the 51 properties that are ready to let 18 properties are for Homeless Pathway cases.

The Zip Building on Rydal Street which was purchased last year is currently being converted in to flats from its previous usage as student accommodation this will create approximately 50 new flats. A percentage of the properties have been assigned to the Help Beyond Housing Team, as trainer flats to enable those tenants who require help and support to sustain a tenancy, the team will have an office in the building to assist with the support to their tenant. It is envisaged that potentially new tenants will possibly be moving into the building around mid-June.

Officers from the Public Health Team are piloting a Community Growing Project on Meadow Gardens this is to enable the residents in the bungalow to commence growing their own produce with the assistance of the Public Health officers and volunteers who work closely with the team. The project is being piloted here first and discussions have been had to potentially look at other areas across the city to engage with other tenants enabling them to also grow their own produce.
