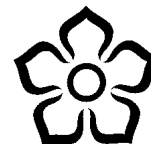

## **Appendix 1 - Highways Update**

### **Highways Maintenance Works**

Last year we completed resurfacing work on Broad Avenue Victoria Road East.

In the coming financial year we will be undertaking carriageway resurfacing work on Elizabeth Street. This work will start on the 1st July and last the approximately 5 days.

We also have some maintenance work on the outbound section of The Portway, between the junction with Claydon St and Uppingham Rd, which we are programming in later this year

We continue to inspect the footways and carriageways around the ward and in the last 6 months have found actionable defects as follows:

- Carriageway - 175 orders
- Footway - 240 orders

Ward funding has also contributed to a new section of footway on Humberstone Road, adjacent to the Merlyn Vaz centre.

### **Road Safety Schemes**

We will shortly be going to public consultation on the proposed speed cushions on St Saviours Road. We hope to be sending this out by the end of May 2024.

### **School Streets**

Our Parking Enforcement team continues to visit schools in the ward, at drop off and pick up times to enforce parking restrictions. Latest visits are:

- Merrydale Junior                      15/01/24 & 22/01/24
- St Barnabas Primary                12/02/24 & 24/04/24
- Shenton Primary                      07/02/24 & 19/04/24
- Spinney Hill Primary                08/02/24 & 08/05/24

We continue to encourage all residents of Leicester to choose sustainable forms of travel and currently have a £300 grant are available for projects, rides, publicity, training or other events which help get more people on their bikes. ## **Appendix 2 – City Warden Update**

We are working in the area and our main spot has been Nottingham Road where the bins have been left on the highway and this has allowed fly-tipping.

It was identified that waste collection day was worse so we made sure that every property has a waste container and then a Section 46 notice was issued, this was to insure that the residents placed their bins back in.

Fly-tipping posters have been placed on the street and we have spoken to the direct business to advise them of the actions we are taking.

We have seen a significant reduction in waste bags being left.

A patch walk was undertaken by managers at the site, where it was discussed with Cllrs and residents.

Barkby Road car park site has been fly tipped. This is being investigated and community protection warnings have been issued to the land owners to action the waste. Further actions to be followed up.

Green Lane Road - problems with businesses with excessive waste notices have been issued and further actions to be taken.

Staythorpe Road, Tilbury Crescent - private owned area with a park. The dog waste bin had been unattended and was overflowing. A waste notice community protection warning was issued to the land owners and waste was removed.

Other works are being followed up.

## **Appendix 3 – Housing Update**

### **Environmental Improvements**

We plan to utilise funding from the Environmental Budget in order to pay for weed spraying on Housing Hard areas (paths, parking bays, courtyards, etc) across the Ward (Oak Street, Lombardy Rise, Charnwood estate & Beatty Avenue).

This is the most effective way of tackling weeds which otherwise will grow back within days during the summer months. Two weed sprays through the summer months should suffice.

### **Beatty Avenue**

We have been successful in bidding for Ward funding to install more way-lighting to the Beatty Avenue.

Initially to the near end of Block A and B, to help tackle anti-social behaviour. With additional funding to repeat the installation at the far end (Uppingham Road end).

### **Kingfisher Avenue**

We are currently consulting residents in the flats 22-52 Kingfisher Avenue over 2 schemes:

1) We plan to remove the shrubs between the flats and Humberstone Road as Pest Control advise that rats use them as cover traversing the estate. However, we don't want to remove the shrubs without providing fencing in order to preserve a barrier between the windows of the flats and the busy Humberstone Road.

2) The introduction of residents parking to the car park area to these flats as it is frequently used by commuters and visitors to the nearby Merlyn Vaz centre.

If we get a positive response to the consultation, then we hope to fund the first scheme this year. And follow up with introducing the residents parking scheme once we have successfully introduced a similar, much larger scheme on the St Peters estate.

It is worth explaining that we can only introduce such a scheme once we have consulted residents and can only apply it to parking bays on Housing owned land, not the highway.
