The report is the second in the regular cycle of reports for the 2007/2008 financial year showing the budget issues that have arisen so far. Cabinet is recommended to approve a number of recommendations as set out in paragraph 3.1 of the report.

## 9. 2007/08 CAPITAL PROGRAMME MONITORING - Appendix D PERIOD 7 Appendix D

Councillor Willmott submits a report that updates Cabinet on the progress of spending on the capital programme for 2007/08 up to the end of October (period 7) and the forecast spend at the end of the year. Cabinet is recommended to approve a revised level of programmed expenditure of £124.3 million, approve £50,000 for an enhanced Alley Gate programme of works, note the level of expenditure to the end of October 2007 of £49.8 million, note the position relating to capital receipts, note that forecast capital programme performance is to spend 96% of the approved programme (excluding any additions or expenditure brought forward) compared to a target of 90%, and note the prudential indicators for 2007/08.

Calculating the estimated surplus, or deficit, for this Account is a statutory requirement because the figure needs to be taken into account during the Council Tax setting process. Cabinet is recommended to approve the estimated collection fund surplus figure of £1.709m and approve the estimated shares payable to the Police Authority, Fire Authority and the City Council as detailed in the report.

## 11. HOUSING CAPITAL PROGRAMME 2007/08 AND Appendix F 2008/11

Councillor Bhatti submits a report that advises Cabinet on the position at period 7 on this years capital programme, revises the forecast for the 2007/08 out-turn and proposes a three year housing capital programme for 2008/11, for Members approval. The approval of Cabinet is sought for setting rents for 2008/09 again based on the Government's "formula rents", and Cabinet is asked to determine the levels of service charges to be applied in 2008/09. Cabinet is recommended to consider the report, and recommend to Council a number of recommendations as set out in paragraph 2.2 the report.

# 13. PROPOSED CHANGES TO THE CONSULTATIVE Appendix H STRUCTURE FOR LOCAL AUTHORITY TENANTS

Councillor Bhatti submits a report that seeks Cabinets approval to make changes to the formal consultative structure, to create a more inclusive involvement mechanism for Local Authority tenants and leaseholders. Cabinet is recommended to agree the proposed changes to enhance the consultative structure for both tenants and leaseholders of Leicester City Council to commence April 2008, to support tenants involvement in the new Community meetings to ensure they can continue to play an active role in local community engagement, and to agree on an interim basis that the tenant representatives to be co-opted onto the new Community meetings will be selected from the existing Tenants Community Associations, until the Tenant & Leaseholder forums are in place as part of the new consultative structure.

# 14. "ADVERTISE AND BID" A NEW LETTING SCHEME Appendix I FOR SOCIAL HOUSING

Councillor Bhatti submits a report that seeks Cabinet agreement, in principle, to implement a new system for allocating Council houses and our nominations to Housing Associations. The new system is based on advertising our vacancies and allowing people on the Housing Register to bid for them. The proposal will require funding from the Housing Revenue Account. Cabinet is recommended to agree the implementation of an advertised based lettings scheme for Leicester subject to budgetary provision, and delegate the details for implementing the scheme to the Corporate Director of Adults and Housing in consultation with the Cabinet Lead for Housing and Community Safety.

## 15. SECOND QUARTER PERFORMANCE REPORT Appendix J 2007/08
