- b) The following applications for grants are submitted for consideration:-

Application 1

Applicant: Gulam Mohammed Lockhat

Proposal: As Salaam Women's Events

Amount: £151

Summary:

This application was considered at the meeting held on 28 March 2011, when a grant of £249 was agreed, (minute 49(b) referred). It also was agreed that, as insufficient funds remained in the budget at that time to support the application in full, consideration should be given at this meeting to whether the balance of the funds requested could be granted. This would be a further £151.

- a) Funding towards the cost of hiring the hall at Christ Church, Nursery Road to hold a monthly meeting and provide refreshments for Asian women living in Thurncourt Ward

In the last few years there has been an increase in the number of Asian families, particularly Muslim families, moving into the area. Approximately 90 such families have been identified in and around the area. Whilst men can meet up and network, there are limited opportunities for Asian women to do this. As most have only just moved to the area and are dispersed, there is a degree of isolation. With increasing unemployment, there is an even greater risk of isolation as incomes for families are reduced and the cost of maintaining contacts becomes more difficult.

To address this, As Salaam has begun a programme of meetings aimed at Asian women in the area. These take place on the first Sunday of each month and refreshments are provided. They enable mutual support networks, such as sharing child minding or school runs, to be established.

To date, a number of individuals have borne the cost of room hire and have provided refreshments. Once fully established, it is intended to make a nominal charge for this activity. The charge will need to be nominal to ensure that those with a limited income are not discouraged from attending.

Approximately 30 – 40 women attended the first couple of events.

- b) Funding towards the cost of hiring Thurnby Lodge Community Centre for an Eid party for women and children in the area

This will be an annual event, after Ramadaan and is a way of getting all the Muslim women and children in the area together for a celebration. The cost of the food, etc will be met entirely from donations, so this request is only for funding for the hire of the Community Centre.

These proposals will help build a community spirit and confidence, especially amongst Asian women, as a precursor to them and As Salaam playing a part in improving an understanding of cultures and helping to promote good citizenship and cohesion.

As Salaam relies on donations but will pay for refreshments and, if possible, pay the balance of the accommodation charge. This will keep the cost to individuals to an absolute minimum. At previous events, participants have been asked to make a donation if they could. This practice will continue if possible so as not to discourage attendance.

Application 2

Applicant: Gulam Mohammed Lockhat

Proposal: Outing for Young People who are part of As Salaam

Amount: £300 for the hire of a single deck coach
(based on quote received from Confidence Coaches)

Summary:

This application was considered at the meeting held on 28 March 2011, (minute 49(a) referred). It was agreed that, as insufficient funds remained in the budget to support the application at that time, it should be deferred to this meeting.

The request is for funding to cover the cost of hiring a coach to a theme park or the seaside in the summer.

In the last few years there has been an increase in the number of Asian families, particularly Muslim families, moving into the area. Approximately 90 such families have been identified in and around the area.

As Salaam provides supplementary education for approximately 62 children, using facilities at Thurnby Lodge Community Centre. The classes operate 5 days per week. The cost of tutors and accommodation is met from donations and fees.

It is proposed to take some of these children, many of whom are from families on low incomes and benefits, to a theme park or on a trip to the seaside. The cost of entrance to the theme park or seaside attraction will be met through a small charge and from donations from the community. Charges will be kept to a minimum, in order not to discourage attendance.

If successful, this will be extended to all other groups at the Community Centre.

Summary:

To assist in the running and management of Thurnby Rangers Football Club, which is based on Willowbrook Park, off Dakyn Road, in Thurncourt Ward.

The Club has provided opportunities for young people to develop their skills as footballers over a period of 25 years, having been established in 1976. However, it has reached a critical stage and relies for its existence on goodwill and financial support that is mainly provided by its original founder, who has contributed a great deal of money and time to maintaining the grounds.

The Club is currently represented in the East Midlands Counties Division.

Application 7

Applicant: Rowlatts Hill Allotment Association

Proposal: Rowlatts Hill Allotment Society Centenary Celebration

Amount: A grant has been requested for the costs associated with clearing and renovating the site, plus publicity and the hire / purchase of gazebos, tables, chairs and toilets.

A total of £600 has been requested, split between Coleman Ward and Thurncourt Ward according to the ratio of plot holders. This Meeting is therefore asked for £200.

Summary:

The Centenary Event will be held at the Blakenhall Road site, which is the largest of the Society's three sites, on Sunday 14 August 2011, from 10.30 am – 3.00 pm.

The event will be attended by plot holders and their friends and families, plus local people, as the Society plans to publicise the event widely. Sir Peter Soulsby, (the City Mayor), has been invited to open it.

The success of the event will be measured by the number of people who attend it and the number of empty plots that are let as a result.

12. ARRANGEMENTS FOR FUTURE MEETINGS

As Thurncourt Ward and Humberstone & Hamilton Ward share various issues of interest, it has been suggested that some joint Community Meetings could be held during the coming municipal year.

It is suggested that the first meeting of the year should be held separately, (ie, one in each Ward), then the second and third could be joint meetings and the final one would be separate.
