# 4. QUALITY STANDARDS IN EMPLOYMENT Appendix A AGENCIES

Councillor Kavia submits a report on the Leicester Employment Agency Association (LEAA) which has been established to raise and maintain quality standards in agency work in the City. The Cabinet is asked to support the LEAA by becoming a signatory member; follow current practice in using employment agencies only when conventional recruitment practices have been assessed as impractical; to accept that, in the case of schools, the Authority is limited in the control it has over the actions of individual governing bodies; to consult with the Local Government Association about their possible contribution to the issue of standards in employment agencies nationally; and to agree that by adopting the standards the authority is making a commitment to quality standards and will require its practices to be adjusted accordingly.

### 5. PLAY AREA STRATEGY 2001/2002 Appendix B

Councillor Holden submits a report on the play area strategy and seeks Cabinet approval for a programme of refurbishment for playgrounds and kickabout areas. Cabinet are also asked to approve capital expenditure of £150,000 in relation to Playground Improvements and Kickabout Areas in accordance with the 2001/02 Capital Programme and to approve the principle of linking the Playground revenue and capital budgets together with the Kickabout Area capital budget in 2001/02 to enable prioritised refurbishment works to be carried out at a total cost of £200,000.

## 6. ENVIRONMENT ACT 1995 PART VI - REVIEW AND Appendix C ASSESSMENT OF AIR QUALITY

Councillor Holden submits a report on progress with the statutory review and assessment of air quality. The Cabinet is asked to approve capital expenditure totalling £74,250 to be funded by Supplementary Credit Approval to upgrade the Council's monitoring and dispersion modelling and carry forward the statutory review and assessment of air quality and to note progress with the current phase of the air quality review and assessment as part of the City Council's ongoing commitment to achieve better air quality.

# 7. CAPITAL RECEIPTS INITIATIVE ALLOCATION OF Appendix D RESOURCES TO TENANT ASSOCIATION INITIATIVES 2001/2002

Councillor Draycott submits a report proposing a programme of work for this financial year under the Capital Receipts Initiative, in line with the Cabinet's decision in January 2001. The report summarises the bids received and Cabinet is recommended to consider the bids and indicate whether it supports the proposed schemes; to indicate whether works such as door entry system, and dropped kerbs/hardstandings should only proceed if owner occupiers meet their full share of the costs involved; to instruct the Central, Humberstone and Beaumont Leys Tier 2 groups to review or reprioritise their bids to stay within the resources allocated; to approve the bids for New Parks and Saffron Tier 2 Groups; and to approve the bid from Braunstone Tier 2 subject to no work being undertaken on streets covered by the demolition proposal, until such time as Cabinet has made a final decision.

## 8. NEIGHBOURHOOD RENEWAL FUND SUGGESTED Appendix E YEAR ONE PROGRAMME

Councillor Draycott submits a report recommending a programme of projects and service improvements to be carried out this financial year using this Neighbourhood Renewal Fund (NRF). The Fund has to be used in partnership with the Local Strategic Partnership for Leicester but in its absence for this year, the Leicester Regeneration Agency was used. The Cabinet are recommended to agree the year one NRF programme, and to ask the Director of Housing working with the Leicester Regeneration Agency (NRF) Task Group to create an evaluation and monitoring framework for the programme that is linked directly to the Council's financial regulations and the Public Sector Agreement and Community Plan targets.

The Town Clerk and Director of Corporate Resources submits a report on the Local Government Ombudsman's investigation of a complaint about the Council's delay in completing the Right to Buy process. The Ombudsman has found maladministration causing injustice and the Cabinet is asked to approve the Ombudsman's recommendations to remedy the situation.

### 10. COUNCIL CONSTITUTION

The Organisations Working Party, at their meeting on 28 June 2001 considered reports on the new Constitution and Cabinet is recommended to note progress (to be reported) in reaching an agreed timescale for the production and adoption of the new Constitution for the Council.

The Organisations Working Party also considered reports on the Periodic Electoral Review and the Independent Panel on Members Allowances - Scope of Review, Terms of Reference and Information Requirements. Both of these reports relate to all Members of the Council and therefore need to be considered at the next meeting of full Council, on 12 July, 2001.

To comply with the requirements of Standing Orders, Cabinet is asked to approve the submission direct to Council of these Reports, as considered at the Organisations Working Party.

### 11. FREEDOM OF THE CITY

The City Council may, if it so wishes, admit to the Freedom of the City persons of distinction and persons who have, in the Council's opinion, rendered eminent services to the City.

Such an honour is initiated by way of a resolution passed by not less than two-thirds of the members voting thereon at a meeting of the Council specially convened for the purpose.

Consideration of the conferment of the Freedom of the City is currently underway. To conclude this deliberation, a special meeting of the Council is proposed to be called for 5.00 p.m. on Thursday, 12 July 2001, with the ordinary meeting of the Council meeting at 5.05 p.m. or immediately upon the rising of the Special Council, whichever is the later.

Although the Lord Mayor may call a Special Meeting of Council, the Cabinet may vary the start time of a Council meeting.

The Cabinet is, therefore, asked to approve the variation in the start time for the Council meeting scheduled to be held on 12 July 2001, and also to approve the submission of a report to the Special Council Meeting

regarding admissions to the Freedom of the City.
