5. REFORM OF THE NHS: PROPOSALS FOR A NEW Appendix A STRATEGIC HEALTH AUTHORITY AND FOR INVOLVING PATIENTS AND THE PUBLIC IN HEALTHCARE -

Councillor Getliffe submits a report responding to a consultation document issued by the Trent NHS Regional Office of the Department of Health on a proposal to establish a new Health Authority for Leicestershire, Northamptonshire and Rutland. The report also outlines a discussion document on involving patients and the public in healthcare, published in September as part of the Government's proposals to replace Community Health Councils. The Cabinet is asked to; endorse the proposal for a Strategic Health Authority (SHA); make strong representations that it be based in Leicester; seek assurances that the interests of Leicester continue to be addressed strategically by the SHA and City Primary Care Trusts; secure the future of the City Health Action Zone; receive a further report on the development of an Overview and Scrutiny Committee for Leicester; continue to monitor developments in the Government's plan to replace Community Health Councils; and to delegate responsibility for the final response to the Director of Social Services, in consultation with the Cabinet Lead Member for Social Services.

6. THE FUTURE INTEGRATION OF MENTAL HEALTH AND SOCIAL CARE FOR PEOPLE OF A WORKING AGE - APPROVAL IN PRINCIPLE

Councillor Getliffe submits a report informing the Cabinet of the completion of phase two of the Mental Health Integration Project and providing an update on progress with the integration work programme. The Cabinet is asked consider a number of recommendations with regard to entering in to a partnership agreement with Leicestershire and Rutland Healthcare Trust, Leicestershire County Council and Rutland County Council for the provision of integrated mental health care.

The Cabinet is asked to; approve extending the scheme to a number of other areas as listed in the report; agree that if there is no demand from applicants aged over 45 years then the age limit will be reduced in ten year bandings; agree that the same criteria contained in the report be adopted for future requests for a delegated decision by the Director of Housing; and to agree that when a review of the scheme is carried out in 12 months further consideration be given to the properties detailed in the report which have not been included in the scheme this time.
