The following budget applications will be considered:-

### Application 1

Applicant: RUSHEY MEAD LIBRARY

Amount: £ 500

Proposal: BHANGRA EXERCISE STEPS

Summary: This application is to continue the current Bhangra Step exercise workshop. This runs at the Rushey Mead recreation centre on alternative Saturdays.

The course, for adults, has been running since February 2011 and more than 40 members are registered with the group whose services are open to men and women within the Rushey Mead community.

The group is working with cluster schools and other community groups to promote community cohesion and leisure/recreation in a safe environment close to their homes.

The dance itself promotes healthy living and other fitness and well-being aspects which relate to wider Council policy.

### Application 2

Applicant: Wyvern Primary School

Amount: £ 1,200

Proposal: Ceremony for achievement of children of English and Maths

Summary: Wyvern primary school would like to make sure that children do as well as they can during the year. They want to motivate the children to make good/ outstanding progress and celebrate their achievements with Award Ceremonies for each year group. Foundation stage will have a graduation ceremony for children moving into keystage 1. Each year group (year 1 – year 6) will have award ceremonies for children that have made 2+ sub level progress in a subject (or a special prize if they achieve it in all three areas of

reading, writing and maths). They would like to use the grant to pay some way towards to awards for the children which the children will be proud of and provide refreshments for parents and the community. Each year group will have an award ceremony. They feel it is important for parents to celebrate their child's achievement.

### Application 3

Applicant: LADIES' SOCIAL GROUP

Amount: £ 150

Proposal: FUNDING OF ROOM RENTAL

Summary: The funding is to be used to stabilise and allow to continue the use of the Ladies' Social Group rental at the Rushey Mead Community Centre.

Around 20 members are involved in the event which takes place on Friday evenings

The meeting helps to increase social interaction within a group which might otherwise continue to be more isolated.
