#### Making meetings accessible to all

<u>Wheelchair access</u> – Public meeting rooms at the Town Hall are accessible to wheelchair users. - ✓ where filming, to (via the Chair of the meeting) ensure that those present are aware that they may be filmed and respect any requests to not be filmed.
