Counillor Coley submits a report that presents a series of proposals and options on the future configuration and delivery of Interpretation and Translation Services (ITS) to enable agreed improvements to be made to service performance. Cabinet is asked to support the proposed 'Strategic Framework' as the basis on which to reconfigure the Council's new Interpretation, Translation and Communication Service and decide on the departmental location of the new service. Cabinet is also asked to agree that the separate but related policy activities be accommodated within the Chief Executive's Office, Policy and Performance team, utilising available resources and agree that the move toward the new service be initiated through the recruitment of a postholder to head up the new service. Cabinet is also asked

to support the disbanding of the Auxillary Interpreters Scheme (AIS), to be replaced by a commissioned service managed by the new service and that the resourcing involved in the agreed changes be contained within existing budgets and current service resources be redirected to ensure the effective establishment of the new service, and to note that the changes outlined to be managed through a Project Management team as set out in para.10 of the report, during the transitional stage.

15. JOB EVALUATION, PAY AND GRADING

Councillor Coley submits a report that seeks Cabinet approval to implement proposals for a new pay and grading structure for Council Employees. Cabinet is asked to approve a new pay and grading structure being developed, the preferred option being the new local job evaluation scheme, and note the joint trade union position and support implementation by joint agreement so far as that is practically possible. Cabinet is asked to agree that the Service Director (HR and Equalities) consults with the Cabinet Link member for RAD on progress and developments.
