1. Purpose of Report

- 1.1. This report provides information for Members about an application made under the Licensing Act 2003, to assist them in determining the outcome of that application.

2. Determination to be made

- 2.1. Having considered the application and representation, Members must consider whether to
- Grant the licence without modification
 - Grant the licence subject to conditions
 - Exclude from the licence any of the licensable activities
 - Refuse to accept the proposed premises supervisor
 - Reject the application

3. Summary

- 3.1 This report outlines an application for a new premises licence for Kritika Pan Centre and summarises the representations received. It also highlights the licensing objectives, the relevant parts of the guidance and regulations, and the pertinent sections of the Licensing Authority's Licensing Policy.

5. Application

- 5.1 An application was received on 11th January 2019 from Mrs Hansha Samji for a new premises licence for 103 Uppingham Road, Leicester. A copy of the application is attached at Appendix A.
- 5.2 The application is as follows:

6. Steps to Promote the Licensing Objectives

- 6.1 The steps the applicant proposes to take to promote the licensing objectives are set out in the operating schedule (see section M of Appendix A).
- 6.2 In arriving at its decision on the application, the Licensing Authority’s primary consideration must be the promotion of the licensing objectives.

7. Representation

- 7.1 A representation was received on 22nd January 2019 from a local resident. The representation relates to the prevention of public nuisance and public safety. The local resident is concerned that there is already an issue of street drinking and anti-social behaviour in the area and granting this licence may increase these issues. A copy of the representation is attached at Appendix B.

8. Conditions

- 8.1 There are no conditions that are consistent with the operating schedule.
