May I take this opportunity to remind you that Section 57 of the Licensing Act 2003 states;

“(2) The holder of the premises licence must secure that the licence or a certified copy of it is kept at the premises in the custody or under the control of

- a) the holder of the licence, or
- b) a person who works at the premises and whom the holder of the licence has nominated in writing...

(3) The holder of the premises licence must secure that

- a) the summary of the licence or a certified copy of that summary, and
- b) a notice specifying the position held at the premises by any person nominated for the purposes of subsection (2),
are displayed prominently at the premises.”

It is an offence to fail to comply with the above requirements.

ANNEXES

Annex 1 - Mandatory conditions

No supply of alcohol may be made under the premises licence -

- a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-

- a) a holographic mark, or
- b) an ultraviolet feature.

A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

Annex 2 - Conditions consistent with the operating schedule

The licence holder will ensure that CCTV is installed following advice from the Leicestershire Constabulary Crime Reduction Officer and maintained in accordance with the Information Commissioner's CCTV Code of Practice.

The licence holder will ensure that an alarm system is installed and maintained.

The licence holder will ensure that customers do not consume alcohol in the vicinity of the premises.

Annex 3 - Conditions attached after a hearing by the Licensing Authority

The licence holder will adopt the Challenge 21 policy.

Adequate, documented training for staff (paid or unpaid) shall be provided before they are allowed to serve alcohol, and this training will be repeated every three months. Documentation shall be provided to Council licensing officers and Police on request.

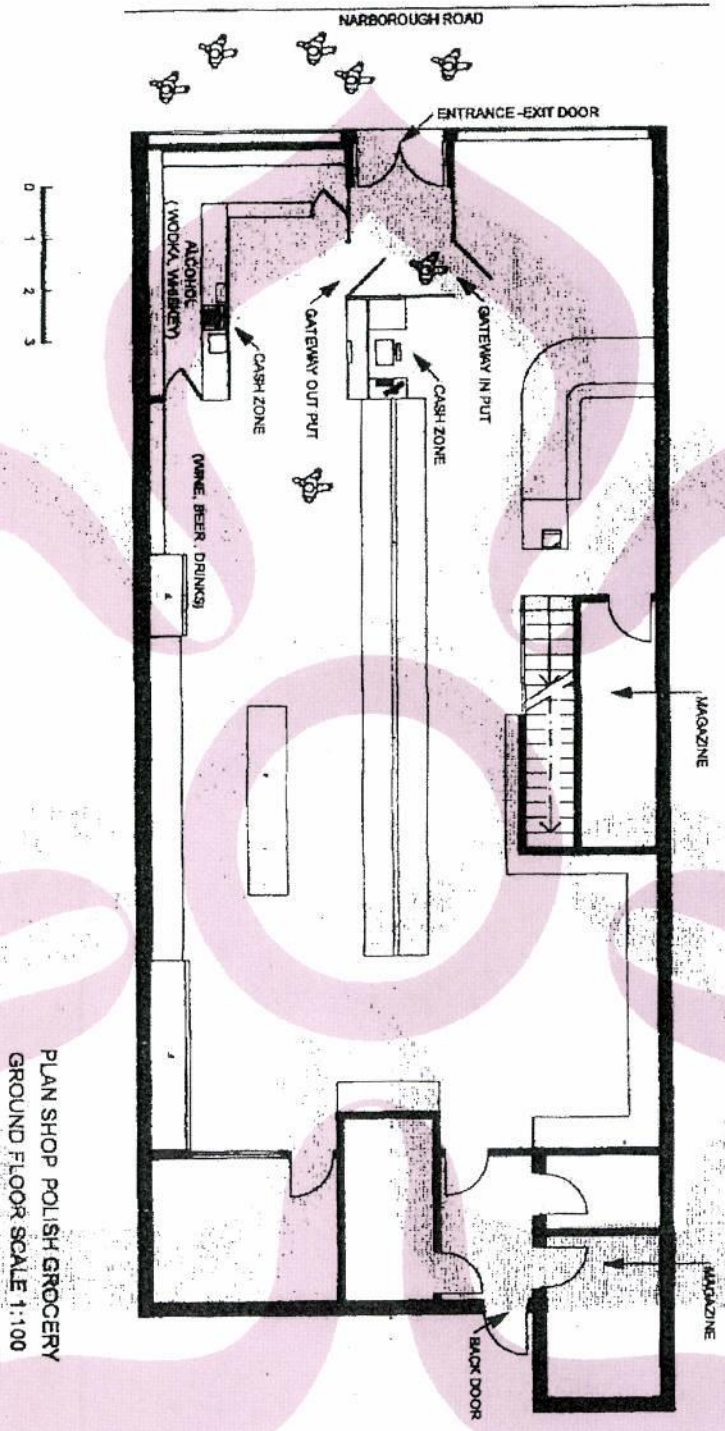
The current DPS shall obtain a recognised qualification for Designated Premises Supervisors. The licence holder must provide the licensing authority with sight of the certificate by 28th January 2011.

The licence holder shall maintain a refusals book, which is to be produced on request to the licensing authority and Police.

No alcohol sales shall be made unless a Personal Licence Holder is present on the premises.
