#### ANNEXES

### Annex 1 - Mandatory conditions

No supply of alcohol may be made under the premises licence -

- a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises-

- a) games or other activities which require or encourage, or are designed to require or encourage, individuals to
  - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supplied alcohol), or
  - ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-

- a) a holographic mark, or
- b) an ultraviolet feature.

The responsible person shall ensure that-

- a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures
  - i) beer or cider: 1/2 pint;
  - ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
  - iii) still wine in a glass: 125 ml;
- b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

### Annex 2 - Conditions consistent with the operating schedule

The licence holder will ensure Digital CCTV will be in operation and recordings will be retained for 31 days and will be available to the Police or other responsible authorities on reasonable request.

The licence holder will ensure no irresponsible sales promotions of alcoholic beverages shall be offered to customers.

The licence holder will ensure no customers carrying open or sealed bottles, shall be admitted to the premises at any time that the premises are open to

the public.

The licence holder will ensure a sign will be located on the premises indicating the standard hours during which the sale of alcohol is permitted.

The licence holder will ensure a sign will be located at exits, requesting that customers leaving the premises do so quietly and with consideration to neighbours. During the performance of regulated entertainment, all windows and doors shall remain closed except for entrance and exit from the premises.

The licence holder will ensure anyone who appears to be under the age of 25 and who is attempting to purchase alcohol must be required to produce proof of age before such a sale is made.

The licence holder will ensure that there is always a member of staff on the premises whilst it is open to the public, who is trained to operate and provide images from the CCTV system to Police officers and responsible authorities.

The licence holder will ensure that Security Industry Authority licence holder(s) will be employed at the premises on each Friday and Saturday from 21.00hrs until the cessation of business on those days and at any other time following advice from Leicestershire Police or the licence holders own risk assessment identifies a requirement for door supervisors.

The licence holder will ensure a risk assessment is completed for events which are outside the scope of normal business and liaise with Leicestershire Police at least 48hours before that event takes place.

The licence holder will maintain an incident book to record all incidents at the premises of crime and disorder, damage to property and personal injury. This book is to be retained at the premises made available to police and responsible authorities on request and retained for a minimum of 12 months.

The licence holder will ensure all incidents of crime which lead to injury, disorder and damage to property are reported to the police.

The licence holder will join City Watch Leicester Against Crime and ensure the designated premises supervisor is an active member.

The licence holder will ensure that all staff, paid or unpaid, will receive training relating to Responsible Alcohol Retailing and the Licensing Act 2003 which will include preventing under-age sales, proxy purchasing, serving to drunks and conflict management. This training will be documented, completed annually and signed for on completion by the trainer and trainee or if completed on-line by the production of a relevant completion certificate.

### Annex 3 - Conditions attached after a hearing by the Licensing Authority

The licence holder shall ensure that no amplified music or speech is audible in Hotel Street before 6pm Monday to Sunday inclusive.

The licence holder shall ensure that all windows and doors are kept closed except for access and egress whilst activities involving amplified music or speech are happening.

The licence holder will ensure that appropriate action shall be taken to ensure that customers smoking outside the premises on either Hotel Street or Greyfriars facades do not cause public nuisance, disturbance or disorder. Other appropriate action may include (i) employing an appropriate number of SIA registered door supervisors where necessary; (ii) monitoring the behaviour and noise from customers whilst outside the premise to ensure public nuisance is not being caused.

The licence holder will ensure that a CCTV system is installed following advice from Leicestershire Constabulary and maintained in accordance with the Information Commissioner's CCTV Code of Practice. The system must cover all areas outside the premises where customers smoke. Copies of recording from the system must be made available for the Licensing Authority and the Leicestershire Constabulary on request.

To prevent the obstruction of the pavement and prevent public nuisance, the licence holder shall restrict the numbers of customers permitted to smoke outside the bar.

The licence holder will ensure that no customers take drinks outside the premises.

The licence holder will ensure that there are no irresponsible drinking promotions.

The licence holder will take reasonable steps to ensure that the immediate area outside the front and rear of the premises are kept clean and tidy.
