**Annex 1 - Mandatory conditions**

No supply of alcohol may be made under the premises licence -

- a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-

- a) a holographic mark, or
- b) an ultraviolet feature.

A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

**Annex 2 - Conditions consistent with the operating schedule**

The licence holder will ensure the Challenge 21 policy is in operation at the premises.

The licence holder shall ensure that customers causing anti-social behaviour are not served.

The licence holder shall ensure that a refusals book is kept on the premises and updated accordingly.

The licence holder will ensure that all staff are trained in relation to age related sales. A training log will be kept on the premises and updated accordingly.

The licence holder will ensure a CCTV system is in operation at the premises. It will have 31 days recording capacity. Recordings will be made available to the Police if required.

The licence holder will ensure that bins outside the premises will only be emptied between 7am and 11pm.

The licence holder will ensure that posters are displayed on the premises indicating underage sale warnings.






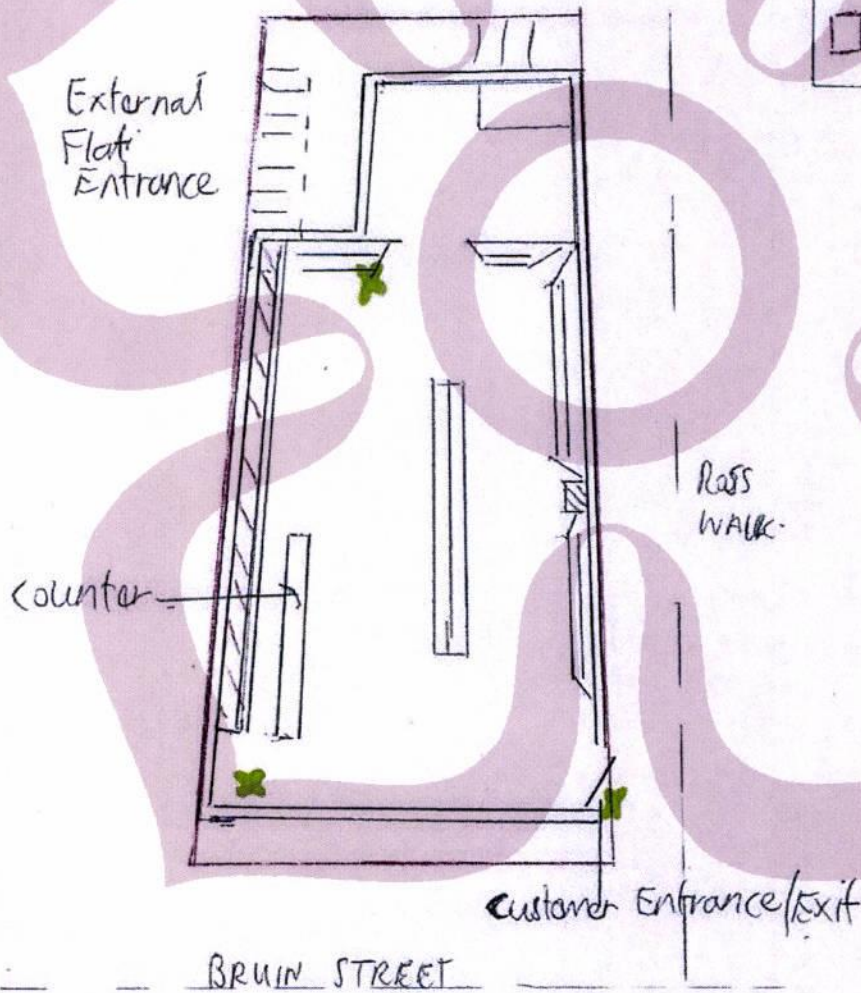
Beer, cider and lager will not be sold that is higher than 5.5% by volume.
