I understand that an application has been made for 66 Queens Road for off-licence sales until midnight.

I would like to object to this application on the basis that it is an hour later than the other off-licences in the vicinity.

I believe this will be contrary to the Licensing objectives of the Prevention of Public Nuisance and the Prevention of Crime and Disorder.

The extra hour of trading will lead to more disruption as people go to and from the off-licence in order to purchase alcohol. The off-licence could also become a flashpoint for conflict as it will be an outlier for later off-licence sales.

If the applicant alters their application to align with other off-licences in the area in particular Bargain Booze and Sainsburys on Queens Road then I would withdraw my objection.

Re new premises licence for 66 Queens Road

Dear licensing

I am writing to object to the licence application for this premises to sell alcohol (off-sales only) from 8am until midnight. My objection relates to public nuisance and public safety.

I don't object to the licence itself, just to the hours. Midnight is too late in this setting and there should be no alcohol sales after 11pm.

If off-licences are selling alcohol after the local bars close, it encourages people leaving the bars to buy more and hang around in the area instead of dispersing home. This then causes problems for nearby residents and a market for takeaway sales that cause further disturbance. I don't know if there is a flat above this shop, but there is certainly one next door. People who hang around with food and drink can congregate in spaces on residential streets off Queens Rd and cause litter (including bodily fluids as there are no toilets open!) and noise there. There have been problems with this in the past. Most bars on Queens Rd are closed by 11pm - or don't allow entry after that time. The other off-licences on Queens Rd close by 11pm. As this is a small premises there is also the possibility if a large group (e.g. students) leaving premises elsewhere is attracted there (because it opens later than others) that they may not be able to handle any issues.

If the applicant agrees to an 11pm closure then I would consider withdrawing my objection.

I would like to **object** to the recent premises licence application for 66 Queens Road to sell alcohol from 8am to midnight every day.

Queens Road is the main shopping and entertainment area serving Clarendon Park, which is a largely residential area that is quiet between 11pm and 7am.

The majority of bars in the area close by 11pm (Queens Road Tap, The Clarendon, Babelas) as do the majority of premises licenced for off-sales (Sainsbury's, Bargain Booze, Hesi Local).

I am concerned that if the Licensing Committee grants this licence to sell alcohol until midnight, then some people leaving the bars will buy more alcohol and linger around the area. This will result in increased disturbance, litter and anti-social behaviour which will particularly impact those living in the flats directly above the retail premises as well as the roads leading off Queens Road.

If the applicant were to alter their application to 11pm instead of midnight, I would be happy to withdraw my objection.
