## 1. Summary

Linked to Manifesto commitment to improve our parks and open spaces with enhanced landscaping and facilities (A City to Enjoy Commitment).

Upgrading / replacement of toilet facilities within Parks and open spaces at Knighton Park, Abbey Park, Braunstone Park, Aylestone Hall, Humberstone Park and Western Park were undertaken in 2006. Watermead Park, Victoria Park, Evington Park, Cossington Street, Belgrave Road were undertaken in 2016.

The proposal is to upgrade and refurbish Knighton Park, Abbey Park, Humberstone Park, Western Park, Knighton Lane East (Aylestone Recreation Ground), Nelson Mandela Park and East Park Road public toilets facilities. To make good all damaged fittings, replace stained toilets, fit grab rails in disabled cubicles, fit new external doors which are all damaged, fit new Wallgate units, increase ventilation and decorate internally.

The scheme will improve all seven facilities.

### **Current situation**

Seven public toilet facilities are now in a poor state and these sites need investment to refresh and improve the existing facilities.

## **Improvement Plan**

Toilets are slowly deteriorating, and no revenue budget is available to make the required improvements. Will lead to a closure of toilets in the near future as becoming unsafe to retain opening.

This is linked into the manifesto - Improve our parks with enhanced landscaping and facilities (A City to Enjoy Commitment)

A capital bid for funding to undertake this work was submitted for the 2020/21 capital programme and was included within the build-up of the People and Neighbourhoods Policy provision.

#### 2. Recommendations

Approval is requested to release £138,000 (as identified in Appendix 1) of the People and Neighbourhoods capital programme policy provision for 2020/21 to undertake the improvement of seven highway and public toilets. A formal published Executive
