#### Annex 1 - Mandatory conditions

No supply of alcohol may be made under the premises licence -

- a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises-

- a) games or other activities which require or encourage, or are designed to require or encourage, individuals to
  - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supplied alcohol), or
  - ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-

- a) a holographic mark, or
  - ) an ultraviolet feature.

The responsible person shall ensure that-

- a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures
  - i) beer or cider: 1/2 pint;
  - ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
  - iii) still wine in a glass: 125 ml;
- b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

Admission of children to the exhibition of any film must be in accordance with the recommendations of the British Board of Film Classification for that film. Where permission has been given by the Licensing Authority to show a film not classified by the British Board of Film Classification, the requirements made by the Licensing Authority for the admission of children to the exhibition of that film must be followed.

All individual(s) at the premises for the purpose of carrying out a security activity must

(a) be authorised to carry out that activity by a licence granted under the Private Security Industry Act 2001; or

Annex 2 - Conditions consistent with the operating schedule

Opening Hours New Year's Eve

· 08:00 - 04:00 hours (New year's Day)

All licensable activities will also cease 30 minutes prior to the terminal hour of 04:00 hours on New Year's Day.

CCTV footage will be made available within 24 hours of a request being made by the relevant authorities.

There will be a member of staff on site when the premises is open to the public who is trained to use the CCTV system.

The incident / refusal book will be updated accordingly and will remain within the premises and be made available upon a request being made by the relevant authorities.

The license holder will adopt the 'Ask Angela' campaign (Or similar) and all staff will receive training on this subject.

No children will be permitted on the premises after 20:00 hours (unless they are part of a pre-arranged private party and accompanied by an appropriate adult).

All staff will receive training on the responsible sale of alcohol, the 4 licensing objectives and 'Challenge 25'. This will be refreshed every 12 months and a training record will be kept on the premises and made available to the relevant authorities upon a request being made.

The licence holder will ensure that there is a written authorisation to sell alcohol for all of their staff. This is to be kept on the premises and updated accordingly

Recorded music shall only be played at background level at first floor level

All external doors and windows must be kept closed, other than for access and egress, in all rooms when events involving live music or speech are taking place.

#### Note to applicant:

You may need to consider providing ventilation or air conditioning in warm weather.

Live/recorded music shall only take place at ground floor level.

Disposal of waste bottles into external receptacles where the noise will be audible to neighbouring properties must not occur between 22:00 hours - 08:00 hours.

The licensee shall take reasonable steps to prevent public nuisance being caused by customers outside whilst smoking.

Prominent, clear notices shall be displayed at all exits requesting customers and staff respect the needs of local residents by keeping noise to a minimum when outside the premises and when leaving the premises.

The licence holder shall ensure that two suitably trained Security Industry Authority licensed door staff shall be employed at the premises on Fridays and Saturdays from 22.00 hours until the close of the premises.

On other occasions suitably trained SIA licensed door staff shall be employed at the appropriate times on a risk assessment basis.

The Designated Premises Supervisor shall ensure that any door supervisors employed at the premises wear and clearly display their SIA registration badge at all times whilst on duty.


