# Appendix 4 – Revised EMAS Significant Effects, Improvement Objectives and Targets (November 2008)

During 2008 a review of the Significant Effects, Improvement Objectives and Targets for EMAS has been undertaken. The review has been informed by:

- Proposed changes to the Council's Environmental Policy (see Appendix 6) driven by the new One Leicester vision and priorities;
- The increasing importance of climate change as a key issue requiring action by the authority, both to reduce greenhouse gas emissions (mitigation) and to adapt to the expected effects of climate change on the City;
- Government introduction of a new set of 198 National Indicators to monitor the performance of local authorities, including several new environmental indicators;
- The need to resolve some previous difficulties with monitoring certain targets.

The tables below present the revised set of Significant Effects, Objectives and Targets for which Cabinet approval is sought. Where amendments or additions are proposed, the reasons for these are summarised in column 4.

The final table at the end of this Appendix presents those Objectives being recommended for removal from EMAS and summarises the reasons.
