<p>The main concern regarding this application would be the level of amplified music that would be heard in the surrounding properties. Preventing the residents from sleeping could lead to sleep deprivation. A high-end cocktail bar playing amplified music opposite to the residential properties is likely to affect their quality of sleep. Especially as the opening hours are Monday to Sunday 15:00-04:00. The location of smoking area, if it is located at the front there would be more use of main door for access and egress. Resulting in further noise breakout.</p> <p>After completing a site visit. It was noted that residential properties are in close proximity, it is likely that a nuisance would be witnessed from the bar.</p> <p>Opening hours suggested on the application are below: Monday to Sunday 15:00 to 04:00</p>

After speaking to the applicant regarding the smoking area, they have confirmed that it to be at the rear of the establishment, this satisfy my concerns.

I believe that the installation of a noise limiting device and agreeing a noise limit with the noise pollution team, and smoking area being at the rear of the property will satisfy my concerns.

The following conditions are recommended to be added to the licence:

- Installation of a noise limiting device and the level to be set and agreed by the Noise and Pollution team
- Receiving of deliveries must only be conducted between 07:00hrs and 22:00hrs.
- Emptying, dispensing or disposing of bottles in outside bins must only be conducted between 07:00hrs and 22:00hrs.
- Keeping all external door shut except for access and egress, in all the rooms involving amplified music or speech are taking place
- Live music and Recorded music to cease by 3:30am Monday -Sunday

I have discussed my concerns with the applicant and an agreement document has been drafted and sent to the applicant.
