Leicester and Leicestershire Waste Development Framework Core Strategy

Report of the Director, Planning & Economic Development

1. PURPOSE OF REPORT

1.1 This report seeks Council approval for the adoption of the Leicester and Leicestershire Joint Waste Development Framework Core Strategy and Development Control Policies Development Plan Document (DPD). This follows the receipt of the Planning Inspector's report finding the above document "sound".

2. SUMMARY

- 2.1 The County and City Councils are preparing a joint Waste Development Framework (WDF). It covers the period up to 2021. It will replace the current Leicestershire, Leicester and Rutland Waste Plan, which ran until 2006.
- 2.2 The two authorities consulted on a submission draft in June last year, before the document was taken through Examination in Public (EiP), where the plan was assessed for "soundness" by a Planning Inspector in accordance with the 2004 Planning and Compulsory Purchase Act. The plan was found to be "sound" subject to minor changes and the Inspector's decision is binding on the Council.
- 2.3 The WDF Core Strategy and Development Control DPD has three parts:
 - (i) **The Core Strategy and Development Control Policy Document** includes a vision, objectives and policies for the spatial aspects of waste reduction, re-use and treatment and development control policies for new waste facilities
 - (ii) **Spatial Diagram**, showing existing waste sites in Leicester and Leicestershire, and broad locations for search for future key waste facilities.
 - (iii) **The Sustainability Appraisal**, incorporating the Strategic Environmental Assessment.

These documents and the Inspector's report will be available in the Members' Library & can be downloaded from the internet from <u>http://www.leicester.gov.uk/WDF</u>.

3. **RECOMMENDATIONS**

- 3.1 Cabinet is recommended to note the report
- 3.2 Council is recommended to approve this report and agree that the Core Strategy and Development Control Policies DPD, as amended in accordance with amendments listed

in Appendix 1 of this report, be formally adopted by Leicester City Council to cover the period to 2021. The plan will be subject to review within this period as required.

4. REPORT

Background

4.1 The County and City Council are working together to prepare a Waste Development Framework (WDF). It covers the period up to 2021 and replaces the Leicestershire, Leicester and Rutland Waste Local Plan 1995-2006 in setting out policies and proposals for the development and use of land for waste management. 4 millions tones of waste are produced in the City and County annually, and this is likely to increase by a minimum of 14% by 2016, requiring additional waste facilities. Leicester has been forward thinking and, by building the Bursom Recycling Centre and its associated anaerobic digestion facility at Wanlip, the City will have enough capacity for processing of municipal waste until the end of the plan period. However there is a shortage of facilities for processing commercial & industrial and construction & demolition waste.

Core Strategy

4.2 The main objective of the Core Strategy is to enable sufficient provision of waste management facilities to help meet the increased need until 2021. New facilities should increase re-use, recycling, composting and energy recovery, while limiting the amount of waste going to final disposal in facilities such as landfill. The Core Strategy contains a detailed vision for the future of waste processing in Leicestershire and Leicester, which highlights the existing situation of waste management and explains how the provision of new facilities will be provided to meet tough government and EU targets.

Spatial Diagram

4.3 The spatial diagram shows existing waste sites and the broad locations of search for strategic waste sites. The area of search covers the whole of Leicester although Leicester's one strategic waste site, the Bursom Recycling Centre, has ample capacity to meet the future municipal waste demands. Strategic Waste sites could include but are not limited to Mechanical-biological treatment, Anaerobic Digestion, Mechanical Heat Treatment and potentially Energy from Waste.

Examination in Public (EiP)

4.4 The WDF document was submitted to the Secretary of State in June 2008 and the EiP took place between 23rd & 27th of February 2009 at County Hall. The Inspector's report was received on 1st May 2009 and, subject to minor changes, the plan was found sound. These changes will have no significant effect for Leicester. A list of the Inspector's proposed changes to the plan can be seen at Appendix1. The Inspector's report is binding on both councils.

Next Stages

4.5 Following approval by both Councils, a date will be chosen for formal adoption of the Plan. This will be followed by a 6 week legal challenge period, which gives aggrieved parties the opportunity to make a challenge to the High Court. They cannot challenge the soundness of the plan, only that various Acts and EU directives have not been followed correctly by the Secretary of State. However the Plan will be adopted, unless the High Court rules otherwise.

5. FINANCIAL, LEGAL AND OTHER IMPLICATIONS

5.1. Financial Implications

5.1.1 Costs from the Local Development Framework process, including the examination in public will be met from existing budgets.
