## 46. PETITION - ADVANCE DIRECTION SIGN, LUTTERWORTH ROAD

The Director of Environment, Development and Commercial Services submitted a report in response to a petition sent to the Traffic Group by a member of the public, asking for an immediate halt to the erection of a new traffic sign at the junction of Monsell Drive and the A426 Lutterworth

#### Road.

The Committee were informed that there had been a large number of representations from local residents, opposing the erection of the sign at the junction of Monsell Drive and Lutterworth Road and suggesting that the sign be relocated to a site nearer the Middleton Street junction.

The Committee were informed that the Government had issued regulations regarding the siting of direction and information signs, the proposed site at Monsell Drive was the optimum in accordance with these regulations. To locate the sign further away from the Glenhills Way/Soar Valley Road junction would contravene the Government guidelines, in fact the suggested site put forward by the objectors, Plantation Avenue, would be some three times further away from the junction than that recommend by the Government.

The Committee sympathised with the objections raised by residents of Monsell Drive and suggested that officers undertake a further review of the siting of the advance direction signing on Lutterworth Road to include full consultation with Ward Councillors and local residents. The review report to be referred to Cabinet with the full review and consultation findings:

#### **RESOLVED:**

- i) that the comments of the Scrutiny Committee be conveyed to the Director of Environment, Development and Commercial Services to ensure that a further review of the site of the advance direction sign is carried out.
- ii) that the full review and consultation findings be referred to Cabinet with a request that they consider the siting of the advance direction sign.
