74. REPORT ON RESPONSES TO THE CONSULTATION DOCUMENT 'MEETING INDIVIDUAL NEEDS - LEICESTER CITY LEA'S INCLUSION STRATEGY'

The Director of Education submitted a report which gave details of the responses to the consultation and summarised the main points. It was stated that the issues raised included:

- parents' concerns about a possible lack of support available in mainstream schools and the ability of mainstream schools to cope;
- schools' concerns that mainstream schools may not recognise children's complex needs or have insufficient expertise and training;
- some agencies' concerns that parents and staff should actively be involved and that needs should be met appropriately. Other agencies were more supportive of the concept of inclusion.

The Department had established a Project Board to oversee future developments and to scrutinise proposals before recommending them for Member approval.

It was stated that the Teachers Associations had submitted a detailed response which had approved of Inclusion as a correct policy. With appropriate levels of funding, pilot projects could be set up. Professional Associations also felt strongly that the membership of the Project Board should be widened to be more representative of Primary schools and of Special Educational Needs Coordinators (SENCOs). Views were expressed that because of misrepresentation in the local media, the consultation had proved ineffective and it was now important for the Council to develop detailed proposals upon which parents could again be consulted.

RESOLVED:

- 1 That Cabinet be requested to consider recommending the widening of the membership of the Project Board and to develop detailed proposals for taking Inclusion forward as a matter of priority.
- 2 That further progress reports be brought back to this Scrutiny Committee.
