REVITALISING NEIGHBOURHOODS GUIDANCE AND BOUNDARIES FOR NEIGHBOURHOOD FORUMS

REPORT OF THE ASSISTANT CHIEF EXECUTIVE

1. PURPOSE OF PAPER

On 21st March 2002 the Council agreed to develop about 10 forums, as part of a number of decisions to take forward the Revitalising Neighbourhoods project.

During June and July 2002 the public, community and voluntary groups, key partners, Council employees and Council Trades Unions were consulted about how the forums should be developed and run.

Guidance which is informed by this consultation has now been drafted. The purpose of this paper is to seek approval for the guidance and approval to for the boundaries for the forums.

2. **RECOMMENDATIONS**

It is RECOMMENDED that Members:

- a. note the findings of the consultation on neighbourhood forums;
- b. approve the 'Guidance for Neighbourhood Forums in Leicester'
- c. approve the boundaries for 10 new forums shown at Annex B of the guidance, subject to final confirmation of new ward boundaries
- d. agree to amend Part 3 of the Council's constitution to include the guidelines on objectives for neighbourhood forums, in line with Article 10.01 of the Council's constitution.

3. FINANCIAL IMPLICATIONS

The financial implications associated with the setting up of area forums, and the wider proposals from the Revitalising Neighbourhoods project, were set out in 'Revitalising Neighbourhoods' report to Cabinet on the 25th February 2002 and the implementation report to Council on the 21st March 2002.

Guidance on the management of specific budgets in connection with neighbourhood forums have been prepared by the Chief Accountant and are set out in the guidelines themselves.

4. LEGAL IMPLICATIONS

Article 10.01 of the Council's Constitution allows for the setting up of consultative forums. This article says that the terms of reference of such forums will have to be included in Part 3 of the Council's Constitution. Terms of reference are equivalent to the 'Objectives' section of the forums' constitutions. However, since the Council is developing guidance on the constitutions of forums and their objectives, rather than having a single set of words prescribed to all forums, it is recommended here that the guidance on objectives is included in Part 3 of the Council's Constitution instead of the ten different forums constitutions. The constitutions of all the forums will be publicly available.

The Service Director, Legal Services has commented on the guidelines and they have been revised in the light of his comments.

During June and July 2002 consultation was carried out with the public, community and voluntary groups, key partners, Council employees and Council Trades Unions about how the forums should be developed and run.

The Guidelines are based on the issues raised and the views expressed by a wide range of people, both in this and previous consultation exercises, an on a wide range of informal discussions and meetings.

To focus the consultation exercise, a consultation paper called 'Setting Up Neighbourhood Forums' was developed, along with a plain language leaflet called 'Let's Get Together'. Before the consultation exercise began, the consultation paper was first discussed and developed within the Council, as shown on the attached timetable.

Details of how the consultation was carried out, and the findings of the consultation are set out in the attached report.
