44. DECLARATIONS OF INTEREST

59. DRAFT REVENUE STRATEGY FOR ENVIRONMENT, REGENERATION AND DEVELOPMENT

The Corporate Director of Environment, Regeneration and Development and the Chief Finance Officer submitted a report that sought the views of the Scrutiny Committee on the draft revenue strategy for the Environment, Regeneration and Development Department. The overall strategy was outlined together with the circumstances leading to the current budget position. The

Appendix to the report dealt with the initial steps and outcomes so far that formed the basis of the department strategy for 2003/04. A list of discretionary services with low or medium strategic priority was provided, together with the Corporate Director's options for savings against these areas. A summary showing both the savings targets and current growth pressures, together with the full Environment, Regeneration and Development Department Revenue position was also appended to the report.

The Scrutiny Committee expressed concerns at the proposals to re-prioritise bus services that were currently in receipt of subsidy, to effect a budget saving. Officers reported that a list of bus service proposals was under preparation and would be circulated to all Members of the Council for comment. A new policy of allocating bus service subsidies was also under preparation and would be reported to the Scrutiny Committee when ready.

RESOLVED:

- i) that the officers report back to the next meeting of the Scrutiny Committee outlining detailed proposals relating to the prioritisation of subsidised bus services.
- that, with the exception of subsidised bus services, the Scrutiny Committee had no further comments to make on the Draft Revenue Strategy report.
