56. THE LOCAL AUTHORITY YOUTH SERVICE PLAN 2003-04

The Corporate Director of Education and Lifelong Learning submitted a report detailing the context for the production of the Local Authority's Youth Service Plan for 2003-04. The final submission of the Plan would be presented to the Government Office of the East Midlands in March 2003. The Plan set out how the Youth Service aimed to assist in meeting the strategic objectives of raising educational standards, achieving community cohesion, raising social inclusion and revitalising neighbourhoods. The various groups that had been consulted regarding the Plan were outlined and detail was given about how services would be delivered. It was also stated that it was planned to review both full and part-time youth work contracts as part of Phase 2 of the Review. This is to ensure the development and effectiveness of the service.

Members welcomed the report. Some concern was raised about the levels of consultation with various groups on the matter. In particular, it was suggested that greater consultation was needed with Disabled groups and Lesbian, Gay, Bi-sexual and Transsexual (LGBT) groups. It was emphasised that the needs of these groups were not currently being met and highlighted the good practice of other authorities in this area. In order to increase the consultation with youth, it was suggested that a young person be co-opted onto the Scrutiny Committee. It was also felt that, in order for fuller engagement with young people, there needed to be greater investment in Detached Youth Work. In addition, Members raised the issue of the face to face element of youth workers time in the authority. It was stated that the aim would be to ensure that this would not fall below 50% of their time.

Councillor Farmer, seconded by Councillor Vincent moved the following suggested resolution:

- that the Committee feels that more consideration should be given to the needs of Lesbian, Gay, Bi-sexual and Transsexual (LGBT) groups and Disabled groups;
- (2) that the Committee feels that there should be greater investment in detached youth work; and
- (3) that the Committee feels that there should be a greater emphasis on consultation with young people.

The matter was put to a vote and was carried.

Councillor Soulsby, seconded by Councillor Coles moved the following

suggested preamble to the above resolution:
