CAPITAL PROGRAMME 2003/04 PLAYGROUND AND KICKABOUT AREAS

Report of the Service Director, Cultural Services

1 Purpose of Report

1.1 This report requests approval for the Capital Funding already allocated for the development and refurbishment of kickabout areas to be redirected and spent on 4 projects which will make a greater impact on the Council's strategic objective to improve the environment to make local neighbourhoods and the City Centre places for people to be proud of.

2 Summary

2.1 There is currently £45,000 allocated in the capital programme to carry out refurbishment of kickabout areas managed by Cultural Services in the City. Whilst this work is important, and officers propose to carry out condition surveys in 2004. meanwhile we would like to use the balance of the funding to undertake a range of projects detailed in the supporting information. These will have a more immediate impact on local neighbourhoods in accordance with the Council's strategic objectives.

3 Recommendations

3.1 That Cabinet approve spending of the £45,000 previously allocated for kickabout refurbishment on the areas of work identified in this report.

4 Financial Implications

- 4.1 The 2003/2004 Capital programme allocated £100k for children's playgrounds and kickabout areas. Cabinet on 1st September agreed that £55k of this should be used for the refurbishment of 6 identified play areas. In addition £45k was carried forward from the 2002/2003 capital programme for the development of a kickabout area in New Parks.
- 4.2 Cabinet agreed that a further report should be brought identifying the findings of the kickabout area assessment and making recommendations for refurbishment and development works to be funded from the remaining £45k 2003/2004 capital programme allocation.

SUPPORTING INFORMATION

1. Background

- 1.1 This report seeks approval to redirect capital expenditure of £45,000 in 2003/2004, for refurbishment of kickabout areas within the City to a range of other projects.
- 1.2 A new kickabout area is being developed at Allexton Gardens in New Parks for completion by 31st March 2004. A citywide strategy for play and youth, which will involve kickabout areas, will be prepared in 2004/2005. This will consider the rationalisation of all play and youth facilities across the City. In the absence of this strategy, part of the funding allocated within this financial year will be used to carry out condition surveys and associated health and safety works to existing kickabout areas. Officers advise that detailed surveys need to be commissioned to consider the condition of the 19 kickabout areas to identify any imminent health and safety/structural problems, rather than develop new areas at this time.
- 1.3 There are, however, a number of other projects that, due to constraints in the parks and green spaces budgets, cannot be financed. The projects are high priority and contribute significantly to the City Council's strategic objective "to improve the environment to make local neighbourhoods and the City Centre places for people to be proud of".
- 1.4 The table below identifies the areas of work that members are asked to approve.

2. Financial Implications

- 2.1 The 2003/2004 Capital programme allocated £100k for children's playgrounds and kickabout areas. Cabinet on 1st September agreed that £55k of this should be used for the refurbishment of 6 identified play areas. In addition £45k was carried forward from the 2002/2003 capital programme for the development of a kickabout area in New Parks.
- 2.2 Cabinet agreed that a further report should be brought identifying the findings of the kickabout area assessment and making recommendations for refurbishment and development works to be funded from the remaining £45k 2003/2004 capital programme allocation.
