# Report of the Corporate Director of Resources, Access and Diversity

#### 1. Purpose of Report

The main purpose of this report is to advise Cabinet of works recommended to be funded from the Disability Discrimination Act Initiatives budget for 2004/2005, including the Access to Work portion of the budget and to seek approvals to enable the programme to proceed. The report also outlines those duties that will come into force on 1<sup>st</sup> October 2004 where a physical feature makes it impossible or difficult for a disabled person to make use of a service.

# 2. Summary

A sum of £300,000 has been approved for the Disability Discrimination Act Initiatives budget 2004/2005.

Commitments from earlier years need to be met from the allocation of £300,000 following the transfer of £83,000 to the CMF Recovery Plan. As a result the sum available for new starts is £217,000. Proposals for spending the budget are attached at Appendix 1.

There is a need for a response mechanism to allow for works to be undertaken during the year should a complaint be received and a sum of £11,757 has been reserved for this purpose at Appendix 1. It will be a requirement of the fund that if works have not been committed by 31 December 2004, then the fund remaining will be allocated to other works which can be completed by 31 March 2005.

Also shown at Appendix 1 is the sum of £20,000 which is allocated from this Budget each year for Access to Work.

#### 3. Recommendations

Cabinet is recommended to:

- 3.1 Approve the works in Appendix 1 including the allocation of £20,000 to Access to Work and a sum of £11,757 in the event that urgent works are required in the light of complaints received.
- 3.2 Authorise the Corporate Director of Resources, Access and Diversity to order the works.
- 3.3 Authorise the Corporate Director of Resources, Access and Diversity to seek all necessary consents.
- 3.4 Authorise the Corporate Director of Resources, Access and Diversity's Head of Legal Services to sign any contracts (if necessary) to allow the work to proceed.
- 3.5 Delegate authority to the Corporate Director of Resources, Access and Diversity to approve further works during the year as necessary or reassess or amend the programme, in consultation with the Lead Member for Property and Regeneration.
- 3.6 Note at Appendix 3 the duties that the Council will have under Part 3 of the Disability Discrimination Act 1995.

#### 4. Financial and Legal Implications

The sum of £300,000 (including fees) is included in the 2004/2005 Capital Programme for this project and this appears on page 19 of the Capital Programme 2004/2005 Book.

In 2003/2004 £83,000 was transferred to the CMF recovery plan which reduces the sum available for new starts to £217,000.

The Head of Legal Services has been consulted on the report and considers there to be no specific legal implications other than to ensure that the consultation complies with the provisions of the Disability Discrimination Act 1995.

## SUPPORTING INFORMATION

#### 1. Report

- 1.1 The Disability Discrimination Act Officer in the Property Review team of Resources, Access and Diversity has produced at Appendix 1 a proposed list of work which is recommended should be undertaken to priority buildings using this year's allocated budget. This list has evolved from consultation undertaken by the Housing Department with disabled customers.
- The Disability Discrimination Act Officer has applied the "List of priorities for 1.2 improving city council buildings for Disabled Persons" to the survey of properties previously undertaken over the years. By applying "Paving the Way" criteria to the survey information and taking into account the results of previous public consultation exercises (previously reported to FREOPS on 19 September 2002), he has established the priority list (Appendix 2) which excludes the buildings recommended for improvement within this report. Further consultation is planned during 2004-2005 to assist prioritisation of future needs, including Priority 1 works not able to be undertaken from this years budget. The priority list is being constantly reviewed to ensure that any buildings that are or may be surplus to use are not being included when works are to be carried out. There is one priority 1 building remaining on the list, (Leicester Leys Leisure Centre) which, due to recent users requests will require re-auditing. This building is likely to be included in the 2005/2006 programme due to budget limitations for the current year.
- 1.3 The proposed list is made up of works and fees to buildings together with a sum of £11,757 for urgent works identified during the year and £20,000 for Access to Work.
- 1.4 It is recommended that the works to buildings should be approved for commencement as soon as possible. The fees on the cost of the works have been set at a maximum of 15 per cent.
- 1.5 It is recommended that the sum of £20,000 is allocated for Access to Work grants, this element being controlled by the Corporate Director of Resources, Access and Diversity's Human Resources Unit. The Access to Work element is to fund the cost of equipment and accessories necessary to assist disabled

- members of staff in their work and is largely grant-aided by the Department of Employment on a sliding scale of up to 100 per cent of the cost.
- 1.6 In previous years there has been a need to address urgent works at buildings as result of complaints received. In order to allow such works to be undertaken as quickly as possible, a sum of £11,757 has been allocated.
- 1.7 Appendix 3 shows those duties that have/will be coming into force arising from Part 3 of the Disability Discrimination Act 1995. Those coming into force from 1<sup>st</sup> October 2004 may have significant cost implications and consequently the budget provision will be reviewed for future financial years.

#### 2. Recommendations

- 2.1 It is recommended that Cabinet:
  - Approve the work in Appendix 1 including the allocation of £20,000 to Access to Work and a sum of £11,757 for urgent work requests in the light of complaints received.
  - Authorise the Corporate Director of Resources, Access and Diversity to order the works.
  - Authorise the Corporate Director of Resources, Access and Diversity to seek all necessary consents.
  - Authorise the Corporate Director of Resources, Access and Diversity's Head of Legal Services to sign any contracts (if necessary) to allow the work to proceed.
  - Delegate authority to the Corporate Director of Resources, Access and Diversity to approve further works during the year as necessary or reassess or amend the programme, in consultation with the Lead Member for Property and Regeneration.
  - Note at Appendix 3 the duties that the Council will have under Part 3 of the Disability Discrimination Act 1995.

The Heads of Property Group, at its meetings in April 2004 approved these works as appropriate in the light of the suitability and sufficiency surveys undertaken as part of the asset management planning process.

#### Appendix 3

# Disability Discrimination Act 1995 Part Three, rights of access to goods, facilities, services and premises.

As a service provider and as a landlord the Council has duties under Part Three of the Act. These duties have / will come into force in three stages:-

#### Since 2 December 1996:-

It has been unlawful for the Council as a service provider to treat a disabled person less favourably than they treat, or are prepared to treat, someone who does not have that disability by:-

- By refusing to provide, or deliberately not providing, a service;
- By providing a lower standard of service;
- By providing a service under worse terms.

#### Since 1 October 1999:-

The Council as a service provider has had a duty to take all 'reasonable' steps to:-

- Amend any policies, practices or procedures which may make it impossible or unreasonably difficult for a disabled person to make use of a service;
- Provide auxiliary aids or services to enable or assist a disabled person to make use of a service:
- Provide a service by an alternative accessible method where a physical feature makes it impossible or unreasonably difficult for a disabled person to make use of a service.

#### From 1 October 2004:-

Where a physical feature makes it impossible or unreasonably difficult for a disabled person to make use of a service, the Council must either:-

- Remove the feature;
- Alter the feature so it no longer has the disabling effect;
- Avoid the feature, or
- Provide the service by an alternative accessible method in line with 1999 duties.

#### **Duties as a Landlord**

Where the Council is a Landlord and lets the premises to other service providers, it is the service provider's responsibility to make the 'reasonable' adjustments to the building where necessary to improve access for a disabled person. However, the Council has a duty not to withhold consent to allow the works to proceed unless such action is justified.

The duties set out above are anticipatory duties and the Council should not wait for a disabled person to find they cannot access a Council service. All 'reasonable' steps must be taken to identify and address any physical features which may make it impossible or unreasonably difficult for a disabled person to make use of a service.

#### Compensation

Where disabled people consider themselves to have been discriminated against for a reason which relates to their disability, they can take the Council to either the Small Claims or County Court. If successful, the disabled person could claim:-

- Compensation for discrimination by the service provider;
- · Compensation for injury to feelings;
- A guarantee that the issue in question will be solved and similar action will not be repeated.
