#### **Report of the Corporate Director of Housing**

#### 1. <u>PURPOSE OF REPORT</u>

1.1 This report advises Cabinet of the outcome of consultation with Members on the Housing, Strategic Planning and Regeneration, REOPPS and the Leisure and Environment Scrutiny Committees, and seeks approval on the way forward for Energy Services in the City.

#### 2. <u>SUMMARY AND RECOMMENDATIONS</u>

- 2.1 Following a decision by Council in February 2004 the Energy function in Regeneration and Culture was transferred to Housing from June 2004 following a Protocol Review. However, further organisational change was suspended until such time as officers had a clear picture of what Members wanted from their Energy Services in the Council. As part of this process a position statement report 'Future Profile of the City Council's Energy Services' was presented to the Housing, Strategic Planning and Regeneration, REOPPS and the Leisure and Environment Scrutiny Committees and their views sought.
- 2.2 The outcome of this consultation is contained within the body of the Supporting Information to this report.
- 2.3 Cabinet is asked to consider the report and to advise on the following:-
  - (i) That an organizational review should be undertaken to bring all staff associated with Energy Services together and a new post(s) created with specific responsibility for identifying opportunities available at a Regional, National and International level;
  - Whether it wishes to continue to operate a dedicated shop front for Energy Services in the Council and whether the current location is appropriate or whether alternative sites should be explored;

- (iii) That a comprehensive marketing strategy be developed to highlight the work of the Energy Service in the City and beyond, and the opportunities available through the shop for citizens to access high quality advice and energy efficient goods at competitive prices. This could include a re-launch of the shop facility either in its current or new location, new product lines, revised opening times and more internet access;
- (iv) Given the requirements of the Energy Efficiency Directive, which comes into force in January 2006, where all public buildings have to be certificated for their use of energy and water, that officers consider how best the Energy agenda can be moved forward so that the Council complies and opportunities to reduce costs and reinvest savings can be maximized;
- (v) Whether the Council should seek to continue to hold the position of Vice President of Energie-Cities (the Council has held this position since 1997);
- (vi) That the Corporate Director Board sets up a mechanism to review the role of the Sustainable City Officers' Group (SCOG) and other environmental management groups, e.g. EMAS, in consultation with the Leader of the Council, to make sure they meet the strategic needs of the Council;
- (vii) That staff should continue to explore the options available for creating an ESCO which limits the liability on the Council; and
- (viii) That the Council continues to support the Leicester Energy Agency, who should act as an advisory body to the Council, but any proposals from the Agency that effect the Council must be agreed by Cabinet, or the Corporate Director of Housing in consultation with the Cabinet Member for Housing, before being implemented. The Corporate Director of Housing be given authority to negotiate an agreement between the Council, De Montfort University and the Leicester Energy Agency to formalise this arrangement and the Head of Legal Services be delegated authority to sign the agreement on behalf of the Council.

#### 3. FINANCIAL IMPLICATIONS (Danny McGrath)

- 3.1 The report seeks advice from Members on how they want to move the Energy agenda forward. Depending on the decisions taken there could be financial implication attached, e.g. moving the Energy Shop to a new location, development of an ESCO, etc. In these circumstances, before any final decision is taken, unless they are operational issues, a further report will be brought to Cabinet for approval.
- 3.2 Other recommendations e.g. developing a comprehensive Marketing Strategy, carrying out an organisational review etc., will be contained within the Department's approved budgets.

#### 4. LEGAL COMMENTS (Peter Nicholls)

4.1 The Energy Agency is, in effect, a consultative partnership board, which was established to comply with requirements of a partnership agreement made between the City Council and De Montfort University in 1996. The agreement has expired, but the Energy Agency has continued. The Agency is not a separate decision making body. The original agreement made it absolutely clear that it is no way intended to create any legal identity separate to the legal identity of the City Council and De Montfort University. The Agency cannot enter in to contracts in its own name, nor can it employ staff etc.

# SUPPORTING INFORMATION

#### 1. BACKGROUND

- 1.1 In February 2004 Council agreed to transfer the Energy Team in Regeneration and Culture to Housing or RAD and save £80k, as part of the budget setting process for 2004/5. In June 2004 Cabinet endorsed Phase one of the review, which transferred the R & C Energy service to Housing and delivered the budget savings required.
- 1.2 Before embarking on Phase 2, officers prepared a report for discussion with Members to identify what sort of service they wanted and which direction the service should follow in the future. This report was presented at the Strategic Planning and Regeneration, REOPPS, Leisure and Environment and Housing Scrutiny Committee's. In total, 29 Councillor's were given the opportunity to express a view on the report as part of the consultation process. The resolutions passed by the various Scrutiny Committees is attached at Appendix 1 for Cabinet's information

#### 2. WAY FORWARD

- 2.1 The consultation exercise proved very useful, as, in a lot of areas, there was cross party support on the way forward.
- 2.2 The areas highlighted and recommendations on the way forward are shown in the table below:

### **COMMENTS FROM THE SCRUTINY COMMITTEE'S**

#### Strategic Planning and Regeneration Scrutiny Committee 10/11/04 – Minute 51

Councillor Kitterick proposed the following resolution, it was not seconded: -

- "i) that the work of the Leicester Energy Agency be commended and that Cabinet be urged to continue support to the Agency.
- ii) that the Corporate Director of Housing be asked to look at savings regarding the Energy Centre.
- iii) that Resources and Equal Opportunities Scrutiny Committee be asked to look into the financing issues of the Leicester Energy Agency."

Councillor Farmer proposed the following resolution, seconded by Councillor O'Brien

- i) Reconfigure the work of the Leicester Energy Agency.
- ii) Review the International work and the non-Leicester work undertaken by the Agency.
- iii) Review the shop front at the Energy Advice Centre.
- iv) Re-invest in the following: -

Citywide advice service provided through City Council services and the 'green doctor scheme.'

Invest in the Home Insulation Scheme.

Establish a dedicated external funding team

Leicester Energy Agency be re-established as a legally formed body."

Officers reported that a Beacon Status Bid had been submitted relating to Energy Efficiency and, should the resolution, as proposed and seconded be agreed, it was likely that the City Council would have to withdraw the bid on the grounds that the terms of the original bid could no longer be met.

The Committee expressed a view that they did not have sufficient information available to enable viable comments on the future direction of energy services to be formulated.

- 1) that the report be referred to Cabinet together with the comments of the Scrutiny Committee.
- 2) that the comments of the Scrutiny Committee be forwarded to the Resources and Equal Opportunities Scrutiny Committee.
- 3) that the officers look into the inclusion of 'Energy Implications' on all future Cabinet and Scrutiny reports.
