Report of the Director of Environmental Services

1. Purpose of Report

1.1. This report provides information for Members about an application made under the Licensing Act 2003, to assist them in determining the outcome of that application.


2. Determination to be made

- 2.1. Having considered the application and representation, Members must consider whether to
 - Reject the review application
 - Modify the conditions of the licence
 - Exclude a licensable activity from the scope of the licence
 - Remove the designated premises supervisor
 - Suspend the licence for a period not exceeding three months
 - Revoke the licence
- 2.2 Where Members take the decision to reject the review application, they are permitted to issue an informal warning to the licence holder and / or recommend improvement within a particular period of time.

3. Summary

3.1 This report outlines an application for a review of an existing premises licence for City Rooms, Hotel Street, Leicester and summarises the representation received. It also highlights the licensing objectives, the relevant parts of the guidance and regulations, and the pertinent sections of the Licensing Authority's Licensing Policy.

- 5.2. The activities and hours permitted by the existing licence are as follows:

Opening hours	Mon-Sun Midnight to midnight

6. Review application

- 6.1 An application was received on 15 August 2014 from Neil Cooper, Noise Team, Leicester City Council for a review of the existing premises licence for The City Rooms, Hotel Street, Leicester. The application was made on the grounds of the prevention of public nuisance. A copy of the application is attached at Appendix B.
- 6.2 The Noise Team are concerned that they have witnessed noise nuisances from the City Rooms in a nearby residential property on two occasions during June and early July 2014, which has demonstrated that the licence holder has failed to properly manage the volume of music at the premises.

7 Steps to Promote the Licensing Objectives

7.1 In arriving at its decision on the review application, the Licensing Authority's primary consideration must be the promotion of the licensing objectives.

8. Statutory Guidance

8.1 Any decision made by the Licensing Authority must be in accordance with the licensing objectives. In addition, the government has issued guidance under section 182 of the Licensing Act 2003. The relevant parts of the guidance in this case are as follows:
