#### Report of the Director of Local Services and Enforcement

#### 1. Purpose of Report

1.1. This report provides information for Members about an application made under the Licensing Act 2003, to assist them in determining the outcome of that application.


#### 2. Determination to be made

- 2.1. Having considered the application and representations, Members must consider whether to
  - Reject the review application
  - Modify the conditions of the licence
  - Exclude a licensable activity from the scope of the licence
  - Remove the designated premises supervisor
  - Suspend the licence for a period not exceeding three months
  - Revoke the licence
- 2.2 Where Members take the decision to reject the review application, they are permitted to issue an informal warning to the licence holder and / or recommend improvement within a particular period of time.

#### 3. Summary

3.1 This report outlines an application for a review of an existing premises licence for The Grapevine and summarises the representations received. It also highlights the licensing objectives, the relevant parts of the guidance and regulations, and the pertinent sections of the Licensing Authority's Licensing Policy.

- 5.1. The existing licence is attached at Appendix A.
- 5.2. The activities and hours permitted by the existing licence are as follows:

### 6. Review application

- An application was received on 24<sup>th</sup> February 2015 from Leicestershire Police for a review of the existing premises licence for The Grapevine. The application was made on the grounds of the prevention of crime and disorder, public safety and the prevention of public nuisance. A copy of the application is attached at Appendix B.
- 6.2 Leicestershire Police are concerned that the premises have failed to uphold or promote the Licensing Objectives, putting members of the public at risk. This is due to a number of poor management practices, failures to assist and being obstructive towards police investigations and reported assaults by staff members on members of the public.

## 7. Representations

7.1 Two representations were received on 7<sup>th</sup> March 2015 and 23<sup>rd</sup> March 2015 from Councillor Kitterick and the Noise Team. Both representations relate to the prevention of public nuisance. Councillor Kitterick and the Noise Team are concerned that they have received repeated noise related complaints over a number of years associated with this premises. Copies of the representations are attached at Appendix C1 and C2.

## 8 Steps to Promote the Licensing Objectives

8.1 In arriving at its decision on the review application, the Licensing Authority's primary consideration must be the promotion of the licensing objectives.

### 9. Deregulation of Entertainment

- 9.1 The Live Music Act 2012 amended the Licensing Act 2003 so that live music is not licensable in certain circumstances. The exemptions include amplified live music in an on licensed premises between 08.00 and 23.00 hours, to an audience of up to 500 people. Unamplified music does not require a licence anywhere between 08.00 and 23.00 hours, regardless of the audience size.
- 9.2 The 2012 Act includes provision for conditions to be imposed on live music following a review and in such circumstances, live music is treated as if it is licensed at the premises.
- 9.3 The Legislative Reform (Entertainment Licensing) Order 2014 further amends the 2003 Act and extends the live music exemption to include recorded music as well. The options at review are also extended to recorded music.

#### 10. **Statutory Guidance**

10.1 Any decision made by the Licensing Authority must be in accordance with the licensing objectives. In addition, the government has issued guidance under section 182 of the Licensing Act 2003. The relevant parts of the guidance in this case are as follows:
