Annex 1 - Mandatory conditions

Supply of alcohol - on the premises

No supply of alcohol may be made under the premises licence -

a) at a time when there is no designated premises supervisor in respect of the premises licence, or

b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence,

The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children-

a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-

 drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supplied alcohol), or

ii) drink as much alcohol as possible (whether within a time limit or otherwise);

b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act).

c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;

 d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-

the outcome of a race, competition or other event or process, or

the likelihood of anything occurring or not occurring;
 selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamourise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

The responsible person shall ensure that-

 a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-

beer or cider: ½ pint;

ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and

iii) still wine in a glass: 125 ml; and

b) customers are made aware of the availability of these measures.

Supply of alcohol - off the premises

No supply of alcohol may be made under the premises licence -

a) at a time when there is no designated premises supervisor in respect of the premises licence, or

b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such

older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark

All individual(s) at the premises for the purpose of carrying out a security activity must be licensed by the Security Industry Authority.

Admission of children to the exhibition of any film must be in accordance with the recommendations of the British Board of Film Classification for that film. Where permission has been given by the Licensing Authority to show a film not classified by the British Board of Film Classification, the requirements made by the Licensing Authority for the admission of children to the exhibition of that film must be followed.

Annex 2 - Conditions consistent with the operating schedule

All amplified music and voice played on the premises be played through a sound limiting device set at a level to ensure that no noise nuisance is caused to occupiers of nearby residential accommodation.

All windows and doors to the front façade be kept closed (apart from access and egress) when amplified music and voice is being played.

The licence holder will ensure that they work closely with the police, local authority, community leaders, fellow tradesmen and residents associations to combat crime and disorder.

The licence holder will ensure that if necessary they will have a security presence, such as registered SIA door staff, particularly on Friday and Saturday.

The licence holder will ensure that they encourage responsible drinking and will not introduce or carry on any irresponsible sales promotion on alcohol.

The licence holder will ensure that there are fire exits and they are regularly maintained. Appropriate signage will be displayed.

The licence holder will ensure that the premises will be equipped with fire blankets and extinguishers.

The licence holder will ensure that all staff will receive extensive training and education in the use of fire extinguishers/blankets.

The licence holder will ensure that they have a nominated fire officer to oversee and regulate fire drills, which will occur regularly.

The licence holder will ensure that staff are fully trained and educated on content and compliance with Health & Safety legislation.

The licence holder will ensure that risk assessments are regularly undertaken.

The licence holder will ensure that the building and its surroundings, particularly the car park is equipped with adequate lighting.

The licence holder will ensure that there is an adequate and appropriate supply of first aid equipment and materials is available on the premises.

The licence holder will ensure that they introduce a policy that all staff request identification for people whom they suspect to look under the age of 21, at intermittent intervals throughout opening hours.

The licence holder will ensure that CCTV is installed following advice from the Leicestershire Constabulary and maintained in accordance with the Information Commissioner's CCTV Code of Practice.
