# **Report of the Director of Local Services and Enforcement**

## 1. Purpose of Report

1.1. This report provides information for Members about an application made under the Licensing Act 2003, to assist them in determining the outcome of that application.


#### 2. Determination to be made

- 2.1. Having considered the application and representations, Members must consider whether to
  - Grant the licence without modification
  - Grant the licence subject to conditions
  - Exclude from the licence any of the licensable activities
  - Refuse to accept the proposed premises supervisor
  - Reject the application

#### 3. Summary

3.1 This report outlines an application for a new premises licence for Riddhi Convenience Store which may be in the Belvoir street area cumulative impact zone and summarises the representations received. It also highlights the licensing objectives, the relevant parts of the guidance and regulations, and the pertinent sections of the Licensing Authority's Licensing Policy.

# 5. Application

- 5.1 An application was received on 26<sup>th</sup> March from Mr Anand Vinod for a new premises licence for Riddhi Convenience Store, 22 King Street, Leicester, LE1 6RL. A copy of the application is attached at Appendix A.

#### 6 Steps to Promote the Licensing Objectives

- 6.1 The steps the applicant proposes to take to promote the licensing objectives are set out in the operating schedule (see section M of Appendix A).
- 6.2 In arriving at its decision on the application, the Licensing Authority's primary consideration must be the promotion of the licensing objectives.

## 7 Representations

- 7.1 Seven representations were received between 27<sup>th</sup> March 2015 and 22nd April 2015 from local residents. The representations relate to the prevention of crime and disorder, the prevention of public nuisance and public safety. The local residents are concerned that licensing of the premises will only add to existing noise problems and increase already high rates of alcohol related harm and anti-social behaviour. Copies of the representations are attached at Appendix B1 B7.
- 7.2 A representation was received on 27<sup>th</sup> March 2015 from Cllr Lynn Senior. The representation relates to the prevention of crime and disorder, the prevention of public nuisance and public safety. The Cllr fully supports the comments of her constituents regarding this application. A copy of the representation is attached at Appendix B8.
- 7.3 A representation was received on 21<sup>st</sup> April 2015 from Leicestershire Police. The representation relates to the prevention of crime and disorder, prevention of public nuisance, public safety and the protection of children from harm. The Police are concerned that licensing of the premises will add to existing cumulative problems in the area and that the application does not fully promote the licensing objectives. A copy of the representation is attached in Appendix B9.

## 8 Conditions

8.1 Conditions consistent with the operating schedule are attached at Appendix C.

#### 9 Cumulative Impact

In February 2011 Leicester City Council introduced a special policy on cumulative impact in the Belvoir Street area, which refers specifically to on and off licences. This creates a rebuttable presumption that an application for a new premises licence will be refused, unless the applicants can show that their premises are unlikely to add to the problems of saturation.

9.1 The address of Riddhi Convenience Store is 22 King Street, but there is also a door to the rear of the premises that opens on to the section of New Walk that is included in the cumulative impact zone. Officers consider that the premises is within the cumulative impact zone, but Members may wish to address this issue for the sake of clarity.
