**Annex 1 - Mandatory conditions**

No supply of alcohol may be made under the premises licence -

- a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

**Annex 2 - Conditions consistent with the operating schedule**

The licence holder will provide CCTV inside and outside the premises and link these to the Local Policing Authority to monitor activities.

The licence holder is committed to assisting the authorities including the adoption of the Police searching policy and conditions of entry.

The licence holder will ensure regular risk assessments are carried out and will initiate a comprehensive noise impact assessment, with a view to tackling noise due to the licensable activities.

The licence holder will ensure staff are trained in crisis management and customer services.

The licence holder will ensure not to cause any nuisance or disturbance to local residents or members of the public.

**Annex 3 - Conditions attached after a hearing by the Licensing Authority**

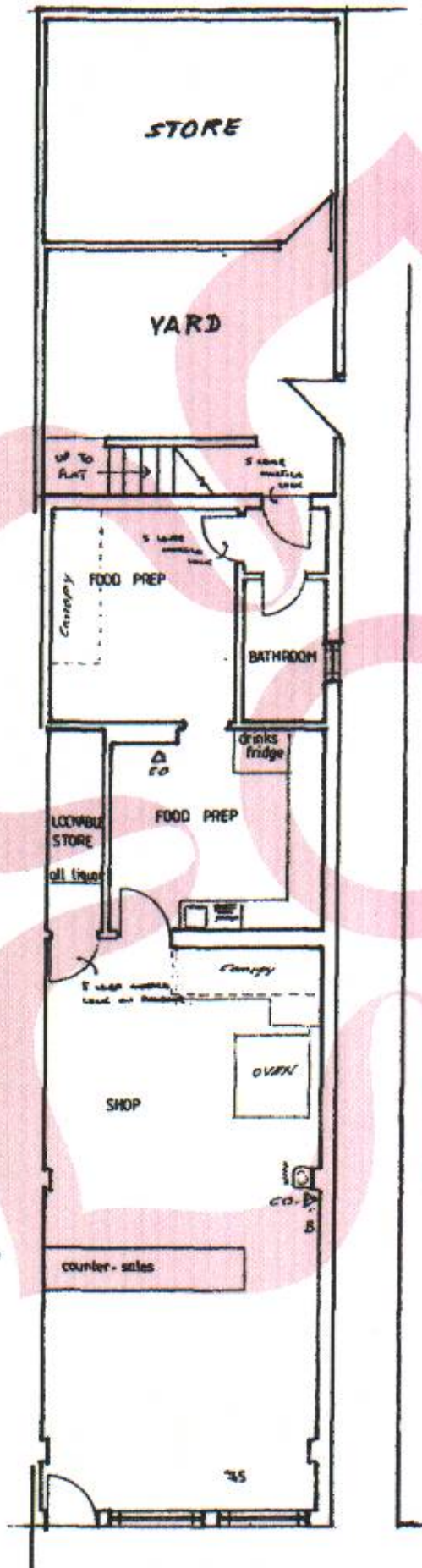
Mr Kharak Singh Rai must successfully complete the National Certificate for Personal Licence Holders and present the evidence to the Licensing Department.

The licence holder will ensure that CCTV is installed following advice from the Leicestershire Constabulary and maintained in accordance with the Information Commissioner's CCTV Code of Practice.

The sale of alcohol will only be made to persons on the premises at the time of sale. Deliveries of alcohol are not permitted.

The challenge 21 policy shall be enforced and refusal log shall be adopted and maintained and made available for inspection by the responsible authorities upon request.
