CORPORATE CAPITAL PROGRAMME 2005/6 TO 2007/8 LOCAL ENVIRONMENTAL WORKS

Report of the Service Director, Highways and Transportation

1. Purpose of Report

1.1 To seek comments of the Highways and Transportation Scrutiny Committee on the proposed Local Environmental Works programmes 2005/6 to 2007/8 and to seek Cabinet approval to implement the programme.

2. Summary

2.1 Cabinet recommended at their meeting on the 16th May 2005 that, before committing expenditure to the Local Environmental Works programme, a further report be brought to the Highways and Transportation Scrutiny Committee for consideration and then to Cabinet for approval. The report would detail options for a 3 year Local Environmental Works programme for 2005/6 to 2007/8.

3. Recommendations

- 3.1 The Highways and Transportation Scrutiny Committee is asked to consider this report on the Local Environmental Works programmes 2005/6 to 2007/8 and make comments to report to Cabinet.
- 3.2 Cabinet is asked to approve the Corporate Capital Programmes 2005/6 to 2007/8 for Local Environmental Works programmes detailed in paragraphs 1.6, 1.7 and 1.8 of the report with Thurncourt ward as the targeted ward for 2005/6 and Humberstone and Hamilton ward as the targeted ward for 2006/7.

CORPORATE CAPITAL PROGRAMME 2005/6 TO 2007/8 LOCAL ENVIRONMENTAL WORKS

SUPPORTING INFORMATION

1. Report

- 1.1 The budget for Local Environmental Works (LEW) is designed to cover a wide range of environmental works around the City, addressing a number of problems, needs and opportunities. These have in previous years included provision of a broad range of works such as:
 - Lay bys,
 - Untidy land,
 - Environmental Improvements,
 - Bus shelters,
 - Improved Signing,
 - Verge Hardening
 - Minor Lighting Improvements
- 1.2 The LEW programme was started in 2000 with part of the budget targeted on a particular inter-war housing area so as to make significant improvements to the local environment, by, for example providing parking areas where narrow roads and increasing numbers of cars cause problems. This approach has now been completed successfully in the New Parks, Eyres Monsell, Mowmacre and the former Saffron housing estates. In addition, match funding with the Braunstone Community Association in 2004/5 and 2005/6 will target the Braunstone housing estates.
- 1.3 This targeted approach has been supported and endorsed by local Members and residents and officers intend to continue this approach in the period 2005/6 to 2007/8. Officers intend to target the Thurncourt ward, in particular, in 2005/6 as it suffers from narrow residential streets with grass verges that were not constructed to deal with the number of vehicles using them. Parking on street is a particular problem for the residents as well as access for emergency vehicles. In addition, Thurncourt is now the ward with the most outstanding requests on departmental request lists for laybys and verge hardening. We have already completed two schemes in Thurncourt (Ocean Close (2004/5) and Kirkwall Crescent (2005/6)) but as can be seen from Appendix 1 there are still many to complete. The proposed funding for 2005/6 for Thurncourt will be

£125,000 and the schemes will be chosen from the list of streets in Appendix 1 after discussion with local ward Members, the Area Committee, residents and other local stakeholders.

- 1.4 There are similar problems in the Humberstone and Hamilton ward and, if Members agree this programme, officers will concentrate on this ward in 2006/7. It is not sensible to prepare a proposed scheme list for this ward in 2006/7 at this stage as requests for this type of work are continually being received and it is important to target the worst areas. We do not propose to submit a ward to be targeted for 2007/8 as there is insufficient information at present to ensure that the right choice of ward would be made. The detailed 2006/7 and 2007/8 LEW programmes will be submitted to the Highways and Transportation Scrutiny Committee for their comments at the appropriate time.
- Officers intend, if Members agree this programme, that the remainder of the funding continues to be allocated citywide. This will fund the most requested work by residents ie laybys and verge hardening. It will also continue to complement the regeneration within the City Centre. The proposed LEW programme for 2005/6 is detailed in para 1.6 below. The proposed funding split for 2006/7 and 2007/8 are given in paragraphs 1.7 and 1.8 below respectively.
