I write to you following my visit and discussions with yourself and Simon Green regarding the application for the new premises licence. I am grateful for your cooperation.

As discussed I have no issues with the application for licensed activities at your premises provided that suitable conditions are attached to the new licence which I believe will help you prevent noise affecting your near neighbours.

The licencing system requires that I request that you make a formal, written request to Licensing that measures have been agreed with the Noise Team. This may make a hearing unnecessary.

Friday and Saturdays 09.00 to 02.00 hours.

The hours for the exhibition of film and live sporting events on the second and third floors be restricted to the lesser hours of  
Sunday 09.00 to 23.00,  
Monday to Wednesday 09.00 to 00.00 (Midnight)  
Thursday, Friday and Saturdays 09.00 to 02.00 hours.

No live or recorded music shall be played on the third floor except for low level background music.

Prominent, clear notices shall be displayed at all exits requesting customers and staff respect the needs of local residents by keeping noise to a minimum when using the outside area and when leaving the premises. All such signs must be in a permanent form, prominently placed and be legible.

Disposal of waste bottles into external receptacles where the noise will be audible to neighbouring properties must not occur between 20.00 and 09.00 hours

The licensee shall ensure that whilst customers are queuing to enter the premises, noise levels are managed to prevent public nuisance to local residents.

The licensee shall take reasonable steps to prevent public nuisance being caused by customers outside whilst smoking.

The form requires your signature before you return it to the Licensing Team.
