STATEMENT OF COMMUNITY INVOLVEMENT IN THE PLANNING PROCESS

Report of the Corporate Director Regeneration and Culture

1 Purpose of Report

To report on the results of the public consultation on the Pre Submission Statement of Community Involvement and for Cabinet to approve the revised Statement of Community Involvement (SCI) for further public consultation and for submission to the Secretary of State.

2 Summary

The new planning system requires involvement of the community throughout the various stages of the planning process. The new Local Development Framework must include a SCI setting out the way in which the City Council intends to engage with the public and community organisations. The Development Framework will ultimately replace the City of Leicester Local Plan and other Development Plan and Supplementary Planning Documents.

- 2.1 The SCI, attached to this report as Appendix 2, describes briefly the new planning system and lists the documents that will be the subject of public consultation and involvement. It sets out the range of groups and individuals who should be involved in the planning process and summarises the types of consultation methods that will be used. Chapter 8 of the SCI describes the Council's policy on community involvement in planning applications.
- 2.2 A six-week consultation period started on 29th July. Officers have taken into account comments received in the preparation of the Submission Draft Statement of Community Involvement. The draft Statement will be published for a further six week period of public consultation on 28th November. Any comments made at that stage would be subject to examination by an independent Planning Inspector.

3 Recommendations

- 3.1 That Members of Scrutiny Committee consider the responses to the comments made on the Pre Submission SCI.
- 3.2 That Cabinet approves the Draft Submission SCI for six weeks public consultation and submission to the Secretary of State.

SUPPORTING INFORMATION

1. Background

- 1.1 As part of the new planning system brought in under the Planning and Compulsory Purchase Act 2004 the City Council must produce a Statement of Community Involvement (SCI). This has to set out the Council's policy for engaging with and involving the community in the preparation of documents in its Local Development Framework, and in deciding planning applications.
- 1.2 The Government has published guidance on the contents of Statements of Community Involvement and statutory regulations specify the minimum standards for access to information and public consultation.
- 1.3 The timetable for the production of the SCI and other planning documents is set out in the Council's Local Development Scheme, which was approved by Cabinet on 13th June 2005. This establishes the key stages in the production of the SCI.
- 1.4 Consultation on the Pre- Submission SCI is a key stage and began, on schedule, in July 2005. The key date for Submission of the SCI is November, with the examination by an independent Planning Inspector scheduled for April 2006.

2. Content of the SCI

2.1 The SCI states which forthcoming Local Development Documents (LDD) will be the subject of public consultation. The Council will produce a Core

- Strategy in the next 3 years and Development Plan Documents (DPD) which form part of the Waste Development Framework will be produced jointly with the County Council.
- 2.2 Supplementary Planning Documents (SPD) are included in the Local Development Scheme and are in progress, but all are scheduled to be adopted before adoption of the SCI. Therefore, at this stage the SCI cannot be specific about the consultation that it will undertake for future SPDs that are not yet identified.
- 2.3 The SCI identifies the categories of people that the Council wants to engage in the planning process and, in particular, the hard to reach groups. More targeted consultation methods will be required to engage with these groups.
- 2.4 Officers propose a range of methods of consultation and engagement. The optimum consultation method will depend on the document being prepared and its range and likely consultees. A variety of methods are likely to be used.
- 2.5 Paragraphs 7.1 and 7.2 of the SCI set out the various stages in the preparation of DPDs and SPDs to indicate when public consultation and participation exercises will be carried out.
- 2.6 The final chapter of the SCI sets out the minimum requirements for consultation on planning applications and what the Council does or is committed to doing in addition to that. Some actions are identified for future implementation or consideration.

3. Consultation on Pre-Submission SCI

- 3.1 During the preparation of the Pre Submission SCI officers undertook informal consultation, in accordance with the statutory regulations, with;
 - Leicester Partnership,
 - Leicester Economic Partnership
 - Organisations representing ethnic minority and faith groups, voluntary groups, people with disabilities and businesses in the city.
- 3.2 As a result of this consultation the Centre for Integrated Living provided guidance on suitable formats for documents and ways of involving people with disabilities in the planning process. The Leicester Partnership provided information on the community networks that might be used for consultation.
- 3.3 Public consultation on the Pre Submission SCI was held for six weeks between 29th July and 9th September in accordance with the statutory regulations on consultation at this stage of the SCI preparation.
- 3.4 36 individuals or organisations commented on the Pre Submission SCI. Of these 19 made comments to which the Council must respond. The other 17 respondents were supporting the SCI; making no further comments or

requesting that they be added to the list in Appendix 2 of the SCI or included on the Local Development Framework Consultation Database. Details of all the respondents; their comments and the proposed Council response are attached at Appendix 1.

- 3.5 This paper proposes that additions are made to the Pre Submission SCI in response to some of the comments. These are set out in Appendix 1.
- 3.6 Paragraphs 7.1 and 7.2 now include a commitment that Area Committees will be consulted at key stages of the preparation of Development Plan Documents and Supplementary Planning documents.
- 3.7 The Government Office made comments on the Pre Submission SCI. After discussion all their concerns have been overcome by minor additions to the document.
- 3.8 Leicestershire County Council were concerned that the SCI did not provide sufficient guidance on exactly how the City Council will enable young people to make a real contribution to its consultation exercises. In response amendments have been made to paragraph 5.8 of the SCI, referring to the role of the Young People's Council and Youth Area Forums.
- 3.9 The Regional Assembly commented that the SCI provides an excellent summary of the new planning system and the associated procedures, requirements and issues.
- 3.1 In response to comments made by Scrutiny Committee on 14th September, paragraph 6.4 has been amended by the addition of a statement that the Council will aim to avoid main holiday periods for public consultation if possible.

4. Conclusion

- 4.1 A draft Submission SCI is attached at Appendix 2. The additions to the Pre Submission SCI, as a result of the comments made during the public consultation are shown underlined.
- 4.2 There will be a further period of formal consultation on the Submission Draft SCI. Comments made at that stage will be examined by an Inspector appointed by the Planning Inspectorate. The examination will not be a formal Planning Inquiry and is most likely to take the form of written representations.
