May I take this opportunity to remind you that Section 57 of the Licensing Act 2003 states;

"(2) The holder of the premises licence must secure that the licence or a certified copy of it is kept at the premises in the custody or under the control of

- a) the holder of the licence, or
- b) a person who works at the premises and whom the holder of the licence has nominated in writing...

(3) The holder of the premises licence must secure that

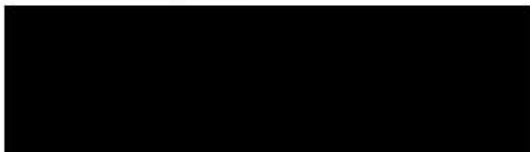
- a) the summary of the licence or a certified copy of that summary, and
- b) a notice specifying the position held at the premises by any person nominated for the purposes of subsection (2),  
are displayed prominently at the premises."

It is an offence to fail to comply with the above requirements.

## ANNEXES

### Annex 1 - Mandatory conditions

No supply of alcohol may be made under the premises licence -

- a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

From 6 April 2014

A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

### Annex 2 - Conditions consistent with the operating schedule

The licence holder will install a CCTV system.

The licence holder will ensure that drinking alcohol on or near the premises is not permitted.

The licence holder will check the age of customers when sales of alcohol are made.

The licence holder will operate the premises according to health and safety regulations.

The licence holder will ensure that customers are encouraged to vacate the premises after making their purchases.

The licence holder will employ a door supervisor or security guard if it is considered necessary.

The licence holder will discourage people from congregating outside the premises.

The licence holder will ensure that the products they sell are safe.

The licence holder will ensure that all equipment on the premises is safe and that health and safety measures are in place.

The licence holder will ensure that fire safety equipment is present on the premises.

The licence holder will ensure that staff are trained in basic first aid.

The licence holder will carry out regular risk assessments.

The licence holder will ensure that fire exits are accessible at all times.

The licence holder will install non-slip flooring on the premises.

The licence holder will ensure that there is a first aid box on the premises and that any relevant accidents or incidents are recorded.

The licence holder will ensure that no music will be played inside or outside the premises.

The licence holder will not sell alcohol to any customers who appear to be under the influence of alcohol.

The licence holder will ensure that staff manage any loud or inappropriate behaviour from customers.

The licence holder will ensure that deliveries take place at the back entry of the premises.

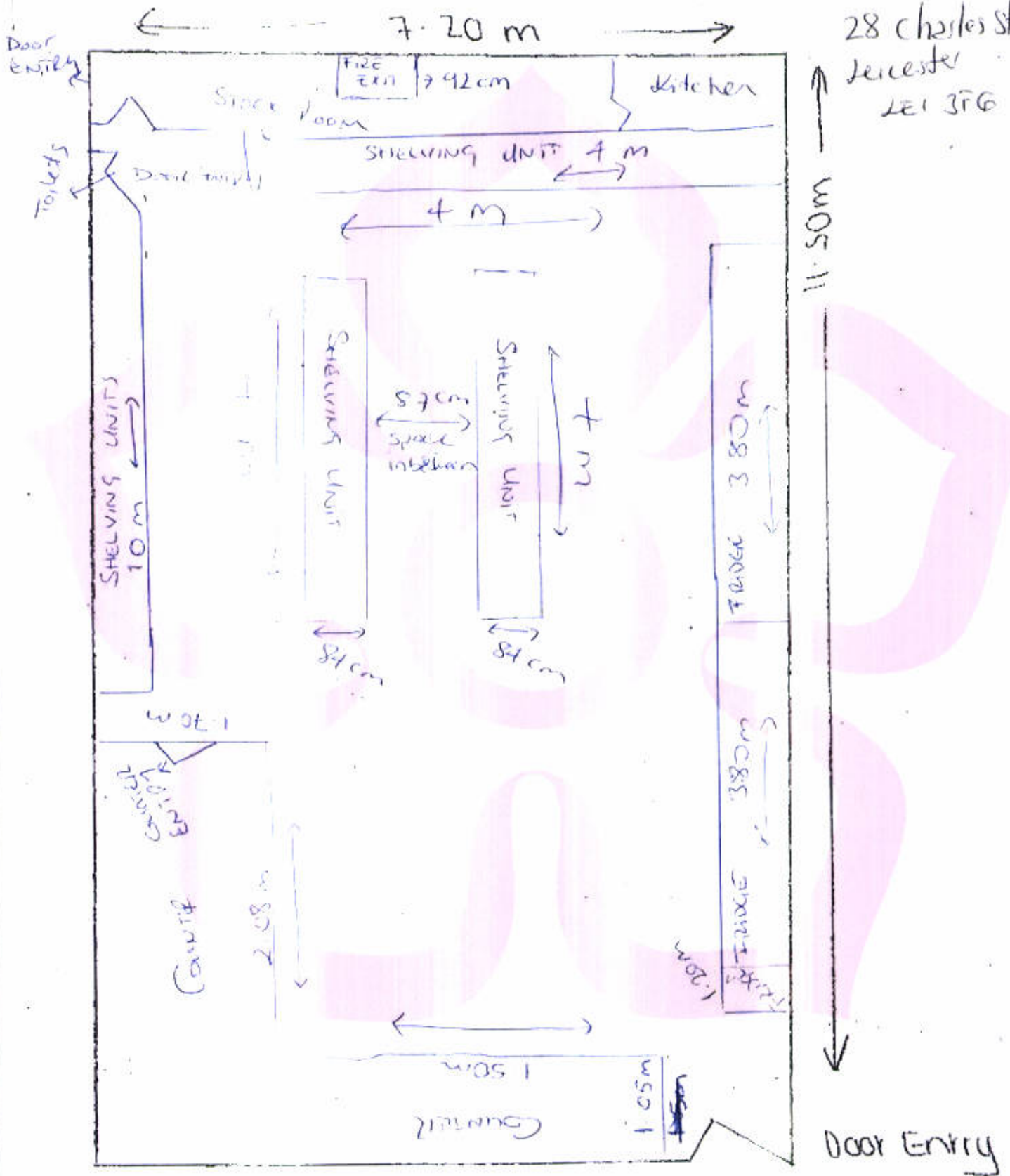
