Leicestershire Police believe that these premises fail to both uphold or promote the Licensing objectives thereby putting members of the public at risk.

The area of Charles Street, Humberstone Gate & Clarence Street Leicester suffers from the congregation of a group identified as street drinkers.

This group are known to purchase high strength alcohol from this shop which fuels the subsequent crime & disorder & public nuisance in this area.

These incidents also impact on the safety of the general public going about their business and the emergency services who are frequently called to deal with the resulting excessive intoxication be it medical or anti-social.

It is recognised that "street drinkers" will look to purchase the greatest amount of alcohol for the least amount of money.

These premises offer for sale a variety of high strength alcohol drinks, many in cans where the ABV (alcohol by volume) is between 5.6% and 9%. Many of these cans are retailed at £1 only

Staff at the premises know the group and are aware of the problems caused by the selling of alcohol to this group but continue to provide the alcohol.

A meeting was held with the Designated Premises Supervisor Mr Chimani Bhaichandbhai SHAH on the 13th June 2016 where he was told that the selling of alcohol to people that went on to cause crime & disorder, public nuisance and impacted on public safety was not promoting the licensing objectives.

Mr SHAH was informed that the premises would be closely monitored over the following 2 weeks and it was for him to show he and his staff were promoting the licence objectives and to ensure those causing the anti-social behaviour were not fuelled by alcohol bought from his premises.

Alcohol has continued to be sold from the shop to individuals of the group that he and his staff are aware cause crime & disorder, public nuisance and impact on public safety within the vicinity of his shop.

Mr SHAH is failing to uphold or more importantly promote the licensing objectives by providing the fuel for this group.

The object of this review application is to seek an appropriate measure to promote the licensing objectives condition and discourage the "street drinkers" from purchasing high strength alcohol and congregating in the area.

We would seek the following condition;

1. The licence holder will ensure that no beers, lagers, ciders or perrys are sold where the alcohol by volume (ABV) exceeds 5.5%.
2. The licence holder will ensure that CCTV is installed following advice from Leicestershire Police and maintained in accordance with the Information

Commissioners Codes of Practice for CCTV. Recordings will be maintained at all times the premises is open to the public and these images will be retained for a minimum of 30 days.

3. The licence holder will ensure that there is always a member of staff on the premises whilst it is open to the public who is trained to operate and provide images from the CCTV system to all Responsible Authorities. Any request for CCTV outside these times will be made available within 48 hours of the request being made.
4. The licence holder will ensure a refusal log is kept on the premises and all refusals will be recorded. This log will be retained for 12 months and made available to Responsible Authorities on request. It will be checked, signed and dated on a weekly basis by the designated premises supervisor or premises licence holder.
5. The supply of alcohol for consumption off the premises be reduced to start from 8am (0800hrs) till 10pm (2200hrs) Monday to Sunday

And if item 5 is agreed that item 6 is applied as a condition.

6. The licence holder will ensure that any alcohol on display outside licensable times is not accessible to customers attending the premises and that signs are clearly displayed in prominent positions informing customers the times alcohol is available for sale.

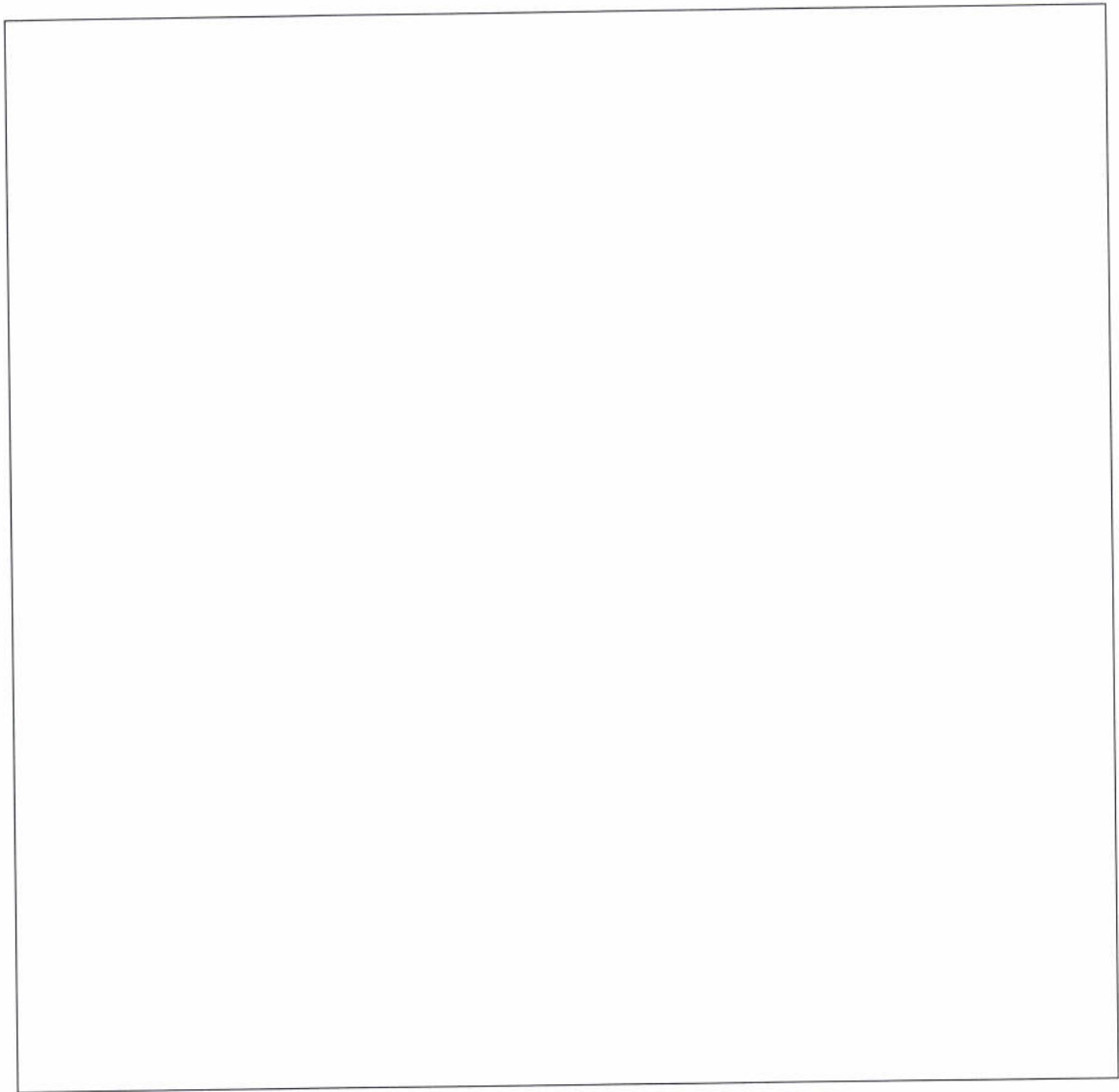

I am Sergeant 1461 Andy Cooper of the Leicestershire Police based at the Central Leicester Neighbourhood Policing Area in Leicester. I have been involved with Neighbourhood Policing in Leicester for the last six years. Part of my role includes tackling crime and anti-social behaviour patterns with a problem solving approach.

Street drinking and begging have always been a problem in the City Centre, causing many visitors, residents and businesses nuisance and distress. However, during recent months this problem has escalated in the area of Humberstone Gate and Charles Street. Police have received daily reports of drunken abusive people street drinking, begging, stealing from shops, using legal highs (NPSs) shouting and fighting amongst themselves. On several occasions shops including Thomson's Travel Agent had to close temporarily due to safety fears for staff and customers. The Police, City Council and City Mayor have received letters of complaints from visitors to the City and businesses. One letter was written by the Director of Brucciani Café which was signed by several local businesses on Humberstone Gate describing how this behaviour had led to reduced customers, reduction in sales and fears for the safety of their staff members.

Those responsible for this behaviour are known as "street drinkers". Most are well known to support agencies and businesses across the City as they have engaged in similar behaviour for a number of years. Most of them suffer from alcohol and/or drug dependency which controls their lives and habits. In many ways, they can be classed as vulnerable. Most are

either homeless or live in hostels or other forms of supported accommodation. They often have other associated health problems and a reduced life expectancy. Three known drinkers have already died in Leicester this year alone, all under the age of 50.

One of the contributing factors to this anti-social behaviour is the availability of cheap strong strength alcohol. There are three off licences in close proximity in the Charles Street area all of whom sell alcohol above 5.6% ABV in cans for between £1 and £1.79 each. Cans can be sold individually and there has been evidence from Officers, CCTV and anecdotally from the public that known street drinkers make regular daily purchases from these three premises before drinking them on nearby streets. The Licensees have been visited by Officers in the Neighbourhood Policing Team and the Licensing Section requesting they stop selling to street drinkers. They have been informed of the reasons why and have admitted they understand this. A lot of the anti-social behaviour occurs in the bus stops outside their stores anyway. However, despite all the advice and support offered - the strong strength alcohol sales are still happening everyday resulting in large congregations of drinkers. In my view, these sales contribute towards the public nuisance in the area and do not promote public safety.

The Police and Leicester City Council have used a significant amount of resources to tackle the problem. In June 2016 alone, 16 different people were arrested on 21 occasions for offences including Fail to Appear Warrants, Thefts, Drug Offences and GBH. All those arrested were linked to the anti-social behaviour in the Charles Street / Humberstone Gate area. Several others were dispersed or had alcohol disposed where the Public Spaces Protection Order (PSPO) had been breached. In addition the Police attend bi-weekly joint agency meetings with partners including Homeless Outreach, Inclusion Healthcare, Criminal Justice Drug Team and Housing where individual cases are discussed and progressed. The primary aim is to assist people away from their offending behaviour with a focus on treatment, support and accommodation. The Anchor Centre on Dover Street is purposely designed and available where it is permissible to drink alcohol whilst receiving individually designed support and treatment programmes. This is open during day time hours every single weekday.

In summary then, the drunken and disorderly behaviour described has a negative impact on the City Centre. The businesses rely on the City being a pleasant and welcoming environment to encourage visitors to spend money in their stores. This is especially relevant in a year

when the City wants to welcome visitors from across the world due to the Football success and the King Richard 3rd activities. Many people's livelihoods depend on these businesses making profits and being successful. The Police have invested significant time and resources doing prevention and enforcement work but we recognise that there are limitations to this while there is easy availability of strong strength alcohol at stores in the affected areas. PCSO 6570 Gorania – 10/05/16 13:00 I was walking past Chrystals News Agents on Charles Street when I noticed a male who is a known street drinker (PS date of birth) in the shop, he was staggering from the refridgerated area to the till, I watched him stretch his arm out as if he was making a payment however I could not see the counter. He had a can of what I believe was Strongbow in his hand (grey and black can)which was sealed. When I asked the shop keeper if he had purchased the can he said he had come into the shop with it. P was clearly intoxicated as he was unsteady on his feet and absolutely stank of alcohol. This has been recorded on bodycam and marked as evidential under Charles Street drinking PSP.

While I was in the shop a female who is also a street drinker (RH date of birth) entered the store and brought alcohol, while she was in the shop TG (also known drinker) was waiting down the road for her. She did not seem intoxicated.

We also reminded them of not to sell to those intoxicated and our presence is increasing ensuring this is being implemented. They assure us they do not sell to those drunk, but have provided bags to those drinking as they think it looks better for the area. They have mentioned RS has been causing a few problems, but asked him to leave which he did.

I've not added anything to Inn web yet as I'm not sure how many characters it will add.

In short, I was street drinker watch today 8th June and at about 17:40 I had a can of Karpackie from CK .She staggered off from me towards Charles St so I followed, she went through the Haymarket and then emerged onto Charles St, She then went into the above store and emerged with a small black carrier bag and walked off.

I have then gone into the store and spoke to an Asian male who confirmed that K had been in, he denied her buying or him selling any alcohol to her. He claimed that he had sold her 2 pots of Pot Noodle!!.

CK was clearly drunk as ten minutes later back on Humberstone gate I have seen CK drinking can of lager - Karpackie! From a small black plastic bag.

Attended the premises to speak with the DPS Mr Shah regarding the information I had been given that the premises was selling alcohol to street drinkers who were intoxicated. Mr Shah was not present so I asked his son who was on duty to ask that he gave me a call. Around midday I received a phone call from MR Shah and I have set up a meeting at Mansfield House on Monday to discuss the matter.

Whilst in the shop I noticed that they are selling Karpackie Beer 9% ABV and a number of East European beers which also had high ABV content.

Mr Shah,

Thank you for attending Mansfield House Police Station today Monday 13th June 2016.

I opened the meeting by introducing myself and PS Andrew Price before asking you how long you had been at the present location and what experience you had in alcohol licensing.

You informed me that you have been at Chrystals for about 3 years and prior to this you had a shop in Granby St. I pointed out that you therefore had a number of years experience of alcohol licensing and I asked if you were aware of the 4 Licensing Objectives. You stated you were and started to describe not selling to under age people but not the licensing objectives themselves. I therefore reminded you of the licensing objectives

- The Prevention of Crime & Disorder
- The promotion of Public Safety
- The Prevention of Public Nuisance
- The Protection of Children from Harm

I reiterated that it was your obligation to promote the Four Licensing Objectives specifically regarding the "Prevention of Public Nuisance" and that presently it was my opinion that by your actions were failing to promote 3 of those objectives.

I mentioned that I was aware that you were presently selling cans of Karpackie beer which is 9% ABV along with a number of Eastern European lagers around the 7% ABV mark. I also told you I was aware that the group identified as "street drinkers" were those that were purchasing this beer as it was being sold for just £1 a can.

Research has shown 'Street Drinkers' are not concerned with taste but with getting the highest 'hit' through high strength beers, lagers & ciders for the smallest financial outlay.

We discussed the 'street drinkers' and the fact that you and your staff were supplying the alcohol which was the main factor in fuelling the anti-social behaviour and public nuisance experienced by members of the public visiting the area, including you and your staff.

You agreed with these comments stating that you and your staff are fully aware of the group we were talking about and fully aware of the anti-social behaviour caused by this group. You also agreed that you have been selling alcohol to those you know to be part of this group.

PS Price reiterated that staff at the shop must be aware of the group who were not like normal customers who came in once a day but would continually come in to purchase alcohol. Again You agreed with this observation.

You also agreed that the present situation on Charles Street is not an acceptable image for the City and impacts on those visiting.

I then went on to explain that we needed to work together to eradicate the problems being experienced, however I assured you that I am prepared to use the Licensing Act and will call a review of the Licence should there be no improvement. I explained that amongst other options I may ask for a revocation of the licence, removal of the DPS but most certainly would seek a condition that no alcohol over 5.5% could be sold.

This is a condition which has been used to good effect in other areas of the City.

You have indicated that you are prepared to work to remove the problems and suggested that you will stop selling alcohol to those that are causing these problems fuelled by alcohol.

Both myself and PS Price agreed that to promote the licensing objectives you must stop selling alcohol to those who you know use alcohol bought from your shop to get drunk and then cause public nuisance and crime & disorder.

I have told you that we will monitor the situation over the next 2 weeks. This is to give you and your staff a clear time in which to show improvement.

If we continue to find that alcohol sold from your shop is a contributory factor in the problems we have discussed a review will be sought.

I also emphasised that the 2 weeks is a time to show immediate improvement however that improvement must continue past the 2 weeks.

Myself and PS Price informed you that Leicestershire Police will support you, especially during the 2 weeks, and should you encounter problems from the group you should report this immediately.

PS Price has advised that you ring either 101 or 999, as appropriate, to enable Leicestershire Police to deal with any problems that may occur from the refusal to sell alcohol.

I pointed out that you should ensure cctv is available and working appropriately to enable officers to view and use it if required to deal with any incidents that may occur.

Again it was emphasised that it is not appropriate to continue to supply the alcohol and then ring in later complaining about a situation that this alcohol, from your shop, has caused.

Mr Shah I thank you for your attendance today and hope that following our meeting you are fully aware of our concerns and action that may be taken.

I hope you will ensure that both you and your staff promote the licensing objectives.

Also there were several drinkers in the first bus stop outside John Cheatles causing a nuisance and ASB .

All were moved on one I recognised as CK. When asked why don't they go to the Anchor Centre to drink they all said that cannot be bothered to walk up there. Wed 1 June, 2:55pm

Conducted several consultations with local shops in the area in relation to community impact statements. Thu 2 June, 12:12pm

Elton Jane (6040)

Incidents: 323, 364, 375 & 386 of 2/6/16 refer:

(323) NewsWorld, Charles Street called in to say a number of street drinkers were outside their shop acting in an anti-social manner putting customers off entering the shop. On arrival there was nobody at location. (364, 375 & 386) all refer to Age UK & Clarence House calling in a large group of males/females/1 young child drinking alcohol & taking drugs behind Charles Street on Clarence Street. Due to quantity of people & drugs being alleged at location other officers called. On arrival the group made off but on reaching the location PCSO 6610 noticed a vehicle had been scratched. This then led to RS coming back to the area acting in a very aggressive manner which lead to his arrest. Whilst on Charles Street a number of people were making complaints about a group in the bus stop between NewsWorld & John Cheatle. On arrival there were a

number of the usual perpetrators stood & sat in the bus stop who were worse for wear. AL was slumped on a seat & people were saying she had taken mamba. She then proceeded to be sick. She was in company with a female who I did not recognise. Others in the bus stop and in the area were SG, MJ, DH, DM, JT, LG & PF. It was commented by a colleague PCSO 6665 that SCHNAPS, Charles Street are selling strong volume lager for £1 a can. She has emailed the licensing officer PC 1790 WEBB for his attention.

Two PC's from response stopped on Charles Street to help move the group on as it was quite large and people were complaining. Thu 2 June, 7:42pm

Visited All European foods store in relation to the increasing ASB in and around the area. we have reminded the store the responsibility they have when selling to intoxicated persons, the effect it is having on the local businesses and persons visiting the town etc. they assured us they do not sell strong lagers etc despite the fact it was visible in the fridges, approx 5 minutes later I spoke to TG and RG who stated that they bought it from this shop! Fri 3 June, 12:44pm

Line Ian (2859)

Conducted patrols around Charles Street/clarence street between 1500 & 2200 I/C with 4011.

Very few persons about on Clarence St or Charles Street and those who were there were good natured.

2200hrs - Assisted PCSO 6610 SMITH at Eastgates with Street Drinkers, including DG, MJ, CK, LJ.

DG and CK were the main protagonists and had caused problems earlier in the evening. After further PRT officers arrived the group eventually dispersed.

MJ was high on mamba and was sat comatose on the floor of Clarkes for about 10 minutes before coming round and walking off, this was at least the second time of the day that he had been in this state. Fri 3 June, 11:38pm

About 17:55hrs 04/06/16 during foot patrol saw MJ and an IC1 male given his details as LG sitting on the seats of the bus stop outside the Newsland on Charles Street, there were empty cans of beer and lots of

cigarette butts by their feet, they were spoken to about ASB and were advised to leave the bus stop area as they were not waiting for a bus! I saw members of public waiting for the bus standing outside the bus stop booth.
