## Objection notice given for a Temporary Event Notice Sumo 54 Braunstone Gate, Leicester

#### Report of the Director of Neighbourhood and Environmental Services

#### 1. Purpose of Report


1.1. This report provides information for Members about an objection notice received in relation to a temporary event notice (TEN) given under the Licensing Act 2003, to assist them in determining the outcome.

#### 2. Determination to be made

- 2.1. Having considered the temporary event notices and the objection notices, Members must consider whether to
  - Give the premises user a counter notice under Section 105 (2) of the Licensing Act 2003 if it is considered appropriate for the promotion of a licensing objective to do so; or
  - Impose one or more conditions on the temporary event notice if:
    - o it is appropriate for the promotion of the licensing objectives to do so, and
    - the condition(s) are also imposed on a premises licence or club premises certificate that has effect in relation to all or part of the same premises as the temporary, and
    - the condition(s) would not be inconsistent with the carrying out of the licensable activities under the temporary event notice; or
  - Disregard the objection notice

#### 3. Summary

3.1 This report outlines an objection notice given by the Noise Team in response to three temporary event notices given by Manoj Kumar for Sumo 54 Braunstone Gate, Leicester. It also highlights the licensing objectives, the relevant parts of the guidance and regulations, and the pertinent sections of the Licensing Authority's Licensing Policy.



## 5. Temporary event notice

- 5.1. Three temporary event notices were given on 12 October 2016 by Manoj Kumar for events at Sumo 54 Braunstone Gate, Leicester. The temporary event notices are for events on 30 October 2016, 13 November 2016 and 27 November 2016 and are attached at Appendix A.1, A.2 and A.3.
- 5.2. The temporary event notices are for the following licensable activities:

Licensable activities	Proposed hours
The sale by retail of alcohol (for consumption	04.00 - 06.00
on and off the premises)	
Provision of regulated entertainment	04.00 - 06.00
Provision of late night refreshment	04.00 - 06.00

#### 6. Objection notice

6.1 An objection notice was received on 17 October 2016 from the Noise Team on the grounds of the prevention of public nuisance. A copy of the objection notices are attached at Appendix B.1, B.2 and B.3.

#### 7. Existing premises licence

7.1 The premises identified in the temporary event notice is partially covered by an existing premises licence. One or more of the conditions on this premises licence may be applied to the temporary event notice if Members consider it appropriate for the promotion of the licensing objectives, and insofar as the conditions are not inconsistent with the carrying on of licensable activities under the notice. A copy of the existing premises licence, including the conditions are attached at Appendix C.

#### 8. Statutory Guidance

8.1 Any decision made by the Licensing Authority must be in accordance with the licensing objectives. In addition, the government has issued guidance under section 182 of the Licensing Act 2003. The relevant parts of the guidance in this case are as follows:
