63. EDUCATION CAPITAL STRATEGY AND PROGRAMME - 2006/07 TO 2007/08

The Service Director Policy & Resources, Education & Lifelong Learning submitted a report which advised Members of the strategic challenges facing Education and Lifelong Learning property portfolio with a view to prioritising available resources and also to provide an update on the progress of projects carried out in 2005/06. It was stated that the programme balance was towards primary schools as it was expected that secondary schools would receive support from the Building Schools for the Future monies with a report expected to be brought to this Committee in the near future.

Members queried as to why the Committee had not been consulted regarding where Children's Centres would be placed and expressed concern that by the time any report was brought to them it would be too late to change the positioning. In response it was stated that a report was scheduled to be brought to this Committee at its April meeting and Members were assured that no decision on the placing of the centres would be made before then.

In relation to the Capital Works at New College it was stated that discussions were on-going with Government regarding the proposed Academy. However works were needed to ensure the buildings current suitability and any possible future use.

In relation to Taylor Road school it was stated that discussions were on-going regarding pupil numbers. Once approval was given it was expected that a consultation period with local people of around 6 months would be undertaken and once that was completed the design, tendering and build would take around a further 27 months.
