The licensing of this public house, which is situated within the heart of a community, is abhorrent. The crime and disorder caused by this Public House over recent years has been deplorable, with all four main principles of the Licensing Act 2003 repeatedly being breached.

I make an objection to the granting of this newly requested premises licence by Parjinder Singh to re-open The Broadway PH, based on experience of living next door to the PH for years and the significant positive difference that has been felt since its been closed.

Prevention of Crime and Disorder - There have been a shocking amount of violent assaults and public order incidents inside and especially immediately outside the PH on a regular basis. There are the occasional incident of crime & disorder through the working week but the vast majority takes place on Friday, Saturday and even Sunday evenings. My wife and I have never once witnessed any person working in the PH come outside to the immediate beer garden area to at least try and intervene, or call the Police. Who ever has owned this PH simply does not care what fighting, shouting, threats and acts of criminal damage happen immediately outside the PH. This is without question a case of profit over people, the people being the long suffering local community. I would encourage the Local Authority to liaise with partners in the Police & NHS and simply check the amount of previous Crime & Disorder incidents linked to this PH. Serious wounding offending has taken place inside the PH, but they carry on as it nothing has happened. It is only a matter of time, I truly believe, where some poor unfortunate will lose their life due to

the violence linked to The Broadway.

Public Safety - Innocent community passersby are susceptible to acts of violence, threats of violence and verbal abuse. The PH is in the centre of a local residential community that simply wishes to live in peace, and I strongly believe that its the lawful duty of the Local Authority to not allow a PH to operate with a licence, given the levels of Crime & Disorder linked to it. Also, especially later in the evenings, there have been significant amounts of vehicles driving erratically around the pub car-park and then entering the busy main road at speed.

Prevention of Public Nuisance - living next door or close by to a PH which hosts late night parties & events which causes intolerable loud music and voices is absolutely awful. Patrons of this PH use the local streets to urinate, drop litter, shout, scream, argue, and hang around causing harassment, alarm and distress to the community around them. On countless occasions my family have been woken by screeching intoxicated females as example and/or aggressive violent intoxicated males as example; the behaviour is shocking and there is also the nuisance caused extremely loud music at 1 to 2 am in the morning. The PH car park has a type of doorway made in their external wall that runs onto Beaumanor Road. I do not even believe this doorway should be there? This doorway enables the PH's patrons to park their cars on Beaumanor Road causing the nuisance of taking up the already minimal residents car parking. I also strongly suspect they use this route, so not to be seen drive away from the PH onto Abbey Lane (excess alcohol?). The doorway also allows the intoxicated PH patrons to leave the Broadway immediately walking into a residential street. Noise nuisance and vandalism being caused as a result. I would again urge the LA to check a reduction in minor damage being caused to vehicles on Beaumanor Road.....Its certainly been a long time, due to the PH being closed. since my cars wing mirrors have been damaged.

Protection of Children from Harm - all that i have stated in this objection clearly can have a negative effect on children and young people. The area of the PH is almost always dirty with rubbish (public health) and broken glass (public safety). As well as this the smell of cannabis from PH patrons smoking in the poorly lit carpark is clearly negative for the young people in our community too.
