1. Purpose of Report


1.1. This report provides information for Members about an application made under the Licensing Act 2003, to assist them in determining the outcome of that application.

2. Determination to be made

- 2.1. Having considered the application and representation(s), Members must consider whether to
 - Grant the licence without modification
 - Grant the licence subject to conditions
 - Exclude from the licence any of the licensable activities
 - Refuse to accept the proposed premises supervisor
 - Reject the application

3. Summary

3.1 This report outlines an application for a new premises licence for Marta Dominiak and summarises the representations received. It also highlights the licensing objectives, the relevant parts of the guidance and regulations, and the pertinent sections of the Licensing Authority's Licensing Policy.



5. Application

- 5.1 An application was received on 2nd January 2018 from Personal Licence Training (UK) Ltd acting on behalf of Marta Dominiak for a new premises licence for Euro Market. A copy of the application is attached at Appendix B.
- 5.2 The application is as follows:

6. Steps to Promote the Licensing Objectives

- 6.1 The steps the applicant proposes to take to promote the licensing objectives are set out in the operating schedule (see section M of Appendix A).
- 6.2 In arriving at its decision on the application, the Licensing Authority's primary consideration must be the promotion of the licensing objectives.

7. Representations

7.1 A representation was received on 30th of January 2018 from the Regulatory Services Manager at Rugby Borough Council. The representation relates to the prevention of crime and disorder and the prevention of public nuisance. Concerns have been raised as to the suitability of Marta Dominiak to be the licence holder or Designated Premises Supervisor. A copy of the representation is attached at Appendix B.

8. Conditions

8.1 The conditions that are consistent with the operating schedule and the representation are attached at Appendix C.
