85. APPOINTMENT OF CHAIR

Councillor Singh Johal was appointed as Chair for the meeting.

It was noted that the hearing of the application was held virtually in accordance with the Local Authorities and Police and Crime Panels (Coronavirus)(Flexibility of Local Authority and Police and Crime Panel Meetings)(England and Wales)(Regulations) 2020 (the 2020 Regulations) and in accordance with the Council's own Remote Procedure Rules.

86. APOLOGIES FOR ABSENCE

There were no apologies for absence.

87. DECLARATIONS OF INTEREST

There were no declarations of interest.

88. APPLICATION FOR A VARIATION OF AN EXISTING PREMISES LICENCE -VITAZ SUPERSTORE, 66 CANON STREET, LEICESTER, LE4 6NG

The Director of Neighbourhood and Environmental Services submitted a report, which outlined an application for a variation to an existing premises licence for the Vitaz Superstore and summarised the representations received.

The existing Licence authorised off-sales of alcohol, seven days a week from 7.00 am to 11.00 pm, those hours also being the opening hours of the premises. The variation sought was to authorise off-sales of alcohol seven days a week from 6.00 am daily to midnight on Sunday through to Thursday and to 2.00 am on a Friday and Saturday. Those hours, if granted, would then become the premises' opening hours.

The report also highlighted the licensing objectives, the relevant parts of the guidance and regulations, and the pertinent sections of the Licensing Authority's Licensing Policy.

Members noted that representations had been received, and that it was necessary that the application be considered by the Sub-Committee.

Mr Vijaykumar Hingu (Premises Licence Holder (PLH)) was present with a representative Mr Anil Bhawsar.

PC Dave Braithwaite was present as Leicestershire Police had made representations.

Mr Andrew Sansome was present as the Council's Noise Team had made a representation.

Also present was the Licensing Team Manager (Policy and Applications) and the Legal Adviser to the Sub-Committee.

The Licensing Team Manager (Policy and Applications) presented the report and outlined details of the application.

It was noted that a representation was received on 6 March 2021 from Councillor Solanki, as a Ward Councillor. The representation related to the prevention of public nuisance the protection of children from harm, the prevention of crime and disorder and public safety. Councillor Solanki was concerned that if the application was granted it would cause disruption to nearby residences and the increase to hours would exacerbate the existing issues of street drinking, noise, litter and general anti-social behaviour in the area. In addition, there were concerns about elderly and young residents in the area as this was a main route for residents walking to schools and places of worship. A copy of the representation was submitted.

Representations had also been received from a local resident and a local temple who submitted photographs.

In response to questions from Members, it was clarified that the photographs were taken at a time when the PLH was present at the premises, and that they were taken by objectors and not the Licensing Officers concerned with the application.

The representations related to the prevention of public nuisance, public safety, the prevention of harm to children and crime and disorder. They were jointly

concerned that customers leaving late at night and the early hours would increase the already unacceptable noise levels and disruption, and the antisocial behaviour witnessed in the vicinity of the premises. There were also concerns about urinating in the street. The existing litter problems, street drinking and gatherings were also be likely to increase into the early hours if the application was granted. Copies of the representations were submitted, together with the photographs referenced.

It was further reported that a representation was received on 22 March 2021 from the Council's Noise Team. The representation related to the prevention of public nuisance. The Noise team were concerned that if the hours were increased in line with the application there would be an increase in noise and disturbance from vehicles, stereos, car doors slamming and talking into the early hours and that this would impact on the lives of local residents and likely increase noise complaints in the area. A copy of the representation was submitted.

A representation was also received on 22 March 2021 from Leicestershire Police. The representation related to the prevention of crime and disorder, the prevention of public nuisance, public safety and the protection of children from harm. The police were concerned that if the application was granted there would be an increase in noise levels, litter, street drinkers and anti-social behaviour. A copy of the representation was submitted.

It was reported that on 24 March 2021 additional information was received from Leicestershire Police whereby they submitted information on other local premises in the area and reported incidences. This representation was also submitted. A further statement was received from Leicestershire police on 25 March 2021 as indicated on the original representation. This was also submitted. It was noted that discussions had taken place between the PLH's representative, the PLH and the Local Beat Officer about the potential to amend the hours of application to Midnight every night. A verbal agreement was made at a recent meeting however no formal written agreement had been made and therefore the application to be determined was at that time in the terms as originally applied for.

The PLH's representative had submitted a signed petition in support of the application, which was also submitted.

PC Dave Braithwaite was given the opportunity to outline the details of the Police representations concerning the application. He confirmed the Police objection to the application in its original form but indicated that the Police did not oppose the amended form of variation subsequently discussed with the PLH where off-sales of alcohol would be authorised until midnight seven days a week. He answered questions from Members and the representative for the PLH.

Mr Andrew Sansome was given the opportunity to outline the details of the Noise Team's representations concerning the application. He indicated that the change in hours in the amended form of variation indicated by the Police did

not alter the Noise Team's view of the matter. He answered questions from Members and the representative for the PLH.

The PLH and his representative Mr Anil Bhawsar, were given the opportunity to present their case. Mr Bhawsar confirmed that the variation now sought was to authorise off-sales of alcohol from 6.00 am to midnight seven days a week. The PLH and Mr Bhawsar answered questions from Members, the Police, and the Noise Team.

All parties were given the opportunity to sum up their positions and make any final comments.

The Sub-Committee received legal advice form the Legal Adviser to the Sub-Committee in the presence of all those present and were advised of the options available to them in making their decision.

The Sub-Committee were also advised of the relevant policy and statutory guidance that needed to be taken into account when making their decision.

In reaching their decision, the Sub-Committee felt they should deliberate in private on the basis that this was in the public interest and as such outweighed the public interest of their deliberation taking place with the parties represented present, in accordance with the Licensing Act 2003 (Hearings) Regulations 2005.

The Chair announced that the decisions and reasons would be publicly announced and confirmed in writing within five working days. The Chair informed the meeting that the Legal Adviser to the Sub-Committee would be called back to give advice on the wording of the decision.

The Chair then asked all but the Members of the Sub-Committee and Democratic Support Officers to disconnect from the meeting. The Sub-Committee then deliberated in private to consider their decision.

The Legal Adviser to the Sub-Committee was called back to the meeting to give advice on the wording of the decision.

RESOLVED:

That the application for a variation of an existing premises licence for Vitaz Superstore, 66 Canon Street, Leicester, LE4 6NG be REFUSED.

In reaching their decision the Sub-Committee Members had carefully considered the Committee report presented by the Licensing Team Manager (Policy and Applications), all written representations and the representations made at the meeting by Leicestershire Police and the Noise Team.

The members had also considered the representations made by Mr Vijaykumar Hingu (Premises Licence Holder (PLH)) and his representative Mr Anil Bhawsar at the meeting, and the legal advice given to them during the hearing. The Sub-Committee Members had taken account of the Statutory Guidance, the Regulators' Code and the Council's Licensing Policy.

Sub-Committee Members had been asked to consider an application by the PLH for a variation of the Premises Licence for Vitaz Superstore on Canon Street, a mainly residential area in Leicester.

The PLH had held the existing Licence for six months. It authorised off-sales of alcohol, seven days a week from 7.00am to 11.00pm, those hours also being the current opening hours of the premises.

Members heard that, originally, the variation sought by the PLH was to authorise off-sales of alcohol seven days a week from 6.00am to midnight on Sunday through to Thursday and from 6.00am to 2.00am on a Friday and Saturday. However, the PLH amended his application before the Sub-Committee, to seek variation to authorise off-sales of alcohol seven days a week from 6.00am to midnight. Those hours, if granted, would then become the premises' opening hours.

The Sub-Committee was informed that representations against the grant of the variation had been received regarding all of the licensing objectives.

Councillor Solanki, Ward Councillor, had submitted a written representation, in which she believed that an increase in licensed hours would cause disruption to nearby residences and would exacerbate the existing issues in the area regarding street drinking, noise, littering and general anti-social behaviour. In addition, Councillor Solanki had concerns for elderly and young residents in the area as Canon Street was a main route for residents walking to schools and places of worship. A local resident and a local Temple had submitted written representations, which shared the concerns of the Ward Councillor. They also believed that customers using the premises late at night and in the early hours of the morning would increase noise levels and the disruption to residents that currently existed. In addition, they believed there would be an increase in antisocial behaviour in the area and in this respect, they referred to existing littering problems and street drinking with people urinating in the street. They believed that gatherings of street drinkers would extend into the early hours of the morning if the variation was granted.

The Sub-Committee also heard from the Council's Noise Team that an increase in hours would result in an increase in noise and disturbance from vehicles, stereos, car doors slamming and talking into the early hours of the morning, which would adversely impact on the lives of local residents, especially, but not limited to, those in the residential premises adjoining the Store. Members were advised that it would be impossible to effectively control the street noise.

The meeting heard that the Police had opposed the application in its original form, believing that an extension of licensed hours in that form would lead to an unacceptable increase in noise levels, littering, street drinkers and anti-social

behaviour. However, the meeting heard from the Police that they did not oppose the application in its amended form.

The Police provided details of approximately 45 incidents of crime and disorder, anti-social behaviour and public safety issues which had occurred within 500 metres of the Store in the 12-month period from 22 February 2020 to 21 February 2021. The Police had also provided details of the opening hours of five similar premises in the area, none of which opened earlier than 7.00am and they had closing times ranging between 10.30pm and midnight. The PLH informed the meeting that in addition to the premises there was a local garage which was licensed for off-sales of alcohol beyond midnight.

In making his application, the PLH indicated that he was responding to requests by his customers for him to operate longer hours. He referred to a culture in the area, of families being out late of an evening seeking to buy items such as desserts and he wanted to be able to sell alcohol to them. He also indicated that he wanted to capture passing trade from people who were employed at nearby businesses when they finished work and who would purchase alcohol to take it home to drink.

The PLH submitted a petition with 37 signatories in support of his application. Although, not determinative of the decision, Members noted that the signatories in the petition were limited in number and did not include those of people residing in the properties immediately adjoining the Store.

The meeting heard that the PLH had proposed an additional condition to the Licence in the event the variation was granted: 'The licence holder will ensure that there will be two members of staff each day on the premises from 8.00pm.'

Members considered the application on its individual merits and felt that it was appropriate for the promotion of the licensing objectives of the prevention of crime and disorder, public safety, the prevention of public nuisance and the protection of children from harm, to refuse the application to vary the Licence.

Members stated that although there were commercial premises in the area, it was in the main a residential area, and any extension of the licensed hours had the potential to adversely impact on the lives of residents. They considered that an extension of the licensed hours would clearly lead to increased levels of noise as detailed by the Council's Noise Team.

Members were further concerned at the level of incidents of crime and disorder, anti-social behaviour and public safety issues in the area which had been reported to the Police in the 12-month period from 22 February 2020 to 21 February 2021. Members believed that there was clearly a problem in the area with street drinking and the associated problems it brought as regards noise, littering and anti-social behaviour and that to extend the licensed hours would add to those problems and as such would not promote the licensing objectives.

The PLH referred to a culture in the area of people going home after work but then coming back out late in the evening with their families, a practice which he had not sought to discourage. Members were concerned regarding public safety and the need to protect children from harm where there was encouragement of families into a late-night environment where alcohol was promoted and available for sale.

Members announced that, in the circumstances, their decision was that it was appropriate for the promotion of the licensing objectives of the prevention of crime and disorder, public safety and the protection of children from harm to refuse the variation of the premises licence.

The Premises Licence Holder would be informed that any appeal against the decision must be made within 21 days to the Magistrates Court.

1.1. This report provides information for Members about applications made under the Licensing Act 2003, to assist them in determining the outcome of that application.


2. Determination to be made

6 Application

6.1 An application was received on 13th April 2021 from Mr Sheakha Sharif Najhat to transfer the existing premises licence for Uni, 39 Western Boulevard, Leicester into his name and to specify himself as the Designated Premises Supervisor. A copy of the application is attached at Appendix B.

7 Representation

- 7.1 A representation was received on 14th April 2021 from Leicestershire Police in relation to the prevention of crime and disorder, public safety, prevention of public nuisance and the protection of children from harm. Leicestershire Police are concerned that this is not a genuine transfer application and is an attempt to mislead the police and licensing authority to believe a new applicant is involved in the business and will not repeat the previous failings as highlighted in the review hearing held on 29th March 2021. A copy of the representation is attached at Appendix C.
- 7.2 At the hearing on 29 March 2021 the decision of the members was to revoke the premises licence. The current licence holder had until 24 April 2021 to appeal the decision. At the time of writing the report we have not been notified whether an appeal has been lodged.

Annex 1 - Mandatory conditions

No supply of alcohol may be made under the premises licence -

- at a time when there is no designated premises supervisor in respect of the premises licence, or
- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-

- a) a holographic mark, or
- b) an ultraviolet feature.

A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

Annex 2 - Conditions consistent with the operating schedule.

The licence holder shall ensure a door supervisor is used when necessary.



I write in my capacity as Licensing Officer for the Leicestershire Police on the authority delegated to me by the Chief Constable.

Only in exceptional circumstances will the police make a representation to a transfer of both a premises licence and a designated premises supervisor application.

It is Leicestershire Police's view that the granting of the transfer would be contrary to the fundamental principle of the Licensing Act 2003 in relation to the prevention of crime and disorder, public safety, prevention of public nuisance and the protection of children from harm.

This application has been submitted on behalf of Mr Sheakha Sharif Najhat to become the new premises licence holder and designated premises supervisor of Uni, 39 Western

Boulevard, Leicester. LE2 7HN.

The current premises licence holder and designated premises supervisor is Mr Nawzad Sharif-Nazhad.

On Monday 29th March 2021, a Leicester City Council licensing committee review hearing was held as a result of the concerns raised by Leicestershire Police. Representatives from Leicester City Council Trading Standards and Public Health also gave evidence at the hearing.

The licensing committee agreed that the premises licence holder / designated premises supervisor was instrumental in the failings associated to the premises and as a result elected to revoke the premises licence.

During the hearing, Mr Nazhad's solicitor Mr Munir made reference to Mr Nazhad's turning to his uncle Mr Sheakha Sahrif for assistance in running the business. Please also see Mr Munir's letter to Leicester City Council dated 9th March 2021. (Annex A)

During a telephone conversation with the new applicant Mr Sheakha Sharif Najhat on Saturday 10th April 2021. Mr Najhat confirmed that Mr Nawzad Sharif Nazhad was his cousin and that he was currently assisting him with managing the business as he too holds a personal licence. Please note that a licence condition stipulates that only a person possessing a personal licence may sell alcohol, which was one of factors resulting in the review hearing in the first instance.

During the conversation Mr Najhat confirmed we had met outside the front of premises as result of the incident on Friday 29th January 2021 and that we had spoken on the telephone on Monday 1st February 2021, as a result of a further incident.

During the incident on Monday 1st February 2021, Mr Nazhad asked that I speak to his relative in order to clarify matters regarding the condition about only persons with a personal licence being permitted to sell alcohol to customers.

During this conversation with Mr Najhat on Monday 1st February 2021, I re-iterated what I had earlier said to Mr Nazhad. Both Mr Nazhad and Mr Najhat both asked that the premises be given an additional two weeks in order to rectify the issue regarding the supply of alcohol by a person holding a personal licence. During the conversation, Mr Najhat asked if I could overlook the condition for two weeks, whilst they found a suitable replacement. When I challenged him and said, "Are you asking me to turn a blind eye for two weeks?" he replied "Yes".

It is also worth noting that the contact number provided on the transfer application for the applicant is identical to the mobile number provided by Mr Nazhad on our first encounter on the 17th December 2021.

Mr Najhat and Mr Nazhad are related and I suspect Mr Najhat has a financial interest in the business. I suspect Mr Nazhad will continue be involved in the business if the transfer of the licence is granted as Mr Najhat has other business interests and requires a person with a personal licence to be present in order to comply with the premises licence condition.

Given Mr Nazhad's previous failings to adhere to the law, licence conditions and promote the licensing objectives, there is no reason to believe he will now and will continue to be involved in the business in some capacity.

Mr Najhat's comments to a police licensing officer on Monday 1st February 2021 about turning a "blind eye" to breaches of its Leicester City Council premises licence condition is not constructive, nor is it supportive of the licensing objectives.



We write in relation to our above named client who we have today been informed that he has a licensing hearing on the 29th March 2021.

We had been instructed in relation to this matter on the 10th February 2021. On that date we made contact with the licensing authority and spoke to Toni. We raised that we did not appear to have all the relevant material in order to make representations and that we wished to speak to the licensing officer dealing with the matter in order to discuss the matter further and then make representations accordingly.

We then received a call back on the 11th February 2021 but regrettably Mr Munir was in court. Mr Munir then attempted to call the officer back and followed this up with an email inviting a call back in order for our issues to be resolved.

We would suggest that this is important because, we have today been provided with body worn video in relation to the aspect of this case pertaining to the 29th January 2021. This is exhibit JJP01 and is the Body worn video of PC 2093 Pritchard. Our clients inform us that they were provided this today and is fundamental to our consideration of this matter in order for us to provide written representations. You will appreciate that we are unable to make effective representations where evidence is provided piecemeal.

We have also recently learned that the deadline for written representations was the 8th March 2021. We would be grateful if our written representations could be considered, notwithstanding this date, as our intention has been to assist and also bearing in mind we have sought to clarify matters, including seeking an opportunity to speak to the relevant licensing officer.

We ask that any documents referred to within the body of the application are provided to us. This includes, by way of example any letters that have been sent and confirmation of the manner in which those letters were sent.

With the material we have been provided, we provide our initial representations in the following terms.

The application for review relates to the "Uni" shop which was formally known as "Schnaps". The licence number is LEIPRM1423 and it was initially granted in May 2012. It has been transferred a number of times, although the details of this are not known to us. Mr Sharif-Nazhad became the premises supervisor in February 2020. He came to manage the shop with a view to establishing a long term business and not with a view to overlook the purposes of the licensing regime.

There were issues in 2014 about the sale of alcohol to persons under the legal age. This, of course, could not be a criticism of Mr Sharif-Nazhad, who took over in February 2020.

There do not appear to be any issues or concerns raised between February 2020 and September 2020.

In September 2020 (date not specified in the application for review), the police receive intelligence about the sale of illegal foreign cigarettes. We are not informed about the veracity of the intelligence and whether any steps were taken at that stage to look into that suggestion. Certainly, no further intelligence or evidence is provided between September 2020 and December 2020.

The first substantive issue raised by the police takes place on the 6th December 2020. On this occasion it is alleged that during an argument the owner or owners son threatened a member of the public with a baseball bat and hammer. The caller to the police did not wish to engage with police officers but police officers found a baseball bat in the shop premises. Our client is clear about this incident. The member of the public is known to have stolen alcohol from the shop. He was told not to come into the shop and was not threatened at any stage. The criminal investigation was filed as "No further action". There is therefore no evidence, on the face of it, of any criminal liability in relation to this incident.

The secondary concern arises from the attempt by officers to obtain CCTV on the 13th December 2020. It is unclear who the officers spoke to on this occasion but it appears on the face of it, that the person attending the shop was unable to use the CCTV. Certainly the application does not indicate that the investigating officer who attended on the 13th December or 17th December had investigated how far the CCTV did go back. In any event, we invite the licensing authority not to view this as an ongoing problem because our client is clear that the CCTV is working in accordance with the licensing conditions and we invite any officers to come and check the same.

Our client does not accept smirking or being rude on the 17th December. We make this assertion as a side point. This may be a misunderstanding of our client's slight nervous disposition.

It is clear that a number of the issues that follow from December relate to a staff member who was present and behaving in a way that was contrary to the licence conditions. These are summarised as relating to the sale of alcohol, the recovery of illegal cigarettes and a suspected offensive weapon. That member of staff was dismissed and therefore does not work for the Uni shop. Mr Sharif-Nazhad has taken on board all concerns and has asked for the assistance of his uncle, Sheakha Sharif, in order to ensure that the licensing conditions are satisfied. Mr Sheakha Sharif has held a licence since 2016. We also point out that there is no evidence that the two poles that were discovered were in fact offensive weapons as there appears to be an assumption regarding criminal use.

During the licensing hearing, we will seek to advance a number of character references and are in the process of obtaining these. We will forward them as soon as possible.

We would submit that with the change in staffing, the bringing in of Mr Sheakha Sharif and the fact that there does not appear to have been any further issues since the 1st February 2021, we would invite the licensing authority to allow our client to retain his licence in relation to the Uni shop
