17. APPOINTMENT OF CHAIR

Councillor Singh Johal was appointed as Chair for the meeting.

The Chair led on introductions and the procedure for the meeting.

18. APOLOGIES FOR ABSENCE

There were no apologises for absence.

21. APPLICATION FOR A NEW PREMISES LICENCE - SINGH BROTHERS EM LTD 258-260 VICTORIA ROAD EAST LE5 0LF

The Director of Neighbourhood and Environmental Services submitted a report on an application for the review of an existing premises licence, for Singh Brothers EM Ltd., 258 – 260 Victoria Road East, Leicester, LE5 0LF

The Premises Licence Holder (PLH) / Designated Premises Supervisor (DPS) Mr Baljinder Singh was present, accompanied by his agent Mr Anil Bhavsar,

Licensing Agent. Councillor Cank was present as an objector accompanied by a local resident. Also present was the Licensing Team Manager (Policy and Applications) and the Legal Adviser to the Sub-Committee.

The Licensing Team Manager (Policy and Applications) presented the report and outlined details of the application. It was noted a petition was received on 1st November 2021 from local residents and shop owners. The representation related to the licensing objectives of the prevention of crime and disorder, the prevention of public nuisance and public safety.

The Sub-Committee Members noted a representation had been received on 2nd November 2021 from Councillor Cank. The representation was made on the grounds of the prevention of crime and disorder, the prevention of public nuisance and public safety. Councillor Cank expressed her opposition to a licence being granted advising that there were already two premises in the small parade of shops selling alcohol. She added that an application was made for the same premises just over 12 months ago which was strongly opposed by in excess of 300 residents in the immediate area.

Members were informed a further representation was received on 10th November 2021 from residents living around Brackley Close Post Office. The representation related to the prevention of crime and disorder, the prevention of public nuisance and public safety. The residents strongly opposed the application as there were already a few premises selling alcohol in the area, and given that there were already significant problems with street drinking and anti-social behaviour, residents believed another off licence would only escalate what was already a growing problem.

Councillor Cank addressed the Sub-Committee as an objector and on behalf of the local residents who signed the petition, and answered questions from the Members, the Applicant, and his licensing agent. Councillor Cank expressed concern that another off licence would further add to litter, noise, and antisocial behaviour in the area. Councillor Cank provided new evidence at the hearing, and it was agreed by all present that it could be circulated and used in the hearing.

Mr Singh and his licensing agent were given the opportunity to put forward their case and address the concerns raised by the objector and answer questions from Members and officers.

All parties were then given the opportunity to sum up their positions and make any final comments.

The Sub-Committee received legal advice from the Legal Adviser to the Sub-Committee in the presence of all those present.

In reaching their decision, Members felt they should deliberate in private on the basis that this was in the public interest, and as such outweighed the public interest of their deliberation taking place with the parties represented present.

The Chair announced that the decision and reasons made during private deliberation would be publicly announced in writing within five working days. The Chair informed the meeting the Legal Adviser to the Sub-Committee would be called back to give advice on the wording of the decision.

The Chair then asked all but Members of the Sub-Committee and Democratic Support Officers to leave the meeting. The Sub-Committee then deliberated in private to consider their decision.

The Sub-Committee recalled the Legal Adviser to the Sub-Committee to give advice on the wording of the decision.

RESOLVED:

That the application for a new premises licence at Singh Brothers EM Ltd, 258-260 Victoria Road East, LE5 0LF be REFUSED.

Members of the Sub-Committee had been asked to determine an application made under the Licensing Act 2003, for a new premises licence.

In reaching their decision the Sub-Committee Members carefully considered the Committee report presented by the Licensing Team Manager (Policy and Applications), all representations and the legal advice provided.

The Sub-Committee had considered carefully the representations made by the Applicant and those made and received in writing from local residents and businesses, and a local Ward Councillor.

The Sub-Committee Members considered the licensing objectives to be of paramount concern and had considered the application on its own merits and in accordance with the licensing authority's Statement of Licensing Policy, the Regulator's Code and the Statutory Guidance issued under Section 182 of the Licensing Act 2003.

Members had not taken anything presented to them at face value and confirmed they had scrutinised the information put before them by all parties.

The Sub-Committee had considered each of the decisions available to them. As a result of what they had heard, Members were satisfied that that it was appropriate and proportionate considering the licensing objectives to REJECT THE APPLICATION.

REASONS FOR THE DECISION

Members accepted the evidence presented to them by the objectors to the Hearing that there was a problem relating to public nuisance in the area, namely litter, and were of the opinion that granting the licence would add to the existing problems.

Members did not believe that any conditions which could be added to the licence that were justifiable and appropriate or were within the control of the

licence holder, would alleviate all the concerns they had.

The Sub-Committee's decision was made in the interests of promoting the licensing objectives.

The application would be advised that they had a right to appeal the decision within 21 days to the Magistrates Court.

22. APPLICATION FOR A VARIATION OF AN EXISTING PREMISES LICENCE - 2FUNKY BAR & KITCHEN, 23 NEW PARK STREET, LEICESTER, LE3 5NH

The Licensing Team Manager (Policy and Applications) read a statement received from the applicant advising they were currently having to self-isolate and if it would be possible to adjourn the hearing.

The chair consulted with members.

The Chair advised that Members agreed for the Hearing to be adjourned to 21st January 2022, at 10am to be held at City Hall.

23. APPLICATION FOR A NEW PREMISES LICENCE WITHIN A CUMULATIVE IMPACT ZONE - CT SUPERMARKET 85 HINCKLEY ROAD, LEICESTER

The Chair led on introductions and confirmed with the Sub-Committee Members that reports for the meeting had been read

The Director of Neighbourhood and Environmental Services submitted a report on an application for a new premises licence within a cumulative impact zone for CT Supermarket 85 Hinckley Road, Leicester.

The applicant Mr Manish Sonraj was present with Mr Anil Bhawser, Licensing Agent. Also present was the Licensing Team Manager (Policy and Applicants) and the Legal Adviser to the Sub-Committee.

The Licensing Team Manager (Policy and Applications) presented the report and outlined details of the application. It was noted that a representation was received on 20th October 2021 from a member of the public, in relation to the licensing objectives of prevention of crime and disorder, the prevention of public nuisance, public safety, and protection of children from harm. The representation highlighted the area was part of the Cumulative Impact Zone and that local residents already had to deal with noise disturbances and antisocial behaviour.

The Sub-Committee Members noted a representation had been received on 7th of November 2021 from a member of the public. The representation related to the licensing objectives of prevention of crime and disorder, the prevention of public nuisance, public safety, and protection of children from harm. The representation highlighted the area was part of the Cumulative Impact Zone and it would go against the licensing objectives if granted.

Members were informed further representations were received on 10th November 2021 from PC Jefferson Pritchard of Leicestershire Police. The representation was made on the grounds of the prevention of crime and disorder, the prevention of public nuisance, public safety, and the protection of children from harm. Subsequently an agreement had been reached between the Applicant and the Police to attach several conditions to the licence should it be granted by Members.

A further representation was received on the 11th November 2021 from a member of public. The representation related to the prevention of crime and disorder, the prevention of public nuisance, public safety, and protection of children from harm. The representation highlighted concern for children attending the nursery at the rear of the store due to an increase in delivery vehicles at the back of the store, street drinking and a greater footfall of strangers.

The Chair asked the Licensing Team Manager (Policy and Applications) to summarise the objections made.

Mr Sonraj and his Licensing Agent were given the opportunity to put forward their case, address the concerns raised by the objectors and answer questions from Members and Officers.

All parties were given the opportunity to sum up their positions and make any final comments.

The Sub-Committee received legal advice from the Legal Adviser to the Sub-Committee in the presence of all those present.

In reaching their decision, Members felt they should deliberate in private on the basis that this was in the public interest, and as such outweighed the public interest of their deliberation taking place with the parties represented present.

The Chair announced that the decision and reasons made during private deliberation would be publicly announced in writing within five working days. The Chair informed the meeting the Legal Adviser to the Sub-Committee would be called back to give advice on the wording of the decision.

The Chair then asked all but Members of the Sub-Committee and Democratic Support Officers to leave the meeting. The Sub-Committee then deliberated in private to consider their decision.

The Sub-Committee recalled the Legal Adviser to the Sub-Committee to give advice on the wording of the decision.

RESOLVED:

That the application for a new premises licence within a cumulative impact zone, for C T Supermarket, 85 Hinckley Road, Leicester be GRANTED, subject to the conditions agreed between the Applicant and the Police.

Members of the Sub-Committee had been asked to determine an application made under the Licensing Act 2003, for a new premises licence situated within the Braunstone Gate, Cumulative Impact Zone at CT Supermarket, 85 Hinckley Road, Leicester.

In reaching their decision the Sub-Committee Members carefully considered the Committee report presented by the Licensing Team Manager (Policy and Applications), all representations and the legal advice provided.

The Sub-Committee Members considered the licensing objectives to be of paramount concern and had considered the application on its own merits and in accordance with the Council's Licensing Policy on Cumulative Impact in relation to the Braunstone Gate area of the city and the Statutory Guidance issued under Section 182 of the Licensing Act 2003.

The Sub-Committee had considered carefully all the representations from the members of the public, Leicestershire Police and those made by the applicant.

Members had not taken anything presented to them at face value and confirmed they had scrutinised the information put before them by all parties.

The Sub-Committee had considered all the decisions available to them. As a result of what they had heard, Members were satisfied that it was appropriate and proportionate considering the licensing objectives to GRANT the application subject to the conditions consistent within the operating schedule and the representation from the Police contained in Appendix C to the report.

REASONS FOR THE DECISION

Members were of the opinion that the conditions were justifiable and appropriate and were confident that by adding the additional conditions, the Applicant would manage the premises in a manner that would promote and uphold the licensing objectives and in compliance with the requirements of the Licensing Act 2003. Members were also of the opinion that granting the licence with the additional conditions would not add to the existing problems of cumulative impact in the area.

The Sub-Committee's decision was made in the interests of promoting the licensing objectives.

Councillor Gee declared he had previously heard an application for the premises in April 2020, and he approached the application with an open mind.

In accordance with the Council's Code of Conduct, the interests was not considered so significant that it was likely to prejudice the Councillors' judgement of the public interest. Councillor Gee was not, therefore, required to withdraw from the meeting.

B1) Application for a new premises licence within a Cumulative Impact Zone.

30. APPLICATION FOR A NEW PREMISES LICENCE WITHIN A CUMULATIVE IMPACT ZONE

The meeting on 24th November 2021, was reconvened to consider information requested by members.

The meeting reconvened at 10:00am on the 4th January 2022.

Introductions were made and the Chair outlined the procedure for the meeting again to those present.

The Applicant was present, accompanied by Designated Premises Supervisor (DPS), Licensing expert, interpreter, and an observer. PC Jefferson Pritchard (Leicestershire Police), Mr Tj Mavani (Licensing Team Manager (Enforcement)) and Mr Matthew Robinson (Licensing Enforcement Officer) were present as persons who had made representations. The Licensing Team Manager (Policy and Applications) and the Legal Adviser to the Sub-Committee were also present.

The Licensing Team Manager (Policy and Applications) explained the additional information requested by Members had been received and reviewed by Members and officers. She then summarised the previous hearing for all present.

The Licensing Enforcement Officer then provided an update and answered

questions from Members, Officers and the Applicant and representatives.

The Licensing Enforcement Officer explained that the applicant had previously stated that they have gained experience at a local premise in Leicester City Centre, completed a mentoring programme and also completed work experience in Birmingham, that they were asked to provide references, evidence of training and certificates due to previous concern around lack of experience. The information had not been provided and when the training provider was contacted for the information, no consent was given to prove training was completed.

PC Pritchard was given the opportunity to put forward his representation and answered questions from Members. He expressed concerns should the application be granted.

The Licensing Expert for the applicant and the applicant through his translator were given the opportunity to make further comments with regards to the application and additional information received having heard from the Licensing Enforcement Officer, and answered questions from Members, Licensing Team Manager (Enforcement), Licensing Enforcement Officer and Licensing Team Manager (Policy and Applications).

All parties were then given the opportunity to sum up their positions and make any final comments.

The Sub-Committee received legal advice from the Legal Adviser to the Sub-Committee in the presence of all those present and were advised of the options available to them in making a decision. The Sub-Committee were also advised of the relevant policy and statutory guidance that needed to be taken into account when making their decision.

In reaching their decision, the Sub-Committee felt they should deliberate in private on the basis that this was in the public interest, and as such outweighed the public interest of their deliberation taking place with the parties represented present, in accordance with the Licensing Act 2003 (Hearings) Regulations 2005.

The Chair announced that the decision and reasons would be publicly announced in writing within five working days. The Chair informed the meeting that the Legal Adviser to the Sub-Committee would be called back to give advice on the wording of the decision.

The Chair then informed the meeting that all but the Democratic Support Officers should withdraw from the room. The Sub-Committee then deliberated in private to consider their decision.

The Sub-Committee recalled the Legal Adviser to the Sub-Committee to give advice on the wording of the decision.

RESOLVED:

That the application for a new premises license within a

Cumulative Impact Zone be REFUSED.

In reaching their decision the Sub-Committee Members carefully considered the Committee report presented by the Licensing Team Manager (Policy and Applications), all representations and the legal advice provided.

The Sub-Committee Members considered the licensing objectives to be of paramount concern and had considered the application on its own merits and in accordance with the Council's Licensing Policy on Cumulative Impact in relation to the Churchgate area of the city and the Statutory Guidance issued under Section 182 of the Licensing Act 2003.

The Sub-Committee had considered carefully all the representations from the relevant authorities and those made by the applicant.

Members had not taken anything presented to them at face value and confirmed they had scrutinised the information put before them by all parties.

The Sub-Committee had considered all the decisions available to them. As a result of what they had heard, Members were satisfied that it was appropriate and proportionate considering the licensing objectives to REFUSE the application.

REASON FOR THE DECISION

- Members accepted the evidence presented by Leicestershire Police and the Licensing Enforcement Team at Leicester City Council and decided that granting the licence would add to the existing problems of cumulative impact in the area.
- 2. Despite further time having been given to the Applicant to provide comprehensive proof of their experience, training and qualifications gained within the Licensing trade, Members were concerned that the evidence provided was insufficient, lacked credibility and did not include any official document to confirm that adequate training and experience had been provided or any official and recognised qualifications gained.
- Members had no confidence that the applicant had the experience or qualifications required to manage the premises in a manner that would promote and uphold the licensing objectives or in compliance with the requirements of the Licensing Act 2003.
- 4. Members did not believe that any conditions which could be added to the licence that were justifiable and appropriate would alleviate any of the concerns they had.
- **5.** The Sub-Committee's decision was made in the interests of promoting the licensing objectives.

31. PUBLIC SESSION

The meeting moved into public session.

32. APPLICATION FOR A NEW PREMISES LICENCE WITHIN A CUMULATIVE IMPACT ZONE BELGIAN CHIPS, 55 GRANBY STREET, LEICESTER, LE1 6EH

The Chair led on introductions and confirmed with the Sub-Committee Members that reports for the meeting had been read.

The Director of Neighbourhood and Environmental Services submitted a report on an application for a new Premises Licence within a cumulative impact zone for Belgian Chips, 55 Granby Street, Leicester.

The applicant Mr Mohammed Choudhury was present. Also present was the Licensing Team Manager (Enforcement), Mr Matthew Robinson, Licensing Enforcement Officer, who had made a representation. The Licensing Team Manager (Policy and Applications), and the Legal Adviser to the Sub-Committee.

The Licensing Team Manager (Policy and Applications) presented the report and outlined details of the application. It was noted that a representation was received on 24th November 2021 from Leicestershire Police, in relation to the prevention of crime and disorder and public safety. The representation highlighted that concerns were raised that the premises occupies a prominent position in the city centre, close to many alcohol led premises and conditions have been requested in relation to the CCTV system and security staffing be added to the license if granted. It was noted that an agreement had been reached between the applicant and the Police and conditions agreed.

A second representation was noted on 7th December 2021 from Licensing Enforcement officers on the grounds of the prevention of crime and disorder, the prevention of public nuisance and public safety. The representation highlighted that concerns were raised that the premises were selling hot food after 11pm without a premises licence, despite being warned that it was a requirement.

The Licensing Enforcement Officer outlined the reasons for the representation and answered questions from Members and Officers.

Mr Choudhury was given the opportunity to put forward his case and address concerns raised by Officers and Leicestershire Police and answer questions from Members and Officers.

All parties were given the opportunity to sum up their positions and make any final comments.

The Sub-Committee received legal advice from the Legal Adviser to the Sub-Committee in the presence of all those present.

In reaching their decision, Members felt they should deliberate in private on the

basis that this was in the public interest, and as such outweighed the public interest of their deliberation taking place with the parties represented present.

The Chair announced that the decision and reasons made during private deliberation would be publicly announced in writing within five working days. The Chair informed the meeting that the Legal Adviser to the Sub-committee would be called back to give advice on the wording of the decision.

The Chair then asked all but Members of the Sub-Committee and Democratic Support Officers to leave the meeting. The Sub-Committee then deliberated in private to consider their decision.

The Sub-Committee recalled the Legal Adviser to the Sub-Committee to give advice on the wording of the decision.

RESOLVED:

That the application for a new premises license within a cumulative impact zone, for Belgian Chips, 55 Granby Street be GRANTED, subject to the agreed conditions.

Members of the Sub-Committee had been asked to determine an application made under the Licensing Act 2003, for a new premises licence situated within the Belvoir Street, Cumulative Impact Zone at Belgian Chips, 55 Granby Street, Leicester.

In reaching their decision the Sub-Committee Members carefully considered the Committee report presented by the Licensing Team Manager (Policy and Applications), all representations and the legal advice provided.

The Sub-Committee Members considered the licensing objectives to be of paramount concern and had considered the application on its own merits and in accordance with the Council's Licensing Policy on Cumulative Impact in relation to the Belvoir Street area of the city and the Statutory Guidance issued under Section 182 of the Licensing Act 2003.

The Sub-Committee had considered carefully all the representations from the relevant authorities and those made by the applicant.

Members had not taken anything presented to them at face value and confirmed they had scrutinised the information put before them by all parties.

The Sub-Committee had considered all the decisions available to them. As a result of what they had heard, Members were satisfied that it was appropriate and proportionate considering the licensing objectives to GRANT the application subject to the following conditions:

- 1. The conditions consistent with the Operating Schedule
- 2. The conditions consistent with the representation from the Police
- 3. The premises will close Thursday Saturday and Bank Holidays at 2am

- 4. The premises will close Sunday Wednesday at 11.30pm
- An additional Security Industry Authority front line door supervisor will be present at the premises when the premises is open after 11.30pm, Thursday – Saturday and Bank Holidays
- 6. No persons are to remain on the premises once they have been served their goods (paid or free). Signs are to be clearly displayed to reflect this and staff and management must fully enforce this condition.

REASON FOR THE DECISION

Members accepted the evidence presented by Leicestershire Police and the Licensing Enforcement Team at Leicester City Council however, they were of the opinion that the additional conditions were justifiable and appropriate and were confident that by adding them, the Applicant would manage the premises in a manner that will promote and uphold the licensing objectives and in compliance with the requirements of the Licensing Act 2003. Members were also of the opinion that granting the licence with the additional conditions would not add to the existing problems of cumulative impact in the area.

The Sub-Committee's decision was made in the interests of promoting the licensing objectives.

1. Summary

1.1 This report outlines an application under the Licensing Act 2003 for a new premises licence for Indian Rooster, 80 Queens Road, Leicester, LE2 1TU and summarises the representations received. 3. Application and promotion of the licensing objectives

- 3.1 An application was received on 16/12/2021 from Mr Vimalkumar Rana for a new premises licence for Indian Rooster, 80 Queens Road, Leicester. A copy of the application is attached at Appendix A.
- 3.2 The application is as follows:

- 3.3 The steps the applicant proposes to take to promote the licensing objectives are set out in the operating schedule (see section 18 of Appendix A).
- 3.4 In arriving at its decision on the application, the Licensing Authority's primary consideration must be the promotion of the licensing objectives.

4. Representation(s)

- 4.1 Thirty-seven representations were received during the consultation period from members of the public. The representations relate to the prevention of crime and disorder, the prevention of public nuisance and public safety. The representees are concerned that the hours requested by the applicant will increase noise, anti-social behaviour, litter and parking issues in the area. Copies of the representations are attached at Appendix B1-B37.
- 4.2 Three representations were received on 12th and 13th January 2022 from Ward Councillors. The representations relate to the prevention of crime and disorder and the prevention of public nuisance. The Councillors are concerned that the hours applied for are out of line with nearby premises and if granted could increase noise and crime and disorder. A copy of the representation is attached at Appendix B38-B40.
- 4.3 A representation was received on 12th January 2022 from the Noise Team. The representation relates to the prevention of public nuisance. The representee is concerned that the use of the back area and the location of the smoking area may affect nearby properties. They have contacted the applicant and have since agreed two conditions to be applied to the licence if granted. A copy of the representation and agreement can be found at Appendix B41.

5. Conditions

- 5.1 The conditions that are consistent with the application and agreement are attached at Appendix C.
- 5.2 The Live Music Act 2012 and the Legislative Reform (Entertainment Licensing) Order 2014 amended the Licensing Act 2003 in relation to the provision of regulated entertainment. Certain entertainment does not require a licence subject to audience limits, between 08.00 and 23.00 hours each day. These exemptions may affect the application under consideration because conditions may not be imposed at this stage to control live or recorded music that is unregulated. However, if problems do occur as a result of that entertainment then conditions may be imposed to control such music in the future after a formal review.



 the UK including:-
 - evidence of the applicant's own identity such as a passport,



Please summarise your concerns about this application: I am concerned about the nature of the premises license which has been applied for at 80 Queens road, Leicester. Which they wish to include the sale of alcohol for consumption on and off the premises, the playing of recorded music, and for the long hours they want the license to cover this activity. The property was previously a betting shop, open in the daytime only. This had minimal effect on the local residents. A late license, alcohol sale, and the projection of recorded music within a very close distance from residents, some of which are vulnerable, will cause major disruption, and stress and will ruin the

ethos of the Queens road area.

Please give further details of WHY you believe this application will have an adverse effect on the licensing objectives: This proposal for licensing is for considerably longer hours then other local establishments. The shorter hours for other businesses in the area including the Clarendon pub, the Queens Road Tap, and the Verandah have obviously been carefully considered by Leicester City Councils licensing team in the past, and should therefore be the same in this instance. All of the aforementioned venues are closed by 10am in the week, 11pm on the weekend. Loud music and alcohol consumption after this time, and rolling throught to 1am is not an acceptable addition to this residential area.

The residents above and behind the property already suffer a considerable amount by the poor waste removal habits of the block of businesses, and people using the back drive as a toilet. These businesses currently sell refreshments and alcohol in the day. - 1) Hours. Those proposed are too late for the area, its location on a corner opposite homes, and the possible style of premises which includes a bar and takeaways options as well as restaurant.

 Alcohol should not be sold after 2300, nor new sales of food (in or out). A reasonable period for eating/drinking up before closure say 23.30.

 Later hours are disturbing to nearby residents wanting to sleep, and could encourage customers to move there after other local premises have closed and create a style of premises not suitable amongst dense housing.
- 2) In view of the corner position and rear yard, giving potential for noise and hanging about (including vehicles with engines and music running), further conditions are needed. Outdoor noise carries further and is less easily controlled.
- a) All refuse to be kept in rear yard, and no refuse to be put outdoors between hours of 08 00 and 22 00. Refuse to be managed so it doesn't create smell or attract vermin.
- b) no public access to rear yard, or rear door. All off sales of food or drink should be from the front entrance only. I agree with condition proposed in application that off sales of alcohol are only with food orders.
- c) no queuing around the side or rear of premises as this can cause more nuisance to residents, and block narrower footways.
- d) windows fixed closed, and doors closed except for access/egress when music or other noisy activity ongoing.
 - 3) Deliveries are a potential problem, with zebra zig-zags and bus-bay at the front, and narrow one-way street to the side. The rear yard suitable for smaller vehicles but potential source of noise for residents. Deliveries should not take place except between 08.00 and 20.00.

As far as I am aware there is no appetite for this extended opening hours - if anything (speaking with friends) there is a strong wish for it to remain as it is with an 11pm cut off. Most of the people I know in the area are parents of young children. The increased change of more on street noise which will undoubtedly (based on actual personal experience) accompany the extended hours, will make local residents lives materially worse, not better. There are many bars in the city that need the trade and are set up specifically to service the nightime economy, Queens Road is residential and is not.

The area of Queen's road and its local residents are very well provided for with numerous bars and pubs who all shut at 11pm and this suits the areas needs perfectly. To extend the opening hours of one establishment sets a worrying precedent to all other current establishments (and potentially new investors looking to opening similar businesses in the area) that this is a price site for late night economies. This is not a good idea. The area is residential The area has always attracted people wanting a 'village' environment and because of that it has maintained it's own character and quality over the years. If you want to loose that character and sense of community then this is a very quick way to do it. I have no problems with new bars (new businesses are part of what makes the area vibrant) but I vehemently oppose extending the opening hours. (This was dealt with very quickly and satisfactorily by the owners when they were made aware.) There could then be 3 flues/ extraction units all in the same small area - the pub, the new pizza bar on Clarendon Pk Rd and Indian Rooster - noise plus smell.

The applicants already operate a branch at 155 Melton Road, Leicester LE4 6QS. The menu on the website https://indianrooster.com/ shows that they don't provide alcohol and the contact page https://indianrooster.com/contact shows the opening hours as 15:00-22:00 daily other than Tuesdays. The website doesn't mention providing recorded music, but presumably that does not happen as otherwise they would require a premises licence, and Chris in Licensing has confirmed that there is no licence for that address.

If the applicants decided to operate the new branch on the same basis as the existing branch, there would be no need to apply for a premises licence.

Planning

In 2003, permission was granted for <u>planning application 20031365</u> covering change of use from Retail (Class A1) to Betting Shop (Class A2), subject to the following condition:

'The use shall not be carried on outside the hours of 07:30-23:00 daily. (In the interests of the amenities of nearby occupiers, and in accordance with policy(ies) S10 of the City of Leicester Local Plan.)'

We are aware that a new planning application has recently been submitted for this premises but not yet validated, so does not yet appear on the online planning register. This is likely to cover change of use from Betting Shop (now class sui generis) to Restaurant/Café/Bar (also class sui generis), for a change to the hours of use and probably for the installation of a flue, and we would oppose any extension of the hours of use beyond 23:00.

I wish to submit an objection to the licence application (as it stands) for 80 Queens Road on the grounds of Public Nuisance and prevention of Crime and Disorder.

From the outset I must state that I have no issue with the granting of a licence in principle for these premises but believe that a reduction in hours and conditions related to activity to the rear of the premises require attention in order to address my concerns around the licensing objectives.

I believe the hours applied for are out of line with nearby premises, in that they are later than their near neighbours; this could lead to the situation where patrons of other licensed premises which have closed for the night could make their way to 80 Queens Road for a last drink or two. The presence of a large movement of people after 11pm who have already been drinking could create a pinch point with noise and potential crime and disorder as a result. The other long term implication is that other licensed premises could seek to raise their terminal hours to match 80 Queens Road. If the terminal hours of activity for 80 Queens Road were reduced to that of surrounding premises then this should address these concerns.

The other concern is activity around the premises, particularly the rear of the premises. The rear yard of 80 Queens Road is already the subject of anti-social behaviour and there is potential for this to intensify with this licence, an obvious example could be the use of the yard to become an informal toilet for patrons of the premises. I have also seen with the nearby Grounded Kitchen that activity to the side of the premises has caused inconvenience for near neighbours. I would, therefore, be interested in any management plan that the applicant could produce which would address these concerns.

If the applicant is willing to look at lowering the terminal hours for activity to that of nearby premises and producing a plan for addressing concerns about the area in the immediate vicinity of 80 Queens Road then I would be more than happy to withdraw this objection.

1.1 This report outlines an application under the Licensing Act 2003 for a variation to an existing premises licence for Bradders, 33 Market Street, LE1 6DN and summarises the representations received. It also highlights the licensing objectives and the relevant parts of both the statutory guidance and the Licensing Authority's Licensing Policy.



- 3.5 In arriving at its decision on the application, the Licensing Authority's primary consideration must be the promotion of the licensing objectives.

4. Representation(s)

4.1 A representation was received on 05 January 2022 from Leicestershire Police. The representation relates to the prevention of crime and disorder, the prevention of public nuisance, public safety and the protection of children from harm.

The Police are concerned that the applicant wishes to move away from the conditions that limit it to a café bar/restaurant and more towards an alcohol led business. They therefore proposed conditions to be added to the licence, if granted and came to an agreement with the applicant. A copy of the representation/agreement is attached at Appendix C1.

- 4.2 A representation was received on 17 December 2021 from the Noise Control and Pollution Team. The representation relates to the prevention of public nuisance. The representee is concerned that noise levels from the premises could have an impact on nearby residents. They therefore proposed a condition to be added to the licence, if granted and came to an agreement with the applicant. A copy of the representation/agreement is attached at Appendix C2.
- 4.3 A representation was received on 22 December 2021 from a local ward councillor. The representation related to the prevention of public nuisance. The representee was concerned that noise levels from this premises were having an impact on the area and that the variation would exacerbate that. The councillor viewed the conditions put forward by Leicestershire Police and the Noise Control and Pollution Team and then withdrew the representation. The councillor did state that they would monitor problems in the area and apply for a review in future if necessary.
- 4.4 A representation was received on 6 January 2022 from a local business. The representation relates to the prevention of crime and disorder and the prevention of public nuisance. The representee is concerned that they run a business near to Bradders and that they are already experiencing anti-social behaviour and crime and disorder from patrons of the premises. They feel that later hours could exacerbate this and didn't feel that the conditions proposed in the agreements would alleviate their concerns. A copy of the representation is attached at Appendix C3.

5. Conditions

All the above will aid the prevention of crime and disorder, public safety, prevention of public nuisance and prevention of children from harm.

Also after numerous conversations with Neil Cooper we have installed a sound limiting system to prevent noise pollution and nuisance, we have re arranged our sound system internally so music is directed away from residence and businesses whom it may offend and finally we have also installed a timer on our outdoor speaker so it shuts off at 11pm if and when we use it.



No supply of alcohol may be made under the premises licence -

- a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises-

- a) games or other activities which require or encourage, or are designed to require or encourage, individuals to
 - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supplied alcohol), or
 - ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-

- a) a holographic mark, or
-) an ultraviolet feature.

The responsible person shall ensure that-

- a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures
 - i) beer or cider: 1/2 pint;
 - ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - iii) still wine in a glass: 125 ml;
- b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

Annex 2 - Conditions consistent with the operating schedule

The restrictions in this Annex do not prohibit any sale, supply or consumption of alcohol previously permitted by the Licensing Act 1964.

Alcohol shall not be sold or supplied unless it is paid for before or at the time when it is sold or supplied.

Licensable activities may continue between the end of the hours permitted by the licence on New Years Eve and the start of the hours permitted by the licence on New Years Day.



I write in my capacity as Leicester City Centre's alcohol licensing officer for Leicestershire Police, with delegated authority given by the Chief Constable.

My representation to this major variation premises licence application is based upon the licensing objectives as per the Licensing Act 2003.

The application in its current format if granted would undermine all four of the licensing objectives.

This is a major variation licence application for an existing licensed premises.

The previous owner operated the business as a café /restaurant and mostly operated the business in the day and evening economy.

The new owner acquired the premises licence in the summer of 2021, during the coronavirus pandemic.

The new owner has been operating the business mostly in the evening and night time economy, given the premises existing permitted operating hours. However, it is worth noting the business is now placing a greater emphasis upon the supply of alcohol during the evening and night time economy. As result of the coronavirus pandemic, the business to date has ultimately been operating at reduced capacity.

The premises is located on Market Street, which is a pedestrianized street in Leicester City centre.

The area consists of a mix of retail and hospitality units at street level, with residential flats above on the first and second floors. Twelve other licensed premises occupy Market Street, of which four are permitted to sell alcohol for consumption on the premises.

As a result of a high concentration of licensed premises within a relatively small geographical area, does occasionally result in crime, disorder and anti-social behaviour. More so at weekends and between the hours of 1am and 6am. Alcohol related violent crime increases significantly in the early hours of the morning, given the greater length of time that consumers have had time to consume alcohol.

Market Street, with its high concentration of licensed premises supplying alcohol until the early hours of the morning, is an area of concern for Leicestershire Police when providing policing in the night time economy. However, every application must be considered on its own merits.

The premises existing opening hours are unrestricted. Likewise, is the licensable activity of, the "playing of recorded music".

The supply of alcohol for consumption on the premises only is limited to:

Monday to Saturday from 10am until 11pm. Sunday from 12 noon until 10:30pm. Christmas Day from 12 noon until 3pm. 7pm until 10:30pm.

The premises has several existing conditions attached to the existing licence that stipulates:

- (1) Alcohol shall not be sold or supplied unless it is paid for before or at the time when it is sold or supplied.
- (2) This licence is granted subject to the condition that intoxicating liquor shall not be sold or supplied on the premises otherwise than to persons taking a table meal there and for consumptions by such persons as an ancillary to this meal.

The applicant has applied to remove these two conditions, so that the premises can diversify. However, as the premises intends to move away from a café/restaurant and more towards a "stand up" and alcohol led premises, potentially increases the risk of

crime, disorder and anti-social behaviour either at the premises or in proximity, regardless of the best intentions of the applicant.

The applicant has applied to amend the hours for the supply of alcohol to:

Sunday to Thursday from 11am until 1am. Friday and Saturday from 11am until 3am.

The applicant has applied to amend the premises opening hours to:

Monday to Thursday from 7am until 1am. Friday from 7am until 3am. Saturday from 9am until 3am. Sunday from 9am until 1am.

Effectively, the applicant wishes to move away from the conditions that limits it to a café bar/restaurant and more towards alcohol led business. As well as providing alcohol for an additional two hours between Monday and Thursday, an additional four hours on Friday & Saturday and an additional 2.5 hours on Sunday.

A site visit was conducted to the premises on Wednesday 22nd December 2021. The applicant's intentions were discussed as well as discussing the existing risk mitigating policies, which the business already employs.

Therefore, the majority of the below proposed conditions are either existing policies and procedures or is included in the applicant's application.

Leicestershire Police are nervous about the proposed removal of the existing conditions and extended operating hours, as this could have a negative impact upon the area and result in an increase in a crime, disorder and anti-social behaviour either at or within proximity to the premises.

However, Leicestershire Police believe that with the inclusion of additional conditions/measures are likely to mitigate the risk.

Leicestershire Police believe that the inclusion of these additional measures would mitigate the above-mentioned risk and promote all four of the licensing objectives.

Therefore, the twelve proposed additional conditions are:

- (1) The licence holder shall ensure the supply of alcohol ceases no later than thirty minutes prior to closing the public.
- (2) The licence holder shall ensure all licensable activity ceases by 3am on 1st January.
- (3) The licence holder shall ensure a high definition, coloured CCTV camera system is installed, operational and recording whilst the premises is open to the public. The system must permit the identification of individuals. CCTV images must be securely stored, display an accurate date/time stamp and retained for a minimum of 31 days. Cameras must cover all areas that the public have access to, including the entrance/exit and pavement area immediately outside the front of the premises.
- (4) The licence holder shall ensure Security Industry Authority (SIA) door supervisor(s)

are employed at the premises on Friday and Saturday from 8pm until close. Door supervisor(s) must remain on the premises until all customers have left. Door supervisor(s) must also be employed between Sunday to Thursday when alcohol is supplied to customers after midnight.

- (5) The licence holder shall ensure all Security Industry Authority (SIA) door supervisor(s) used at the premises record their full name, SIA registration number and the dates/time deployed on the premises. A record must be kept on the premises for six months and made available for inspection to an officer from a responsible authority upon request.
- (6) The licence holder shall ensure all Security Industry Authority (SIA) door supervisor(s) engaged at the premises for the purpose of supervising or controlling queues or customers must wear high visibility jackets/vests or armbands.
- (7) The licence holder shall ensure the premises possess an operational retail radio supplied by the Leicester's City Watch scheme.
- (8) The licence holder will promote and ensure that all front of house staff are trained in public safety campaigns such as the "Ask Angela" or other similar schemes. A record of training must be retained for at least twelve months, the record kept on the premises and made available to the responsible authorities on request.
- (9) The licence holder will operate a Challenge 25 policy with the only acceptable proof of age identification consisting of a current passport, photo card driving licence or identification carrying a PASS logo. A training record must be kept on the premises, retained for twelve months and produced to an officer from a responsible authority upon request.
- (10) The licence holder shall ensure customers are not permitted to take drinks supplied by the premises, out of the premises between 9pm and 9am.
- (11) The licence holder shall ensure children are not permitted on the premises after 8pm or when adult entertainment is being shown.
- (12) The licence holder shall ensure no more than ten customers at a time, will be permitted to smoke/vape outside the front of the premises between 9pm and 9am.

The applicant has agreed to these twelve additional conditions and is confirmed in a signed written agreement dated Tuesday 4th January 2022.

In light of the above agreement, Leicestershire Police no longer believe that a licensing hearing is required.

The premise has previously operated until 0300 under a Temporary Event Notice and caused a noise nuisance to flats above an adjacent premises.

Following the noise nuisance witnessed by the Noise and Pollution Team, the DPS has installed a sound limiting device, set at a level that he felt is unlikely to cause a noise nuisance. Since the limiter has been installed, the premises has operated until 0300 without causing a noise nuisance to occupiers of the flats.

The application includes a statement that all music will be played through the noise limiting device set at the level used during previous Temporary Event Notices. I will have no objections to the proposed variation, should it be granted, subject to the addition of the following condition:

"All amplified music and voice on the premises shall be played through a noise limiting device which is installed, fitted and maintained in such a manner as to control all sources of amplified music and voice at the premises. The level shall be set to the agreement of the Noise and Pollution Team to prevent noise nuisance being caused to the public, and the agreed level shall not be exceeded without the agreement of the Noise and Pollution Team. Once the device is set it should be inaccessible to anyone on the premise other than the licence holder."

I shall contact the applicant to request that he formally agrees to this condition. Since the applicant has stated that it is the intention to continue to use the sound limiting device, albeit not formally stated as a propose condition, I feel that it is unlikely that he will object to the inclusion of this condition.

I note that the Noise and Pollution Team has received complaints about noise on Market Street affecting residents of the hotel opposite Bradders. The source at the time may have been either Bradders or the adjacent Mamba bar. Initial investigations suggest that the acoustic insulation scheme for the hotel may not meet the agreed specification to prevent a noise nuisance from these bars, and that at the time of the complaint the noise levels from the bars was not unreasonable for the location.

CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

Staff will be fully trained on our challenge 25 policy and restricted times for minors on premises.

Licensed door supervisors will always be present and working during peak times: Friday & Saturday 20:00-close of business. They will also be present and working on any night of the week that we sell alcohol after 0:00 hours, from 23:00.

SIA licensed door supervisors will be aware of the company policies and legal implications of 'challenge 25' and will be implementing customer bag searches upon entry to the venue.

We will ask and do our best to ensure customers entering and leaving the venue are respectful of noise pollution, their surroundings and others, also we will ensure no glasses are taken outside the front door after 9pm and also we will ensure people are not drinking within the venue to an irresponsible level on intoxication.

We will not let any children in the venue past 8pm.

We have installed a sound limiting system to prevent noise pollution and nuisance, we have re arranged our sound system internally so music is directed away from residence and businesses whom it may offend and finally we have also installed a timer on our outdoor speaker, so it shuts off at 11pm, if and when we use it.

We will continue to utilise our state-of-the-art security system, which is assisted 24/7 by Verisure alarms & security. This system also comes with an 'instant response' panic button, in case of emergency. We are also a part of City Watch (Tango Victor) with instant police response if needed. We also have 11 working cameras around the venue for CCTV purposes.

CONDITIONS CONSISTENT WITH REPRESENTATION FROM THE POLICE

The licence holder shall ensure the supply of alcohol ceases no later than thirty minutes prior to closing the public.

The licence holder shall ensure all licensable activity ceases by 3am on 1st January.

The licence holder shall ensure a high definition, coloured CCTV camera system is installed, operational and recording whilst the premises is open to the public. The system must permit the identification of individuals.

CCTV images must be securely stored, display an accurate date/time stamp and retained for a minimum of 31 days.

Cameras must cover all areas that the public have access to, including the entrance/exit and pavement area immediately outside the front of the premises.

The licence holder shall ensure Security Industry Authority (SIA) door supervisor(s) are employed at the premises on Friday and Saturday from 8pm until close. Door supervisor(s) must remain on the premises until all customers have left. Door supervisor(s) must also be employed between Sunday to Thursday when alcohol is supplied to customers after midnight.

The licence holder shall ensure all Security Industry Authority (SIA) door supervisor(s) used at the premises record their full name, SIA registration number and the dates/time deployed on the premises. A record must be kept on the premises for six months and made available for inspection to an officer from a responsible authority upon request.

The licence holder shall ensure all Security Industry Authority (SIA) door supervisor(s) engaged at the premises for the purpose of supervising or controlling queues or customers must wear high visibility jackets/vests or armbands.

The licence holder shall ensure the premises possess an operational retail radio supplied by the Leicester's City Watch scheme.

The licence holder will promote and ensure that all front of house staff are trained in public safety campaigns such as the "Ask Angela" or other similar schemes. A record of training must be retained for at least twelve months, the record kept on the premises and made available to the responsible authorities on request.

The licence holder will operate a Challenge 25 policy with the only acceptable proof of age identification consisting of a current passport, photo card driving licence or identification carrying a PASS logo. A training record must be kept on the premises, retained for twelve months and produced to an officer from a responsible authority upon request.

The licence holder shall ensure customers are not permitted to take drinks supplied by the premises, out of the premises between 9pm and 9am.

The licence holder shall ensure children are not permitted on the premises after 8pm or when adult entertainment is being shown.

The licence holder shall ensure no more than ten customers at a time, will be permitted to smoke/vape outside the front of the premises between 9pm and 9am.
