

Report of the Director (Neighbourhood & Environmental Services)

1. Purpose of the Report

To determine an application for the grant of a Highways Amenities Licence for a Street Café for premises known as Mamba Bar, 29 Market Street, Leicester. The applicant is Mr Harjinder Athwal.

2. Options for the Sub-Committee

The Sub-Committee may determine the application in one of the following ways: -

(1) Grant

The Sub-Committee may grant the application.

If the Sub-Committee decide to grant the application, it should be subject to the standard conditions applicable to Highway Amenities Licences.

(2) Grant subject to special conditions

The Sub-Committee may grant the application subject to such variations, conditions or restrictions, as they think fit.

(3) Refuse

The Sub-Committee may refuse the application.

In arriving at its decision, the Sub-Committee should consider the comments put forward by the applicant and any other information provided in the report.

The Sub-Committee must give the applicant the reasons for the decision it makes when it is announced.

3. Financial Implications

None.

4. Report

An application was received on 18th July 2022 from Mr Harjinder Athwal one of the owner of Mamba Bar for the grant of a Highway Amenities Licence (Street Café).

The premises is situated within a row of shops and business on Market Street. There are a wide range of businesses in this area including bars, shops, a hotel, and cafes. There are also some residential apartments. Due to the range of businesses in the area the street is extremely busy at all times of the day and throughout the night as it is a thoroughfare for people visiting the different businesses that operate in the night time economy.

This business operates as a bar and attracts customers predominantly during the early hours of the morning between 3am and 6am.

The licence held under the Licensing Act 2003 was recently reviewed by the Licensing Authority as Leicestershire Police were concerned about the amount Crime and Disorder associated with the premises – particularly around the outside of the premises which during the nighttime is cordoned off with barriers. The area is a flash point for disorder with customers of the bar and those passing by on Market Street and there have been a number of violent incidents. In addition the Hotel opposite has voiced concerns about the level of crime and disorder and noise associated with the bar affecting their clientele and staff.

The decision of the Licensing Sub Committee to reduce the hours and add conditions to the licence is currently under appeal and is due to be heard at Leicester Magistrates Court on 2nd and 3rd November 2022.

The applicant has submitted a plan which details three tables and six chairs, to be placed in front of the premises.

The tables and chairs are to be contained within the requested area, sectioned off by barriers.

The furniture and barriers proposed are in line with what is suitable to be used within a licensed area.

The applicant has requested to use the street café between the following hours after which the outside area will be cordoned off with the barriers that are already in use:

Monday to Sunday 13.00 to Midnight

On 18th July 2022, letters of consultation were hand delivered to surrounding businesses and residential premises within the area to advise them of the application and a public notice was prominently displayed on the premises itself. This was checked to ensure it remained in situ throughout the consultation period.

Any objections were to be received no later than 28 days from the date of the notice.

Consultations were also carried out with Councillors who represent the Castle Ward of the City, Leicestershire Police, Leicestershire Fire & Rescue Service, Noise Pollution, Planning, Public Safety and Highway/Traffic Management.

Within the representation period, there were three objections received from a local business, Leicestershire Police and Leicester City Councils Licensing Enforcement Team.

All objections were accepted as being 'relevant' to the application. The objections raise concerns about noise, anti-social behaviour and crime and disorder. All objections are attached to this report and detailed in the appendix list below.

5. Policy Guidelines

The overall policy on Street Cafes is to encourage more restaurants, cafes and public houses to have more outside activity in the street which would give an ambience that makes the City more attractive to visitors and residents alike. If an objection is received, the Sub-Committee should consider the impact a street café may have on residents and any surrounding businesses in the area.

6. Legal Implications (including Human Rights Act)

A licensing decision is also a determination of civil rights to which Article 6 the right to a fair trial applies. Article 8 the right to respect for private and family life applies to the protection on neighbouring properties from noise and disturbance. Article 1 of the First Protocol gives the right of peaceful enjoyment of possessions, which would include a licence. Terms and conditions imposed on the grant of a licence will need to be proportionate, and necessary to protect the interests of a democratic society.

There is no right of appeal against the refusal to grant a Highway Amenities Licence.





Representations:
<p>The premises is situated on a busy street within the City Centre comprising of other bars, restaurants, offices and retail premises.</p> <p>The area is deemed to be an area of special interest and consultation in the Leicester City Council Licensing Policy Statement. This relates to the Licensing Act 2003 and not specifically to Street Café legislation but outlines the concerns relating to the area. Details of the policy and the relevant parts of this can be found at Alcohol, entertainment and late night refreshment (leicester.gov.uk)</p> <p>By its nature and location, the bar attracts a late crowd during the night-time economy. Market Street is subject to traffic measures and access is controlled by retractable bollards and there are no street markings in this pedestrianised section.</p> <p>We have some concerns in respect of the times applied for as this would create the possibility of day time and late outside drinking space which may attract and encourage Crime and Disorder.</p>

The concerns in relation to this application follow on from a recent Premises Licence Review for Mamba relating to incidents of crime and disorder inside and outside of the premises. It has been reported that since 2019 there had been approximately 151 incidents connected to the premises.

No details of how this space would be managed and risk mitigation is included with the application.

As previously stated, there are residential flats situated above the retail units and we have concerns that late night noise from this outside street cafe will cause Public Nuisance.

There is also a hotel directly opposite which is likely to be subjected to noise from the Street Café. Transient noise from members of the public will be present, however the presence of a static noise source causes concern.

We request that adding all the below list of conditions in full, which we believe are reasonable, proportionate and enforceable, may assist the Licence Holder to be successful in the application for a Street Café being granted.

Requested Conditions:

If the committee is minded to grant the application, we would ask for the following conditions, which we believe are reasonable, proportionate and enforceable to be applied in their entirety:

Licensed times to be restricted to Mondays - Sundays from 13:00hrs until 23:00hrs.

The licence holder shall ensure that the street café pavement licence area is properly supervised by a member of staff at all times when it is open

The licence holder will ensure that street café pavement licence area is fully covered by the premises CCTV and that no umbrellas, parasols or other coverings are used at any time.

The licence holder will ensure that a trained CCTV operative is available at all times to download and issue CCTV footage at the time of request from the police, local authority or other authorised persons.

The licence holder shall ensure CCTV is retained for a minimum of 31 days and permit the identification of individuals in all lighting conditions. It must be available to the police, local authority or authorised persons at the time of request

The licence holder shall ensure only drinks supplied by the premises are consumed within the street cafe licence area.

The licence holder shall ensure drinks supplied by the premises are only served in polycarbonate / plastic containers.

All customers using the area covered by the pavement licence will be required to be seated with the exception of entry and egress. Customers will not be permitted to stand and consume drinks within that area.

The licence holder shall complete regular risk assessments and if necessary employ additional Security Industry Authority (SIA) door supervisors who are clearly identifiable to patrol/monitor the street cafe licence area

No amplified or unamplified music or other entertainment will be permitted.

This application is for a licensed premise known as Mamba Bar, 29 Market Street, Leicester. LE1 6DN.

The premises is licensed to supply alcohol and other licensable activities.

The premises existing opening hours to the public are:

Monday to Wednesday – 11am until 3am.

Thursday to Saturday – 11am until 6am.

Sunday – 11am until midnight.

The premises currently only open's 2-3 days a week and does not open until after 10pm/11pm. The premises often does not attract customers until after midnight, therefore after when the Street Café Licence area will be used.

The premises is currently subject of a licensing appeal against Leicester City Council. The use of the outdoor area immediately outside the front of the premises in the night time economy was a key aspect of the review hearing.

It is Leicestershire Police's opinion that the outdoor area has been poorly supervised in the past and acted as a flash point for disorder.

The premises wish to place up to three tables and six chairs immediately outside the premises along the building line.

The application does not directly refer to those days that the "Street Café Licence" would operate. It is believed the proposed operating hours for Street Café Licence area would be 1pm until midnight.

The premises has two existing external CCTV cameras which cover the proposed area.

The premises is located on a busy pedestrian thoroughfare during the day, afternoon, evening and night economy.

The premises is also located within the "Market Street" area of special interest as referred to in Leicester City Council's - Licensing Policy statement.

Crime, disorder and anti-social behaviour have occurred at the premises in the past and within the proposed area but not until after midnight.

As the outdoor space is intended to be used for the consumption of alcohol in the evening/night time economy, significantly increases the risk of crime, disorder and anti-

social behaviour occurring at the premises.

Therefore, Leicestershire Police would recommend that the following conditions be attached to the licence in order to mitigate the risk and promote the licensing objectives in terms of:

- (1) The prevention of crime and disorder.
- (2) Public Safety
- (3) Public Nuisance.

Recommended Conditions for the consideration of Licensing Authority:

- The licence holder shall ensure that the street café pavement licence area is properly supervised by a member of staff at all times when it is open.



4. Report

An application was received on 12th July 2022 from Mr Orenzeb Jussab the owner of Grounded Kitchen (Salvador Deli) for the grant of a Highway Amenities Licence (Street Café).

The premises is situated within a row of shops and businesses on Queens Road on a junction with Howard Road. There are a wide range of businesses in this area including office premises, retail premises, restaurants and take away food outlets. The business is also surrounded by residential properties. Due to the range of retail, fast food and residential premises the area is busy at all times of the day.

In past years, the premises was called Salvador Deli – the name which remains on the premises licence under the Licensing Act 2003. For members information there is no requirement for licence holders to formally change the name on a premises licence however it is encouraged.

The premises previously held a Street Café Licence until 31 May 2022 for six tables and twenty four chairs – Monday to Sunday 08.00 to 20.00.

The applicant has submitted a plan which details eight tables and twenty four chairs, to be placed in front of the premises on both sides of the property.

The tables and chairs are to be contained within the requested area, sectioned off by planters.

The furniture and barriers proposed are in line with what is suitable to be used within a licensed area.

The applicant has requested to use the street café between the following hours:

Monday to Sunday 11.00am to 21.30

On 14th July 2022, letters of consultation were hand delivered to surrounding businesses and residential premises within the area to advise them of the application and a public notice was prominently displayed on the premises itself. This was checked to ensure it remained in situ throughout the consultation period.

Any objections were to be received no later than 28 days from the date of the notice.

Consultations were also carried out with Councillors who represent the Castle Ward of the City, Leicestershire Police, Leicestershire Fire & Rescue Service, Noise Pollution, Planning, Public Safety and Highway/Traffic Management.

Within the representation period, there were four objections received from a local business and three residents.

All objections were accepted as being 'relevant' to the application. The objections raise concerns about Smoking, Littering, Parking and Noise as well as the general layout of the proposed street café area. All objections are attached to this report and detailed in the appendix list below.

5. Policy Guidelines

The overall policy on Street Cafes is to encourage more restaurants, cafes and public houses to have more outside activity in the street which would give an ambience that makes the City more attractive to visitors and residents alike. If an objection is received, the Sub-Committee should consider the impact a street café may have on residents and any surrounding businesses in the area.

6. Legal Implications (including Human Rights Act)

A licensing decision is also a determination of civil rights to which Article 6 the right to a fair trial applies. Article 8 the right to respect for private and family life applies to the protection on neighbouring properties from noise and disturbance. Article 1 of the First Protocol gives the right of peaceful enjoyment of possessions, which would include a licence. Terms and conditions imposed on the grant of a licence will need to be proportionate, and necessary to protect the interests of a democratic society.

There is no right of appeal against the refusal to grant a Highway Amenities Licence.



Street café application, Grounded Kitchen, 50 Queens Road

I am writing to object to this application as it stands.

I don't object to the principle of this application, but it is too large for the location and nature of the premises.

There is always a balance to be made between the needs of the business and pedestrians using the footway. When a street café is busy and used to capacity, some inconvenience to pedestrians can be justified. This business is primarily a takeaway and does not have much use of the street café. Indeed I have never seen more than one table in use at a time. The disadvantage to pedestrians from such a large café should not then be acceptable. There is plenty of width to have a smaller café that is enough for this businesses use without causing problems for pedestrians.

Plan at corner

The plan is very poor in regard to context. It does not show that the premises is on a corner, and that there are bollards around the corner. The inability for a mobility scooter, and difficulty for pushchairs, to get around the corner has been a problem when the café was in use. It was also difficult for pedestrians coming down the side-street to get around the corner when pedestrians are waiting to cross Howard Rd This has been exacerbated by the business using a window on the side-street to serve delivery couriers - whose bikes, e-scooters and motorbikes ride on and block the footway.

- **So my first condition would be that this café starts well away from the corner, to give good access around the corner**

The plan as shown does not allow a clear 2m between the café barriers and the bollards along the front. The café when out was using two rows of small tables that encouraged the barriers further out. It was causing some people to walk in the road to pass.

- **My second condition is that a minimum clear 2 metres is maintained between the outside of café barriers and the bollards, preferably more.**

Recessed area

The plan does not show that there is a raised kerb for a bus-stop in front of the recessed area. Currently there is not a stop pole there, but more width is needed for passengers to wait, and for people alighting at same time as others are waiting and walking by. It's also unpleasant for passengers to wait close to people smoking in café – they cannot walk away if it gets too much. Under the plans for improvements to Queens Rd a bus shelter is proposed here. The street is not being pedestrianised as stated in the application, and there is no extra footway width planned on this premises frontage. As mentioned previously, this business uses very few tables at a time, and so far they have had their large bins rather than a café along this stretch. They also keep their barriers on street in this recess when not in use.

If it was used, at least 3 metres would be needed, more once a bus shelter was there.

- **My third condition would be that only the main double frontage is used for the street café, not this recessed area**

Hours

This premises is **not** 'detached', as stated in the application. It shares a long party wall with a residential property and has a flat above. It is right at the end of the shopping area and there are many homes close by, especially as it's on a corner. So late evening operation of a street café is not appropriate.

Planning and licensing hours are both only until 2000. The street café should not exceed this.

- **So my fourth condition would be to finish at 2000 not 21 30**

If the applicant can meet these 4 conditions I may be prepared to withdraw my objection.

Hi Deborah,

Thanks for the copy of the application and for clarifying the reason for the Salvador Deli name persisting.

Could you confirm whether this is a **new** application (as described in the weekly licensing report and at the top of the first page of the application) or a **renewal** of an existing licence (as described at the top of page two of the application)?

Also, at the top of page two of the application, the applicant says that the street is currently being pedestrianised, when in fact a number of improvements to Queens Road are only currently being consulted on. Although the proposed improvements include widening some parts of the footway to make more space for pavement cafes, there are no changes proposed to the footway directly outside 50 Queens Road, nor is the road being pedestrianised.

My initial concerns are that:

- As usual with most street café applications the plan is not to scale so gives a misleading impression of how much of the footway the pavement café takes up
- The plan shows the distance from the building line to the kerb as 4.3m, the distance from the building line to the edge of the barriers as 2.0m and the distance from the kerb to the inside face of the bollards as 0.5m, leaving only 1.8m between the bollards and the barriers, which is less than the minimum required distance of 2.0m
- Although the plan shows the set back part of the pavement café having a depth of 3.0m, it doesn't show how what distance this leaves between the barriers of the set back part of the café and the raised kerb in front of this section, which forms part of the bus stop.
- The plan omits the bollards and the kerb on the corner with Howard Road, which necessitated the barriers being put out at an angle when Salvador Deli operated from this premises (see street café plan attached) and which is now regularly blocked by food couriers bicycles while they're waiting to collect food via grounded Kitchen's side window on Howard Road
- The photo included with the application clearly shows the pavement café taking up more than 2.0m from the building line and leaving much less than 2.0m to the bollards on the corner with Queens Road
- Rather than storing the barriers overnight on the street as has become recent practice, they should be stored off the street, either along with Grounded Kitchen's commercial bins in the storage area between 50 and 52 Queens Road or inside the premises itself

Based on these initial concerns I'll be recommending that FCP objects to this application, but we may be able to avoid this if these concerns can be addressed by the applicant.

On the 9th June 2022 an application (Appendix 1) was submitted by Daniele Taverna on behalf of a business named, Gelato Village for the grant of a Highway Amenities Licence (Street Café). This was made under the Highways Act 1980.

The premises is situated within the Queens Road area of the city and is located near to the junction with Clarendon Park Road. Queens Road itself is a thriving shopping area consisting mainly of small businesses, cafes and bars. There are residential properties above some of the businesses and also housing within the nearby vicinity.

The premises is described as an 'Italian Artisan Gelato' café. The premises serves Gelato, coffees and food items. It currently advertises as being open on Mondays from 3pm until 8pm, Tuesdays to Thursdays from 1pm until 8pm, Fridays and Saturdays from 1pm until 9pm and Sundays from 12 midday until 6pm.

The applicant submitted an initial plan (Appendix 2) which detailed two tables and eight chairs, to be placed directly in front of the premises. The tables and chairs would be contained within the requested area, sectioned off by barriers. The plan outlines the measurements requested and conducted by the applicant.

The applicant also details further information on the application which reads: "Street Café setting with tables laid out in the pavement in front of the store, no alcohol is served"

The applicant has requested a licence for the street café for the following:

08.00hrs – 23:00hrs, Mondays to Sundays

As part of the application process and required by legislation, on the 14th June 2022, letters of consultation were sent to surrounding businesses and residents in the area to advise them of the application (Appendix 4) and a public notice (Appendix 4a) was prominently displayed on the premises itself.

Any objections were to be received no later than 28 days from the date of the notice which in this matter was midnight on the 12th July 2022.

Consultations were also carried out with Councillors who represent the Castle Ward of the city, Leicestershire Police, Leicestershire Fire & Rescue Service, Noise Pollution, Planning, Public Safety and Highway/Traffic Management.

Within the representation period, there were a total of four objections. All objections were accepted as being 'relevant' to the application.

On the Friday 15th July 2022, Mr Taverna emailed the Licensing Enforcement Generic Email to enquire about the application. An email reply was sent on the same day to inform him that there had been several objections received and that the matter would likely be taken to the Licensing Enforcement Sub Committee to be determined. It was also relayed that there may be a chance of a negotiated settlement between all parties.

Licensing Officer Nicola Marsh on return commencing Monday 18th July 2022 as part of her work, then looked to see if a negotiation could be made between all parties. This can only be done once all the information on the objections had been assessed, parties contacted and time for return of information. There had also been attempted negotiations between parties during the course of the representation period through efforts of Officer Marsh, however in totality, no negotiation could be found and therefore the matter was brought before the committee.

Objection Details:

Cllr Kitterick – These concerns relate to timings proposed and suggested that a 21:00hrs closing would be more suitable for the area.

Officer Marsh then spoke to the applicant about the representations who agreed the hours to be restricted to 08:00hrs until 21:00hrs.

This is attached as Appendix 5.

Highways – These concerns related to incorrect measurements on the original application plan. This was then addressed with the applicant by Officer Marsh by visiting the premises and the applicant provided an updated plan. This is attached as Appendix 6.

Sally Williams – These concerns relate to the restricted space of pavement for a street café, near to public amenities, the measurements on the plan and times of proposed operation. There are a number of suggested conditions/restrictions that the objector believes would mitigate their concerns if applied.

Officer Marsh relayed the agreed new reduced times to 21:00hrs and the new plan with correct and agreed measurements.

A reply was received providing photos and concerns about the premises putting out street furniture without a licence. The concerns still remain by the objector.

This is attached as Appendix 7.

Ian Brown (FCP) – These concerns relate to the restricted space of pavement for a street café, near to public amenities, the measurements on the plan and times of proposed operation. There are a number of suggested conditions/restrictions that the objector believes would mitigate their concerns if applied.

Officer Marsh relayed the agreed new reduced times to 21:00hrs and the new plan with correct and agreed measurements.

A reply was received reiterating the concerns about the number of tables and chairs able to fit in the proposed area. Concerns also about the premises putting out street furniture without a licence. The concerns still remain by the objector.

This is attached as Appendix 8.

On the 19th July 2022, several queries were raised by Mr Taverna about street cafes generally by email directly with Officer Marsh. This was replied to on the 20th July answering all the queries in turn. An email was then sent by Mr Taverna to Cllrs Clarke & Myers on the 21st July 2022 expressing discontent at the process conducted and the objections raised. The thread of those emails is attached as Appendix 14.

On 20th July 2022, Officer Marsh relayed the objections to the applicant and a reply to this was received on 21st July 2022 and is attached as Appendix 9.

On 22nd July 2022, after negotiations were not possible, Officer Marsh provided a letter to state that the matter would be heard and determined by the Licensing Enforcement Sub Committee and provided with details of the objections from Sally Williams and Ian Brown. A request was made to return any information for the committee by the 5th August 2022. No response was received to that letter.

Further information:

This application was instigated following a visit to the premises on Tuesday 7th June 2022 by Licensing Enforcement Officers after being notified of the possible use of tables and chairs on the highway. This was confirmed upon the visit and a warning letter was issued to the owner of the premises (Mr Daniele Taverna) for placing table and chairs on the highway without a relevant licence in place. This letter (Appendix 10) detailed the reason for the warning letter as well clearly stating that tables and chairs cannot be placed on the highway without a licence.

In addition to the initial warning detailed above, a further visit by Licensing Enforcement officers on 8th June 2022 which noted that tables and chairs had been placed on the highway again without a licence.

The staff on duty at the premises were verbally advised that this was not permitted. Evidence has also been gathered by Licencing Enforcement officers that the tables and chairs had been placed on the highway on numerous occasions from 8th June 2022 until 13th August 2022 (time of writing report) This is shown by photographs attached as Appendix 13.

On Friday 22nd July 2022 a final warning letter (Appendix 11) was hand delivered to the premises, but the tables and chairs continue to be placed on the highway.

The warnings were issued to both staff and to Mr Daniele Taverna.

A complaint was received to the Authority on the 21st July 2022 by a member of the public raising concerns about the street café and its vicinity to the bus stop and lack of room. Photos were taken of the premises. This is attached as Appendix 15.

This continued disregard of legal requirements, despite the numerous warnings, provides the Licensing Enforcement Team no option but to look to take further legal action regarding this matter.

It also raises serious concerns that if a licence was to be issued, as a direct result of the non-compliance, that the management would have a disregard to the conditions or requirements of a licence.

If an objection is received, the Sub-Committee should take into account the impact a street café may have on residents and any surrounding businesses in the area.

A licensing decision is also a determination of civil rights to which Article 6 the right to a fair trial applies. Article 8 the right to respect for private and family life applies to the protection on neighbouring properties from noise and disturbance. Article 1 of the First Protocol gives the right of peaceful enjoyment of possessions, which would include a licence. Terms and conditions imposed on the grant of a licence will need to be proportionate, and necessary to protect the interests of a democratic society.

There is no right of appeal against the refusal to grant a Highway Amenities (Street Café) Licence.

Objection (1)



Dear licensing

I am writing to object to the street café planned for Gelato Village on Queens Rd.

I don't object to the principle of a small café, but to the extent planned – and the diagram seems misleading.

This is a congested section of Queens Rd footway, partly due to it being close to the busiest bus stop in the area, plus a number of small premises that mean people are coming in and out of a number of entrances as well as walking along the street. Gelato itself sometimes has queues on the street. Cyclists and e-scooters regularly travel along the footway now – especially food couriers to the many takeaways. As you can see in the photo the congestion is increased by the street café for Bondade which does not leave enough room for people to pass properly by the bus stop and shelter. This can mean groups of people waiting while others come past in the opposite direction. The population of the area includes a high number of young people who walk in groups. Having navigated that bottleneck people can currently walk forward in a natural flow near the building line, apart from any A-boards when placed out. A street café of any sort at Gelato alters this direct pedestrian flow line, and puts pedestrians nearer to the road and the fixed street furniture.

The measurement on Gelato's plan appears to be to the kerb edge. The bollard and lamppost are shown at equal distance but the lamppost is further from the kerb – and there is a bin just beyond the premises on the other side. As you can see from the photo, the area beyond the line of the bin and lamppost is not a usable bit of the footway.

There needs to be an absolute minimum 2m space between the line of these bits of street furniture and the café (not just to the bollard), or a convoluted route will be created, risking

people walking into the lamppost. If the measurements given are to the kerb edge, it would mean that the space for a café is less than the 1.2m shown.

Even 2m space is not much for this location with its high volume of pedestrians and bus passengers (especially at some peak times) plus buses pulling out should pedestrians divert into the road. The café must be considered in its context. LCC guidance says 'Additional width may be required in areas with high volumes of pedestrian or vehicular traffic'. I think this is a place where more space is needed.

Additionally I feel the diagram of 4 chairs around tables is misleading and can't be fitted into the depth of café available, not even 1.2m. A 2 seater table with the table against the premises and chairs either side might work.

Otherwise it would be yet another street café on Queens Rd whose barriers would creep further over the footway than the licence allows – and difficult to enforce effectively.

This is a permanent licence, not a temporary one while footfall was lower over Covid.

Finally, there are a lot of homes very close to this premises, noise carries outdoors. While I don't suppose a Gelato will be opening very late, the street café should be limited to 8pm to prevent nuisance, in line with its currently promoted opening hours. 11pm is too late.

I may be prepared to withdraw my objection if

- There was a condition limiting end of hours to 20 00 hours
- The café is limited to tables which are against the building line with one chair each side. I'm not sure if there is room for two across the frontage or not.
- An absolute minimum 2 metres is taken from the line of the lamppost and bin (not the kerb or the bollard) and that this measurement does not include the barrier, including its feet, protruding into the space. Nor any A-board. Preferably it should be greater than 2 metres.

Thank you for this Nicola. I might have considered this acceptable apart from still being too many chairs/tables shown to fit the space.

However Gelato Village has been jumping the gun, and put out a café. This has had two effects.

- 1) It has demonstrated the problems this café could cause.
- 2) It has indicated this is an applicant who may not keep to the rules, and therefore proposals may need to be tighter than for others. We already have too many cafes that do not meet the agreed plans.

3)

I attach some photos from this morning.

- There was no protection from the north end, causing potential hazard for VI person approaching.
- The combination of cafes and people that wait around this area was causing most people to divert in front of the bus-stop. There have been falls there.
- While I don't know the measurements of the café put out, there did not appear to be 2 metres between the café and the street furniture. The café was taking more than half the available footway width.
- It was clear that there wasn't room for two tables with eight chairs in the available space. There were two chairs on one table and three with the other (not all occupied). I noted that there didn't appear to be room for two tables/chairs side-by-side across the frontage width - so one table/chairs was set back, creating greater depth. There was no way eight seats could have been provided even within this over large area.
- There was also an A-board beyond the café. It was obstructive to people trying to access the doorway.

I am prepared to compromise on the finish time to 2100 hours, due to the nature of the business.

But I still don't believe there is sufficient footway left with the café barriers as they have them – and my objection to seating for 8 around two tables remains as I simply don't see how it can be achieved in the area proposed. Indeed I'm now not sure there can't be two tables/two chairs each as I suggested in my objection. This is a small premises in a congested area.

The evidence of seeing the café in situ confirms this – and the likelihood if allowed is that this premises will keep spreading the barriers leading to a detriment to pedestrians or a constant enforcement issue.

I'm still prepared for negotiation, but my objection remains at present.

Re. Gelato Village, 107 Queens Road – application for a street café licence to have two tables and eight chairs contained by barriers Mon-Sun 08:00 to 23:00

While FCP does not object to the principle of a street café at this location, we have concerns about both the hours applied for and the size of the proposed café, so must **object** to the application.

Hours

The opening hours for the Queens Road branch are shown on Gelato Village's [website](#) as Mon-Thu 15:00-20:00, Fri-Sat 13:00-21:00 and Sun 12:00-18:00, so it seems unlikely that Gelato Village would use their street café licence to 23:00, but this could set a precedent that others, including bars on Queens Road, would want to follow.

Space

The plan provided with the applications doesn't appear to be scale, showing the tables and chairs smaller than actual within the 1.8m barriered area. Also, the 2m clear distance is measured from the kerb rather than the street furniture, and the plan shows the bollard and lamp post at the edge of the pavement when they are actually set back from the edge. Here's how it looks on the latest Street View on Google Maps:



The inner edge of the bollard is ~50cm in from the kerb and the inner edge of the lamp post ~90cm in from the kerb, so the 2.0m minimum clear footway needs to be measured between the front of the street café barriers and the street furniture. Based on the measurements shown on the plan and the actual position of the bollard and the lamp post, that would make the street café only 90cm deep, which wouldn't accommodate two tables with four chairs each, but might accommodate two tables with two chairs each if they were up against the front of the shop. Although this pavement café would not be right next to the bus stop, people do congregate there when waiting for a bus, increasing congestion on that section of footway. If the lamp post were moved closer to the kerb as part of the Queens Road improvements, then the depth of the street café could perhaps be increased.

Objection

FCP objects to this application based on:

- 1. the proposal leaving less than the required 2m minimum between the barriers and street furniture, and
- 2. the requested hours for the street café being later than the opening hours.

We would be prepared to withdraw our objection if:

- 1. the depth of the street café is reduced to allow at least the minimum 2.0m between the front of the feet of the street café barriers and the inner edge of the lamp post

Thanks for sending the revised plan, and no problem about the delay – I’ve been away on holidays too.

It’s good to see that the depth of the proposed café has been reduced from 1.8m to 1.5m and the that standalone barrier has been relocated closer to the tables. However, the plan still shows two tables with four chairs each, which seems optimistic with a depth of only 1.5m and is likely to result in customers moving the barriers further out. Also, although the revised plan shows 2.3m from the front of the barrier to the kerb, I’m not convinced this leaves the minimum 2m between the barriers and the bollard and particularly the lamp post. Finally, as you can see from the attached photos, Gelato Village are already putting out their street café but without the standalone barrier.





Objection (1)



Dear licensing

I am writing to object to the street café planned for Gelato Village on Queens Rd.

I don't object to the principle of a small café, but to the extent planned – and the diagram seems misleading.

This is a congested section of Queens Rd footway, partly due to it being close to the busiest bus stop in the area, plus a number of small premises that mean people are coming in and out of a number of entrances as well as walking along the street. Gelato itself sometimes has queues on the street. Cyclists and e-scooters regularly travel along the footway now – especially food couriers to the many takeaways. As you can see in the photo the congestion is increased by the street café for Bondade which does not leave enough room for people to pass properly by the bus stop and shelter. This can mean groups of people waiting while others come past in the opposite direction. The population of the area includes a high number of young people who walk in groups. Having navigated that bottleneck people can currently walk forward in a natural flow near the building line, apart from any A-boards when placed out. A street café of any sort at Gelato alters this direct pedestrian flow line, and puts pedestrians nearer to the road and the fixed street furniture.

The measurement on Gelato's plan appears to be to the kerb edge. The bollard and lamppost are shown at equal distance but the lamppost is further from the kerb – and there is a bin just beyond the premises on the other side. As you can see from the photo, the area beyond the line of the bin and lamppost is not a usable bit of the footway.

There needs to be an absolute minimum 2m space between the line of these bits of street furniture and the café (not just to the bollard), or a convoluted route will be created, risking

people walking into the lamppost. If the measurements given are to the kerb edge, it would mean that the space for a café is less than the 1.2m shown.

Even 2m space is not much for this location with its high volume of pedestrians and bus passengers (especially at some peak times) plus buses pulling out should pedestrians divert into the road. The café must be considered in its context. LCC guidance says 'Additional width may be required in areas with high volumes of pedestrian or vehicular traffic'. I think this is a place where more space is needed.

Additionally I feel the diagram of 4 chairs around tables is misleading and can't be fitted into the depth of café available, not even 1.2m. A 2 seater table with the table against the premises and chairs either side might work.

Otherwise it would be yet another street café on Queens Rd whose barriers would creep further over the footway than the licence allows – and difficult to enforce effectively.

This is a permanent licence, not a temporary one while footfall was lower over Covid.

Finally, there are a lot of homes very close to this premises, noise carries outdoors. While I don't suppose a Gelato will be opening very late, the street café should be limited to 8pm to prevent nuisance, in line with its currently promoted opening hours. 11pm is too late.

I may be prepared to withdraw my objection if

- There was a condition limiting end of hours to 20 00 hours
- The café is limited to tables which are against the building line with one chair each side. I'm not sure if there is room for two across the frontage or not.
- An absolute minimum 2 metres is taken from the line of the lamppost and bin (not the kerb or the bollard) and that this measurement does not include the barrier, including its feet, protruding into the space. Nor any A-board. Preferably it should be greater than 2 metres.

Good afternoon,

I will address each point raised.

1. St Martins is a privately owned area and therefore the legislation regarding street cafes do not apply and we have no powers to enforce any issues in the square.
2. Veenoo have applied for the area that they are using. You are also able to alter your licenced area for your street café by contacting our licensing applications team and completing the online application for a major variation.
3. Sonrisa – the planters allow pedestrians to walk through the street café although by the layout of the street, pedestrians usually travel around the outer edge. I actually walked through it yesterday to remain in the shade from the afternoon sun.
4. Prana – with regards to parasols – You are able to have removable parasols in your street café if you apply for them or can contact the licensing applications team with regards to adding them to your existing licence.

Regarding your application for the street café on Queens Road, the objections were surrounding the concerns of the size of the licenced area (I have forwarded the new plan for consideration to the persons objecting) and the amount of tables and chairs – their concerns were that the two tables with four chairs may encourage customers to push the barriers out of the licensed area to gain enough space to sit down comfortably.

Would you consider reducing the amount of chairs?

The other objection was the opening times – which I have forwarded the new agreed times. They did suggest 2000hrs as a cease time – I am still waiting for the reply from them for the proposed 2100hrs cease time.

I hope this answers your queries satisfactorily.

I would just like to have clarified the usage of pavements by some of our neighbours so I we may be able to do the same?

Veenoo seems now to have permission to use the entire width of the pavement, from their store-front to the curb, leaving a gap in between for pedestrians, who are then faced by the items put out by the store adjacent.

Sonrisa, is leaving an entire area closed off with planters: sometime ago when I enquired about leaving heavy-duty parasol out (like also Prana at Town Hall Square does), but during a meeting with other council officials someone from the Licensing department said that it couldn't be done .

As I said at the beginning I don't mean to cause trouble, but only understand how things work.
