Gaza Conflict Motion

Councillor Dawood proposes that Leicester City Council notes:

We as elected members of Leicester City Council, call on the Prime Minister, the Leader of the Opposition, and the other parties nationally to:

- 1. Call for an immediate ceasefire in the conflict in Gaza.
- 2. Advocate for the unrestricted restoration of aid and amenities into Gaza.
- 3. Demand the unconditional release of all hostages.
- 4. Urge the UK to recognize the state of Palestine.
- 5. Make the UK a place of sanctuary for refugees fleeing the conflict.

Fire & Emergency Evacuation Procedure
